Mr. CUELLAR. Mr. Speaker, I rise today to honor the life and service of Judge Oscar O. Martinez, Sr., a distinguished public servant, businessman, and lifelong resident of Laredo, Texas.

Born in 1941 to Arnulfo and Adela Martinez, Judge Martinez graduated from Martin High School, attended Laredo Junior College and Texas A&I University in Kingsville, and proudly served his country in the United States Air Force.

After his honorable discharge in 1969, he returned home, working first in radio sales before venturing into business with Martinez Brothers' Gulf Service Station. He later founded Border Realty, building a career in real estate that reflected his entrepreneurial spirit.

In 1991, Judge Martinez was appointed Justice of the Peace for Webb County Precinct Four, and the voters returned him to office six more times. Over 24 years on the bench, he was a tireless advocate for the youth of our community.

He co-founded the Texas Court Judges Association, directed the South Texas Justice of the Peace and Constable Association, and launched truancy prevention and disciplinary programs such as Parents' Against Crime, graffiti clean-up initiatives, and youth groups with city and county partners.

His partnership with Border Patrol and IBC created the R.E.A.L. Mission Program, which served at-risk students in Laredo and was later expanded across the Rio Grande Valley and El Paso.

Beyond the courtroom, Judge Martinez lived a life of faith and service. An active parishioner of St. Patrick Catholic Church, he was a

longtime member of the Knights of Columbus and the St. Patrick's Men's Club.

He devoted over four decades to LULAC serving as District 14 director and president of Council No. 12, co-founding the Señor Internacional program, and creating the "Lo Mejor de lo Nuestro" award.

His dedication to youth and education earned him recognition from schools, civic organizations, and his peers, including honors such as "Tejano Achiever," Rotary's "Service Above Self," the Laredo Bar Association's Liberty Bell Award, and the title of "Tiger Legend."

He also gave 44 years of service to the Laredo International Fair and Exposition, where he was named "Rancher of the Year," and was appointed by Governors Dolph Briscoe, Ann Richards, and George W. Bush to the South Texas Workforce Commission.

He loved ranching at the family's Santa Teresa Ranch in Ramireño, where he spent his spare time.

Judge Martinez retired in 2014, and in recognition of his lifetime of service, Webb County named the Precinct Four Justice Center in his honor.

His legacy will be remembered in the youth programs he created, the civic institutions he strengthened, and the countless lives he touched.

Mr. Speaker, I ask my colleagues to join me in celebrating the life of Judge Oscar O. Martinez, Sr.—a devoted husband, father, veteran, public servant, and proud Laredoan who leaves behind a legacy of service above self.

Maryam's vision and expertise helped facilitate the transfer of technologies developed within federal agencies to public, private and non-profit partners.

Maryam developed her expertise in technology transfer after beginning her career as a microbiologist and researcher at the U.S. Army Medical Research Institute of Infectious Diseases. Discovering a passion for technology transfer and a talent for the intersection of science and the law, she lent her expertise to the U.S. Army Medical Research and Materiel Command and the Naval Research Laboratory.

A Marylander to her bones, Maryam prepared for this remarkable career at the Free State's world class colleges and universities. She's earned degrees at the University of Maryland-College Park, Hood College, and the

Israel obtained an engineering degree from ISPJAE in Havana and a bachelor's degree in theology and pastoral ministry from the Baptist Theological Seminary of Havana. He also pursued master's studies in Cuba and Guatemala. Finally, he is currently working on the dissertation phase of his third doctorate, a Ph.D. in Bible Exposition at Liberty University. Previously, he had obtained a Ph.D. in Theological Education at SETECA and a D.Min. in Hispanic Ministry Leadership at DTS.

Mr. GOMEZ. Mr. Speaker, I rise today to honor a visionary leader whose life's work has left an indelible mark on the United States, Latin America, and the world, Mr. Ernesto Nieto, founder and president of the National Hispanic Institute (NHI). On the occasion of his 85th birthday, we commemorate not only the years of his extraordinary life, but also the enduring legacy he has forged for generations to come.

Son of civic activists and Methodist church leaders, Santos and Esther Nieto, Ernesto was born on October 6, 1940, in Houston, Texas. He and his brothers, Albert and Roy, grew up confronting racial discrimination firsthand, experiences that fueled his determination to join the civil rights movement and to create new pathways of opportunity for the Latino community. A proud graduate of Southwestern University, a talented basketball player ranking 23rd leading scorer in the nation, along with further graduate studies at the University of Houston, Mr. Nieto combined academic rigor with an unwavering commitment to being a cultivator of human potential, a steward of possibility, and a teacher of hope. His life reminds us that the truest measure of leadership is not in what we accumulate for ourselves, but in what we awaken in others.

In 1979, guided by that bold vision, Mr. Nieto founded the National Hispanic Institute to cultivate young Latino leaders. At a time when too many narratives focused only on deficits, Mr. Nieto charted a different course—one of possibility, strength, and aspiration. Under his leadership, NHI has engaged over 100,000 high-achieving students from across the United States and Latin America, partnering with more than 120 institutions of higher education.

Through NHI, he gave students the stage to discover their gifts, the structure to practice leadership, and the conviction to see themselves as architects of their communities' future. While NHI's roots are proudly grounded in the Latino community, its reach has expanded to a hemispheric scope. Today, NHI engages youth of every cultural background—from Nigerian American and Indian American families to young leaders across the Americas—all united by the common purpose of civic engagement, community life, and the pursuit of a stronger future.

For Mr. Nieto, leadership is not an abstract concept but a lived experience of community, family, and heritage. His philosophy is rooted in respect for the long history and traditions of

Latino leadership and in building systems that identify, nurture, and amplify the talents of young people. His groundbreaking book *Third Reality: Crafting a 21st Century Latino Agenda* captured this vision, underscoring the vital importance of cultivating leaders who embrace their cultural identity as an asset to American society and to the world.

Over the decades, Mr. Nieto's leadership has been recognized through countless honors. He has received the Distinguished Alumnus Award of Southwestern University, the Human Relations Award from the National Association of College Admissions Counselors, and the Splete Award for Civil Rights from the National Association of Independent Colleges & Universities. Together with his co-founder and wife, Gloria De León, the lessons from his parents and supported by his children, Nicole, Roy, Marc and Chris, his extended De León family, and his beloved NHI familia, Ernesto Nieto has built an institution that does not merely train leaders but transforms futures. His impact resonates in classrooms and boardrooms, in communities from the Rio Grande Valley to Puerto Rico, from Chicago to Mexico City, and across continents—reminding us that the strength of a nation, and indeed the world, rests on the gifts of its people.

Mr. Speaker, as we celebrate Ernesto Nieto's 85th birthday, we recognize a man whose vision and persistence created not just an organization, but a movement. His life affirms that when communities invest in their youth, they invest in their future. For generations to come, the National Hispanic Institute will stand as a living testament to his belief that Latino communities are assets to be celebrated and empowered.

On behalf of my colleagues in Congress, I extend heartfelt congratulations to Ernesto Nieto. May his example continue to inspire leaders for generations, and may his life's work remind us all of the enduring power of vision, faith, and relentless commitment to awakening the leaders already within us, and among us.

Mrs. TRAHAN. Mr. Speaker, I rise today in recognition of September as Childhood Cancer Awareness Month and to highlight two bipartisan bills, the Give Kids a Chance Act and the BRAIN Act, that will help save lives. Cancer is a disease which affects nearly every household and community around the country, and nowhere is it more heartbreaking than when it affects our children.

This month marks an opportunity to raise awareness for childhood cancer and support research for new treatment and therapy avenues. Just this year alone, nearly 10,000 children will be diagnosed with pediatric cancer. This is an issue that could not be more important and pressing.

The Give Kids a Chance Act removes many of the hurdles and barriers to researching treatments for rare pediatric diseases. It restores FDA incentives through the Rare Pediatric Disease Priority Review Voucher Program, encouraging companies to develop drugs for rare childhood diseases. The PRV program has already helped develop new treatments for 200,000 patients spanning nearly 50 rare diseases. Muscular dystrophy, sickle cell, and tropical diseases have all seen medical breakthroughs during this program.

Give Kids a Chance will also reauthorize the FDA to take action against drug sponsors that fail to comply with pediatric study requirements. Thus, ensuring that patients get the latest and best treatments that they require. As Dr. Benjamin Ebert, President of Dana-Faber, said, "sustained federal investment is needed to ensure that every child has the opportunity for a life free from disease." This bill would cement that investment and sustain our leadership in biotechnology, while costing the taxpayer nothing.

Similarly, the BRAIN Act is another common-sense, bipartisan piece of legislation that

will advance pediatric care. Recently, brain cancer has passed leukemia as the leading cause of cancer-related deaths of pediatric patients. While the number of cases is growing, survival rates have remained stagnant for 45 years. This needs to change.

The BRAIN Act will increase awareness for clinical trials, invest funding into glioblastoma therapeutics and cellular immunotherapy research, and authorize the FDA to ensure brain tumor patient access to clinical trials. Many aggressive pediatric cases have a survival rate of less than the average school year. We have the responsibility and opportunity to try and change that. Echoing what David Arons, of the National Brain Tumor Society, stated, “now is the time to build on government support for research and access to care for cancer patients.”

During this Childhood Cancer Awareness Month, I urge my colleagues to support these two bipartisan bills and give pediatric patients, across the country, a better chance to fight and survive.

Prostate Cancer is one of the most common cancers among men. As such, efforts that increase awareness of early detection, treatment, survival, and long-term health are vital.

As the second leading cause of cancer death in men, every 15 minutes a man dies from Prostate Cancer. More than 35,000 patients are projected to lose their lives to this disease in 2025 alone. However, early detection through regular screenings can significantly improve treatment outcomes and quality of life.

When detected in its early stages, Prostate Cancer is highly treatable, and patients have a wider range of options due to state-of-the-art innovations. The relative 5-year survival rate for Prostate Cancer diagnosed in its earliest stages is over 99 percent. Today, there are more than 3.3 million prostate cancer survivors.

However, Prostate Cancer incidence is increasing in the U.S.—after a period of decline, driven primarily by a rise in advanced-stage and distant-stage diagnoses—posing serious threats to the health of men in our Nation. The 5-year survival rate for advanced or metastatic prostate cancer drops to 37 percent—though early detection and treatment can prevent the cancer from spreading to other body organs, significantly improving long-term survival rates.

We must also recognize the dedicated healthcare professionals, as well as world-renowned expertise, seeking effective treatments of Prostate Cancer and other forms of Cancer, both in my congressional district in Northeast Ohio and throughout the Nation. Innovation in medical technology leads to better outcomes and a higher value of overall care. Broad advancements, including state-of-the-art non-invasive precision treatments, among others, have the capacity to revolutionize patient care and improve health outcomes.

It is sobering that one in eight men is diagnosed in their lifetime. Prostate Cancer impacts men from all walks of life, from urban centers to rural communities across America. While particularly affecting underserved populations, its reach touches even those in the highest profiles of public life, even those in this body.

Despite advancements in early detection and treatment, Prostate Cancer continues to exact a devastating toll on our nation, as a man is diagnosed with Prostate Cancer every two minutes in America. Therefore, the critical nature of saving lives from Prostate Cancer through awareness, education, and support is paramount.

I applaud H. Res. 675, recognizing September as National Prostate Cancer Awareness Month, for which I am a cosponsor, and thank my colleagues for these efforts. More importantly, I commend those who have been touched by this devastating disease, including Tim Hecker in my home state of Ohio, as well as local cancer advocates, for their tireless commitment. Our Nation must lead the way in ending the devastating impacts of Prostate Cancer—with an urgent focus on breaking barriers for long-term health and survival for men in the United States.

On October 19, 1969, His All-Holiness Ecumenical Patriarch Bartholomew was ordained to the Holy Priesthood, and later elected Ecumenical Patriarch in 1972 as its director. On Christmas Day, 1973, His All-Holiness Ecumenical Patriarch Bartholomew was consecrated as bishop and remained as head of the Personal Patriarchal Office until his enthronement as the Metropolitan of Chalcedon on January 14, 1990, and later unanimously elected as Archbishop of Constantinople, New Rome on October 2, 1991.

For more than three decades, His All-Holiness Ecumenical Patriarch Bartholomew has traveled throughout the world, addressing global audiences and fostering spiritual connections. His leadership and theological background provide him with a unique perspective and inspire the values of unity, inclusivity, and mutual respect.

Stanley developed the Topologically Integrated Geographic Encoding and Referencing system (TIGER) and the Reaching Every Single Person on the Nation's Decennial (Operation RESPOND) program. His work on these matters revolutionized Census operations and continue to serve as part of the bedrock of Census operations to this day.

His work led him to receive accolades, including the Bronze Medal for Superior Service, the Silver Medal Award for Meritorious Service, and the Gold Medal Award for Exceptional Service. He is also a recipient of the prestigious Hammer Award for National Partnership for Reinventing Government.

In addition to his meritorious government service, Stanley was a powerful advocate for equality and justice throughout Chicago. In the 1970s, Stanley was instrumental in the desegregation of Chicago housing. His 4-year long legal battle against racial discrimination culminated in his success in court and the purchase of a new home in the Beverly community. Through his search for justice and equality, Stanley led the way for countless others to continue to work against the evils of segregation.

I would like to express my gratitude to Stanley for his service and ask my colleagues to join me in celebrating his 90th birthday.

Seventy-five years ago, in the bitter winter of 1950, 30,000 United Nations forces, most of them United States Marines, were surrounded by more than 120,000 Chinese troops near the Chosin Reservoir in North Korea. Facing the freezing conditions, overwhelming odds, and heavy casualties, these men executed a successful fighting retreat to the port of Hungnam. In doing so, these heroes evacuated over 100,000 troops and civilians, through unyielding courage, sacrifice, and determination.

The Battle of Chosin Reservoir is remembered not only for the extreme conditions that were faced, but more importantly the courage of those who fought. Over the course of 14 days, 17 Medals of Honor and 78 Service Cross Medals were awarded to these men for their actions in combat.

Mr. Speaker, as chairman of the House Committee on Veterans' Affairs, I ask all of my colleagues to join me in honoring the Chosin Few and in recognizing the enduring legacy of courage, sacrifice, and freedom that their service represents.

He later moved with his family to Derwood, Maryland, where he graduated from Colonel Zadok Magruder High School in 1993. From a young age, Robert demonstrated a strong commitment to service, a trait that would guide the course of his life and career.

On October 10, 2000, he joined the District of Columbia Fire and Emergency Medical Services Department. Following the successful completion of his recruit training, he was assigned to Engine Company 14 in the Fort Totten area of Washington, D.C., in February 2001. Over the next two decades, he served with distinction in some of the department's most challenging and demanding assignments.

Rob was a proud and dedicated member of the Trinidad firehouse, known as the "House of Pain," a firehouse which was repeatedly recognized as the busiest in the entire United States. It was there that he earned a reputation for courage, professionalism, and unwavering commitment to those he served alongside. He later rose to the rank of Lieutenant and was assigned to Rescue Squad 2, one of the most elite companies within the department.

In 2023, Lieutenant Heaney was diagnosed with bladder cancer, a condition now recognized as an occupational illness associated with the fire service. Despite his diagnosis, he continued to show up with determination and resolve, remaining steadfast in his dedication to the job and his colleagues. On January 22, 2025, at the age of 49, he passed away from occupational cancer. His death was formally recognized as a line-of-duty death.

Lieutenant Heaney is survived by his loving wife, Beth Heaney, and their two children, Molly and Finn. He also leaves behind his father, Robert Heaney Sr., his brother Sean, and his sister, Kellie.

Lieutenant Robert John Heaney's legacy is one of service, sacrifice, and honor. His memory lives on through his family, his colleagues, and the countless lives he touched throughout his career. It is an honor to enter Lieutenant Heaney's legacy in the CONGRESSIONAL RECORD, and I extend my deepest gratitude for his devotion to others.

Music was her lifelong ministry. Dr. Gamble served as organist, choir director, and soloist for churches in New Jersey, Georgia, and South Carolina. She was a founding member of the National Baptist Convention USA Choir Auxiliary, served faithfully with New Ebenezer Baptist Church in Florence where her husband pastored, and was inducted into the South Carolina Baptist E&M Convention's Music Hall of Fame. She believed that music was a way God spoke to her, and she shared that gift in sanctuaries, classrooms, and celebrations across decades.

Dr. Gamble's professional life was equally impactful. She taught in higher education, guided young people through the Williamsburg County School District and Williamsburg Technical College, and directed grant-writing efforts that secured a \$25 million Race to the Top award. Even after retiring, she continued to consult with school districts and local governments, championing programs to improve education, healthcare, and opportunities for rural communities.

Her civic and cultural service extended through many affiliations, including the Lions Club, the American Leadership Forum, and her beloved Alpha Kappa Alpha Sorority, Inc. Initiated into AKA in 1986, she served as president of two chapters, including Lambda Theta Omega Chapter in Kingstree, South Carolina, and exemplified the sorority's motto of "service to all mankind." Known for her elegance and joy, she approached each conference, convention, and gathering with grace, flair, and her radiant smile.

At the heart of her life was her family. She married Rev. Dr. Norman Gamble in 1993, and together they raised four children—Ti-Esha, Cambridge, Na-Dya, and Malcolm—in stilling in them the values of faith, education, and service. She delighted in her role as "Mommy La" to her grandchildren, Landon and Tihler.

Even during her courageous battle with pancreatic cancer, Dr. Gamble remained a beacon of hope. She brought joy to others with her trademark "fashion show" entrances at chemotherapy treatments and inspired countless friends and strangers through her uplifting messages of faith shared online.

She was a woman of deep faith, boundless energy, and remarkable talent who gave of herself in every sphere of life.
