Expressing Condolences and Support for Families and Communities in Evergreen, Colorado: Committee on the Judiciary was discharged from further consideration of S. Res. 396, condemning the tragic act of violence on September 10, 2025, in Evergreen, Colorado, recognizing the victims, survivors, and responders, and expressing condolences and support to their families and their communities, and the resolution was then agreed to. **Page S6882**
