Continuing Appropriations and Extensions and Other Matters Act: By 47 yeas to 53 nays (Vote No. 536), three-fifths of those Senators duly chosen and sworn, not having voted in the affirmative, Senate rejected the motion to close further debate on the motion to proceed to consideration of S. 2882, making continuing appropriations for the fiscal year ending September 30, 2026. **Pages S6893–94**
