Since its incorporation in 1895, The Ariel Club has provided a supportive social environment for women of Asbury Park to connect, share experiences, and foster friendships.

Together, 10 women chartered and founded the first Asbury Park ariel cycles club to pair bicycle riding throughout the city with the community. Social clubs create a space for people to connect with their interests, hobbies, and businesses, and foster purposeful and influential partnerships. The Ariel Club's earliest rewarding community endeavors have transpired into a meaningful practice for several generations of women to follow.

In 1896, members began a collective effort to raise funds, volunteer their time, and donate supplies to the Asbury Park Library. This renowned group of women raised \$4,000 for the library of Asbury Park. Over the years, they have donated a beautiful large mahogany mantle clock, sponsored a beloved reading room, and continued to finance the clock's repairs today. It is a significant achievement that the Asbury Park Library could undergo several refurbishment projects and remain a fine resource for residents of Asbury Park after all these years. With forty current members, The Ariel Club remains a vibrant tight-knit group whose positive impact on the greater community stands as a special reminder of the value of neighborly connection.

It is my privilege to honor The Ariel Club as its members mark this historic 130th anniversary, and I ask my colleagues to join me in celebrating this milestone. The Ariel Club truly deserves this body's recognition.

HONORING THE 125TH ANNIVERSARY OF CRANFORD UNITED METHODIST MEMORIAL CHAPEL

Mr. BEYER. Mr. Speaker, I seek to recognize the 125th anniversary of Cranford United Methodist Memorial Chapel, a spiritual home deeply rooted in the history of Fairfax County and the American story itself.

The site predates Fairfax County, which was found in 1742, starting and still serving as a place of worship and gathering. Originally home to Pohick Church, established in 1730, it counted among its vestry members George

Washington and George Mason. The surrounding cemetery, the oldest in the county, dates back to the same year and has been researched and preserved for centuries. Over 200 unmarked graves have been discovered and marked. This historic grave is where soldiers from the Revolutionary War and the Civil War lie to rest.

The site's spiritual legacy continued through the Methodist movement, with John Lewis and early circuit riders holding meetings here as far back as the early 1800's. By 1830, a formal Methodist congregation had been established, leading to the construction of Lewis Chapel in 1857, a humble building that served as a chapel, schoolhouse, and even a Civil War hospital. Its walls still bear visible traces of that history.

In 1900, local craftsman James Cranford built the present-day church, consecrated as Cranford United Methodist Memorial Chapel. 125 years later, it remains a sacred house of worship in Northern Virginia, interweaving community, service, history, and faith.

Mr. PALLONE. Mr. Speaker, I rise today to recognize and congratulate Dr. Bruce Siegel on his retirement after an extraordinary career as a leader in public health, hospital administration, and health policy. Bruce has spent his entire career advocating on behalf of our Nation's most at-risk populations and the providers that care for them. For the past 14 years he has led America's Essential Hospitals, formerly the National Association of Public Hospitals, championing the cause of mission-driven safety net hospitals that serve communities facing the greatest social and financial barriers to care.

During Dr. Siegel's tenure, he led efforts to preserve the 340B Drug Pricing Program, secured targeted safety-net hospital funding during the COVID-19 pandemic, and fought to close Medicaid payment gaps. He was instrumental in stopping harmful cuts to Medicaid DSH funding. Perhaps most notably, Dr. Siegel spearheaded a national campaign to incorporate social risk factors into federal value-based purchasing programs—an important step toward recognizing and addressing health disparities in policy and practice.

Dr. Siegel's medical career began after graduating from the Joan & Sanford I. Weill Medical College of Cornell University and reflects a deep commitment to public service and health equity. From his early days as New Jersey's Commissioner of Health to his leadership of NYC Health+Hospitals and Tampa General Hospital, and later as a professor and director at The George Washington University, Dr. Siegel has consistently worked to improve care for the most vulnerable among us, performing pioneering research into health care quality, health care disparities, and the safety

net. He has had a significant and positive impact on our health care system, and his contributions will be sorely missed.

Mr. Speaker, my staff and I thank Dr. Siegel for his tireless dedication and leadership. His legacy will continue to inspire future generations of health care advocates and public servants.

Pennsylvania's Sikh community, whose roots trace back to the State of Punjab in India, began immigrating to our Nation more than a century ago. These remarkable Americans have played a vital role in the growth and vitality of the Keystone State and have enriched their communities through their commitment to tolerance, service, and civic engagement.

These extraordinary ideals reflect the Sikh tradition of seeking peace through equality, fraternity, and respect, while striving to overcome division through sacred teachings and the admirable tenets of honest work, charity, volunteerism, and sharing with those in need.

Ms. KAPTUR. Mr. Speaker. I rise to recognize a significant milestone in the life of St. Peter's United Church of Christ in Millbury, Ohio. The congregation celebrates its 150th anniversary on Sunday, October 12, 2025.

Only one year after the founding of Millbury, St. Peter's Church was founded in 1875 by twelve families of German immigrants who came together to form the German Evangelical United St. Peter's Congregation. It is the oldest continuous church in the community. Church records show that the first meeting took place at the home of Adam Martin, a home that stands yet today, and was officiated by Reverend Andrews of Genoa St. John's Church.

A fire sparked by a passing train burned the newly constructed building in 1878 and a new building was finally completed in 1884 using the railroad settlement. That year, the church adopted its first constitution. In 1908 a parsonage was built and a minister was hired.

The following years brought growth along with stained glass windows and a pipe organ. In 1934 following a national merger the congregation was renamed St. Peter's Evangelical and Reformed Church. Since a 1957 merger the church has held its current name, St. Peter's United Church of Christ.

Branching out into the community in the 1950's, adjacent land was purchased and a park was built which serves the neighborhood, gardens and athletic teams. Uniquely, a boulder which resembled the image of Christ at

Gethsemane was unearthed in 1969. Moved next to the church, a plaque was inscribed with Mathew 16:18, "And I say unto thee, that thou art Peter, and upon this rock I will build my church; and the gates of hell shall not prevail against it."

Believing that "every generation is called to live out its faith in meaningful worship, honest reflection and sincere devotion to God," the church continued to grow through the decades. A youth program produced musical groups Kid's Praise and The Light Brigade which toured the states in our region and visited the Creation Music Festival in Pennsylvania. Community services continued throughout, as the congregation supports food pantries, partners with service organization, has hosted an AA chapter for over forty years, opened its doors following a devastating tornado and became a Red Cross command post, and adapted to COVID by offering a "parking lot church" and live streaming which continues to this day. Also during this time the congregation merged with its shared church Eastminster United Presbyterian Church so the two congregations now worship as one.

For an astounding 150 years, St. Peter's United Church of Christ lives up to the faith's motto, John 17:21: "That they may all be one." The church demonstrates this message while living Christ's message of Love and being "a welcoming place for all—no matter who you are or where you are on life's journey." As today's congregants celebrate this journey of 150 years, looking back with inspired recollection and renewed with a faith-filled purpose, we look forward to the next centuries of servant leadership in the community of Millbury and surrounding neighbors.

The goals of the UASC Tryzub align with preserving history, culture, tradition, and Ukrainian sport (specifically professional soccer). Their home-base in Horsham township continues to be a center where the community comes together. Some notable achievements of the UASC Tryzub include in 1856 the Club's Majors' Division soccer team reached the national championship game for the coveted US Amateur Cup. A year later the UASC Tryzub organized a professional soccer franchise; the Philadelphia Ukrainian Nationals, which generated many professional championships onto the City of Philadelphia. These achievements, along with many others, brought a downpour of glory and attention to Philadelphia from the international soccer world.

Today, 56 teams and 800 athletes, known as the "Ukie Nation" proudly wear blue and yellow and play under the Philadelphia Ukrainian Nationals Banner. Travel and club teams, including all skill levels, are offered for boys and girls all year round. The UASC Tryzub is not only notable for their achievements, but for giving back to the community. The players develop and improve not only their soccer skills but their personal goals as well. Through scholarships, volunteering, and community efforts to preserve Ukrainian heritage and bring awareness to those in need, the Tryzub continues to support and grow the Ukrainian American community.

In times of need, their service is a testament to the belief that an individual's dedication can ripple through the lives of many, sparking change, fostering resilience, and inspiring hope. Today, we honor the UASC Tryzub not just for their remarkable deeds but for fostering an incredible community.

Mr. Speaker, their actions remind us that progress is not forged in grand gestures but in the cumulative power of selfless acts. They embody the timeless American values of resilience, generosity, and compassion, showing us that the future is built by those who care deeply, act decisively, and give without hesitation.
