Mr. CASE. Mr. Speaker, I rise today to say aloha and congratulations to the newest cohort of Teach For America (TFA) Hawaii.

TFA, a critical national nonprofit partner since 1989 in our effort to eliminate educational inequality, continues its mission to “enlist, develop, and mobilize as many as possible of our Nation’s most promising future leaders to grow and strengthen the movement for educational excellence.” By recruiting and training college graduates to teach in high-need schools for at least two years, it aims to expand educational opportunities for all.

This school year, TFA Hawaii marks its 20th year of service to the State of Hawaii by welcoming 103 corps members to classrooms across our islands. In total, the TFA network in Hawaii now has 631 corps members and alumni, collectively improving the lives of over 18,000 students.

I especially commend the program’s focus on locally-rooted leadership. TFA Hawaii has recruited 259 corps members and alumni who are kama‘āina, born and raised in our islands, including 89 Kānaka Maoli. They embody the sense of kuleana and community responsibility necessary to provide critical education support for our keiki.

The impacts of our TFA Hawaii kumu—or teachers—have lasted far beyond their initial commitment, with over 500 alumni remaining in education across Hawaii, 15 of them now serving as school leaders.

Their mission reminds us of the ‘ōlelo no‘eau “hahai no ka ua i ka ululā‘au.”: the rain follows the forest. By intentionally investing in this forest of local talent, we ensure a bright future for all our students.

I offer my mahalo to the new corps members and alumni for their continued service.

Ms. NORTON. Mr. Speaker, today, I introduce the Government Accountability Office District of Columbia Home Rule Act. This bill would repeal the authority of the U.S. Government Accountability Office (GAO) over the District of Columbia.

GAO, a federal agency that conducts investigations and audits for Congress, has the same authority over D.C. that it has over fed-

eral agencies. GAO's authorizing statute defines D.C. as a federal agency. In addition, GAO's authorizing statute and the D.C. Home Rule Act require GAO to engage in specific types of oversight of D.C.

D.C. is not a federal agency, and it should never be treated as such. D.C. already has a locally appointed auditor and inspector general, so GAO's authority over D.C. is both redundant and offensive. GAO does not have general authority over states and cities, and therefore it should not have such authority over D.C.

This bill is an important step to increase home rule for D.C. I urge my colleagues to support this bill.

Over the past year, the congregation of Salem Heller's Evangelical Reformed Church has commemorated three centuries of faith and service. The church's humble beginnings date back to a time before the founding of both Lancaster County and the United States. As the congregation concludes this year of celebration, it is fitting to honor its storied past and its promising future. For 300 years, Salem Heller's Evangelical Reformed Church has served as a bastion of faith and community for the people of Lancaster County. As generations continue to worship in this historic church, I know the congregation will continue

to serve its mission to both the community and its faith.

CELEBRATING DIANA NYAD

Ms. WASSERMAN SCHULTZ. Mr. Speaker, it is with great pleasure that I, along with Rep. Moskowitz, rise to recognize the tremendous achievements of Diana Nyad.

Diana Nyad was born in New York City on August 22, 1949, and raised in Ft. Lauderdale, Florida. She is a legendary endurance swimmer, author, inspirational speaker and sports journalist. She attended Pine Crest School in Ft. Lauderdale and later graduated Phi Beta Kappa from Lake Forest College.

Ms. Nyad gained fame by setting a new speed record for both men and women when she circled Manhattan Island in 1975 in 7 hours and 57 minutes. She was the first person to swim North to South across Lake Ontario in 1974, and was the world champion on the marathon circuit that year. Her first attempt to swim from Havana, Cuba to Key West, Florida was in 1978 and 35 years later, at the age of 64, Diana became the first to ever swim from Cuba to Florida without the aid of a shark cage—110.86 miles, 52 hours and 54 minutes.

Ms. Nyad was inducted into the United States National Women's Sports Hall of Fame in 1986. She is also an International Marathon Swimming Hall of Fame Honoree and an ISHOF Al Schoenfeld Media Award recipient. In addition to her illustrious career as an athlete, Ms. Nyad founded the national walking initiative EverWalk and wrote and starred in the off-Broadway play, *The Swimmer*.

In 2014, the City of Key West honored Ms. Nyad with an historic bronze plaque installed at Smathers Beach where she walked ashore at the end of her Cuba crossing. On November 6, 2025, a State of Florida Historic Marker tribute to Diana's inspirational life will be unveiled and eventually be on permanent display at Las Olas Beach in Ft. Lauderdale.

It is with great enthusiasm that I congratulate Ms. Nyad on her accomplishments and ask Floridians to join me in thanking her for contributing to our state's rich cultural history.
