HONORING THE 100TH BIRTHDAY OF MEYER LUSKIN

Mr. LIEU. Mr. Speaker, I rise today to recognize the contributions of visionary philanthropist Meyer Luskin. For decades, Mr. Luskin and his wife, Renee, have been civic and philanthropic leaders supporting academic and social causes throughout Southern California. Today, the impact of the Luskins' wide-ranging philanthropic giving can be seen across the campus of the University of California, Los Angeles, at local public schools and at leading medical centers in Southern California. It is my honor to celebrate his legacy on the occasion of his 100th birthday.

Meyer Luskin came from humble beginnings. Born in 1925, he was raised on the Lower East Side of New York where he lived until he was fourteen years old. His family then moved to Boyle Heights on the East Side of Los Angeles, one of LA's most densely populated and historic neighborhoods.

In 1942, Meyer began his college education at the age of seventeen, traveling seventeen miles every day by streetcars and buses to attend the University of California, Los Angeles. He left following his first year to serve in World War II with the U.S. Army Air Corps but returned thereafter to complete a bachelor's degree in economics in 1949. To this day, Meyer emphasizes that his ability to return to college was because of a \$30 scholarship he received, deepening his appreciation for philanthropy in support of higher education. After UCLA, Meyer went on to earn a Master of Business Administration degree from Stanford University in 1951.

Taking a risk, Meyer left his job as a stockbroker to found and develop Scope Industries, a company that was ahead of its time in recognizing the benefits of transforming food waste into profitable and useful resources. As a result, Meyer became a trailblazer in the recycling industry and served as company president, CEO and chairman over the course of his leadership. Alongside the growing success of Scope Industries, opportunities also grew for Meyer and his beloved wife, Renee, to pay forward their achievements.

The Luskins have played a transformative role in shaping UCLA's future through major philanthropic gifts focused on innovation, education and public service. In 2008, Meyer and Renee founded the UCLA Luskin Center for Innovation, an institute that develops ongoing programs focused on sustainable urban solutions including smart water systems, parklets, electric vehicle plans, solar power options and more. Their charitable commitment to the university deepened even further in 2011 with a transformative \$100 million gift that established the Luskin Conference Center. UCLA renamed the university's policy school to the Meyer and Renee Luskin School of Public Af-

fairs in their honor. This philanthropic donation by the Luskins reflected their belief in the institution's ability to tackle society's most pressing issues and foster effective collaboration across various academic and professional disciplines.

In 2019, the Luskins were awarded the esteemed UCLA Medal, the university's highest honor, in acknowledgment of their extraordinary contributions and lasting legacy. They were later named the Edward A. Dickson Alumni of the Year in 2020, another prestigious award for outstanding service to the university. Continuing their generosity, the Luskins made a historic \$25 million donation in 2024 to UCLA's Department of History, marking the largest single donation to both the department and the Division of Social Sciences. Most recently, Meyer was a founding donor to the California Institute for Immunology and Immunotherapy, part of the new UCLA Research Park at the former Westside Pavilion, which aims to support groundbreaking medical research and treatments.

In addition to pivotal donations to UCLA, Meyer has been involved in the university community and beyond through multiple leadership roles. He currently serves on the Board of Advisors for the UCLA Luskin School of Public Affairs, and the boards of the UCLA Luskin Center for History and Policy, and the Luskin Center for Innovation at UCLA. Meyer also serves on an advisory board to UCLA's Chancellor called the UCLA Second Century Council. Several of his past roles include Chairman of the Board of both the UCLA Medical Center and Orthopedic Hospital and the Orthopedic Institute for Children, as well as a member of the UCLA Centennial Campaign executive committee and the UCLA Foundation board of directors.

The Luskins' philanthropic support extends across the greater Los Angeles area, including the backing of arts and cultural entities such as the Los Angeles Philharmonic, Los Angeles Opera, Center Theatre Group and many other organizations.

This October, Meyer Luskin reaches the age of one hundred years old. The decades of leadership and generosity that he and his wife Renee have shown have served countless residents of Southern California and beyond. Los Angeles County and its institutions are stronger because of Meyer Luskin's civic engagement and generosity.

RECOGNIZING DANNY CHARLES MASUR WITH A CONGRESSIONAL VETERAN COMMENDATION

Mr. SESSIONS. Mr. Speaker, I rise today to honor Danny Charles Masur, of Rockdale, Texas, by presenting him with a Congressional Veteran Commendation. His persistent efforts in fostering beliefs of sacrifice and respect reflect his value as a leader during service and in retirement.

After completing his early education in Lockhart, Texas public schools, Danny enrolled at Southwest Texas State College. Within his first week there, he recognized the potential of the ROTC program, and after his first experience with them he was set on a path to earn his pilot's license, graduate, and head to Air Force Pilot Training as soon as possible. He dedicated five years and one day of service to his country before his release from active duty.

Beginning in June 1968, Danny spent a year at Del Rio's Laughlin AFB Pilot Training, and upon completion he was assigned to Dover AFB, Delaware's Military Airlift Command. He flew the C-133 Cargomaster, the largest military transport aircraft at that time. Danny flew special missions world-wide including flights into Vietnam, followed by European and Middle Eastern trips supporting our Nation's Cold War military exercises. He also flew into other various conflicts such as the Israel-Jordan Crisis, and across the world to Pakistan, Ethiopia, Panama, Greenland, and Libya. Danny had the privilege of flying the last C-133 to the Boneyard at Davis Monthan AFB, Arizona. He received the Air Force Commendation Medal, National Defense Service Medal, Small Arms Expert Marksmanship Ribbon, Armed Forces Expeditionary Medal, Republic of Vietnam Campaign Medal, and Air Force Outstanding Unit Award.

After leaving the Air Force, Danny became a tracking pilot/recovery supervisor at the National Center for Atmospheric Research. He was located in Palestine, Texas at their Balloon facility, wherein, alongside some of the world's top scientists and astrophysicists, he contributed to invaluable scientific discoveries in the facilities critical outer space work.

Danny then moved to work at the ALCOA plant in Rockdale, Texas, where he began

dedicating his life to his family and several community volunteer organizations. For twenty-two years he was a board member of the Rockdale Fair Association, as well as the Goat Superintendent and Vice-President of Fiscal Affairs. In 1982, he joined the Rockdale Knights of Columbus, serving as Columbus Club treasurer for 18 years and spending significant time as a Crew Leader. Since 2012, Danny has served as a Board Member for Minerva Water Supply Corporation; and for 17 years has served the Minerva community as a volunteer fireman where he currently serves as their treasurer.

Alongside his wife, Linda Matocha Masur, Danny has dedicated 58 years of marriage to raising four children and has extended his love and commitment to nurturing nine grandchildren and one great-grandchild.

Danny's heart has never left the sky. As a pilot in the Rockdale Flying Tigers Flight Club, Danny is an EAA member and works with the Young Eagles Flight Program giving introductory flights. He has been an instructor pilot for years, serving as a technical, emotional, and mental mentor to many students who have made piloting their career.

It is with great honor and respect that I present Danny Charles Masur with a Congressional Veteran Commendation from the 17th Congressional District of Texas. His exemplary service to our Nation and continued contributions to his community stand as an inspiration to us all.

Mr. MULLIN. Mr. Speaker, I rise today to honor and recognize Mr. John Holger Lyngso, a remarkable 97-year-old World War II veteran, lifelong entrepreneur, and beloved member of the San Mateo County community. Born on April 18, 1928, in San Francisco, California, to Alfred Holger Lyngso and Edith Schack, John's story is a testament to the ideals upon which our Nation was built: service, perseverance, and aspirations. His parents immigrated from Denmark in the early 1920's, and their maritime heritage instilled in John a lifelong love of the ocean nurtured by family stories and, as he proudly put it, "Viking blood."

At just sixteen, driven by a sense of duty and adventure, John enlisted in the United States Merchant Marine on December 22, 1944, serving as an oiler aboard the U.S. Army tug *LT-518*. Often referred to as the "fourth arm of defense" during World War II, the Merchant Marine played a critical role in transporting troops, equipment, and supplies across dangerous waters, ensuring the success of Allied operations. From the final days of the war through its aftermath, John contributed to the vital maritime efforts that sustained American forces and supported victory around the globe.

Following his service, John continued to embody the values of hard work and perseverance. On August 28, 1950, he married Mary Eva Morris in San Francisco, beginning a marriage and family legacy that would span generations. Together, they built what would become a cornerstone of our local community, Lyngso Garden Materials. Initially, John did grading, including work on Highway 101. The business grew by accident, when John discovered that there was a market for different types of gravel. Everyone who saw the gravel wanted some, and a business was born. He would later name the stone mixes after his daughters. What began as a modest backhoe and hauling service grew into Redwood City's first landscape materials business, a thriving enterprise that remains to this day. John's en-

trepreneurial journey embodies the American dream: identifying a need, serving his community, and building lasting success from humble beginnings.

Rooted in his maritime heritage, he captained boats well into his 80's, including a memorable 2012 voyage from Ensenada, Mexico to San Francisco, California, to bring home his final vessel, an N37 trawler named *Lena*. The 550-mile trip took nine days steaming up the California coast, stopping first at San Diego to clear into the country, at Morro Bay for a rest, and at Monterey for repairs before finally passing under the Golden Gate Bridge. Throughout the journey, John displayed his ability and agility in the engine room, kept his appetite despite rough seas, and entertained his companions with his humor.

Today, John Lyngso is the proud patriarch of a large and loving family, including three daughters, five grandchildren, nine great-grandchildren, with one on the way, and two great-great-grandchildren. His legacy is one of faith, dedication, and boundless curiosity. Now at 97 years young, he remains committed to reaching his next goal of celebrating his 100th birthday, a milestone that, given his strength and determination, he is sure to reach.

Mr. Speaker, I ask my colleagues to join me in recognizing John Holger Lyngso for a lifetime of devoted service and unwavering purpose. His service during World War II, his entrepreneurial contributions to the San Francisco Bay Area, and devotion to family, hard work, and community are appreciated and admired.

Commander High is originally from Cincinnati and Mansfield, Ohio. He earned a Bachelor of Arts in History/Political Science from Otterbein University. He and his wife Lyssa have lived in Lexington since 1999. They have two sons, Jackson and Harrison.

With no prior military experience, High requested and was granted a Direct Commission as a U.S. Navy Reserve Public Affairs Officer following the terrorist attacks on our Nation on September 11, 2001. He was commissioned as an Ensign in April 2002. He has served in numerous Navy Public Affairs Reserve units in his career, including the Navy Media Center, Washington, D.C. and the Sixth Fleet Public Affairs in Naples, Italy. In 2009 and again in 2010, Commander High was deployed for the Africa Partnership Station missions. He was recalled to active duty and deployed to Kabul, Afghanistan in 2017 as part of NATO's Resolute Support Mission. For his service in Afghanistan while under fire, he was awarded the Defense Meritorious Service Medal, NATO Service Medal, and Afghanistan Campaign Medal.

Many of Commander High's other missions throughout his Navy career involve conducting media training for Navy Leadership and Navy Mass Communication Specialists. These trainings have occurred on many overseas bases as well as stateside. He has also produced several video programs for the Navy. Commander High has been decorated with the Meritorious Service Medal (twice), the Navy Commendation Medal, and the Navy Achievement Medal (5 awards).

In civilian life, Doug High has served for the past 16 years as a News Anchor for WTVQ-TV ABC 36 in Lexington. He is an EMMY Award winning documentary film producer/director and has four additional EMMY nominations. For four years, he served as Executive Director of the Kentucky Historical Society.

Mr. TRAN. Mr. Speaker, it is with solemn remembrance that I rise today to pay tribute to a beloved husband, devoted father, thoughtful grandfather, and courageous Purple Heart Veteran, Ramon Vicioso. Ramon, known as Ray to those close to him, passed away peacefully on September 28, 2025, at the age of 93.

Ray was born in New York City, grew up in the Bronx borough, and enlisted in the United States Marine Corp on October 23, 1947 at the age of 17 with his father's permission. He was first stationed at Camp Pendleton in Southern California before being sent to the frontlines of the Korean War. In July 1951, his tank platoon in Korea was traveling down a road when foot soldiers came up behind them. The tanks were ordered to pull off the road, unknowingly into a mine field, to let the soldiers pass. Unfortunately, Ray's tank was one of the first to be blown up, which resulted in his left leg being amputated and his right leg severely damaged. Upon returning to California, Ray continued his recovery, was awarded the Korean Service Medal, and received a Purple Heart for his sacrifice in the war.

As he transitioned back into civilian life in the 1960's, he began his long career in aerospace planning for Bendix and later Martin Marietta, supporting their critical efforts in the race to outer space as well as working on the latter's Titan IV launch team. Ray retired in Nevada where he was an active member of the local veteran community. He was known for his unwavering pride in the Marines and his own service, never complaining about what happened to him in Korea.

Ray was also a beloved husband, father, and grandfather. While his wife of over 40 years, Patricia Vicioso, passed away in 2024, he is survived by his five children, Victoria Hoffman, Ted Vicioso, David Vicioso, Paul Iverson, and one of my constituents, Beth Brown, as well as several grandchildren and great-grandchildren. I have requested that the United States flag be flown over our Nation's Capital in recognition of Ray's life and sacrifice to this country. Ray will be dearly missed by his friends and family, and his fiery legacy will continue on in the hearts of everyone who knew him.

Bill has served on committees and boards repeatedly since moving to Milam County, as his leadership cannot go unnoticed. In the early 2000's, he was selected to serve on the committee tasked with developing the new jail for Milam County. His work with this committee led to the conversion of an old hospital into the new offices for the Sheriff's Department, the Texas Department of Public Safety, Precinct One and Two Justices of the Peace, and attached to all of this was a new modern jail.

Bill has served on the Cameron Housing Board, as member and director, and currently serves on the Board of Directors for the North Milam Water Supply District and served as a city councilman for years. From 2000 to 2024, he served as the Mayor of Cameron, stepping in to serve as Interim City Manager while the city was held without one. Bill does not simply lend a helping hand, but he truly commits himself to enforcing change and improvement where it is needed.

At nearly 77 years old, while raising three children and being a grandfather to two, many would have retired, but not Bill. He continues to work hard every day as the owner of multiple businesses, which he runs with his wife Gwyn. His service has been recognized by the Cameron Chamber of Commerce, which named him Citizen of the Year in 2007 and presented him with its Lifetime Achievement Award in 2023. As a man of great faith, Bill continues to serve as pastor of Davilla Baptist Church.

Through community, both broadly as an American and much more personally in any number of ways, through family, and of course through a strong commitment to faith, Bill has made himself more than worthy of this achievement.

This vision allowed the region to transition from an agricultural hub to a thriving residential and commercial community, while safeguarding one of its most vital resources.

In 1987, the District completed the Miramar Water and Hydroelectric Facility, a \$30 million project that strengthened water storage, distribution, and energy infrastructure, demonstrating the careful planning and collaboration executed by Three Valleys, the City of La Verne, and Golden State Water Company.

Today, Three Valleys provides water to 13 member agencies, continuing to support the Pomona Valley's growth and resilience.

The District has also earned recognition for excellence in governance, earning its District of Distinction accreditation in 2014 and again in 2024, along with the District Transparency Certificate of Excellence, reflecting its commitment to ethical leadership and public accountability.

Solebury School has been a cornerstone of independent education in Bucks County, known for its close-knit community, academic excellence, and commitment to fostering intellectual curiosity and character in young people.

Solebury School was founded in 1925 by four visionary educators, Laurie Erskine, Julian Lathrop, Robert Shaw, and Arthur "Doc" Washburn, who shared a dream of creating a new kind of educational environment. As the school's first headmaster, Doc Washburn captured that vision best when he wrote, "Our goal is to start a small school with an informal atmosphere, where the needs of each boy would be attended to, where friendship between teachers and pupils would be encouraged, and where a boy would be prepared not only for college, but for life beyond high school."

From those humble beginnings, Solebury School opened its doors in rented quarters in September 1925 with just four boys and four teachers. One year later, the founders purchased the historic Michener Farm, establishing the permanent campus that continues to serve generations of students to this day.

Just down the road from Solebury stood the Holmquist School for Girls, founded in 1917 by Miss Karlina Holmquist, who shared a similar belief that education should help each student discover and develop her unique talents and capabilities. As both schools grew, they often collaborated, sharing theatrical productions, musical performances, proms, teas, and community gatherings. In 1949, these two institutions united to form one of the first coeducational independent schools in the Nation: Solebury School, as we know it today.

On October 1, 2025, Solebury marked 100 years since its first day of classes. Over the past century, Solebury School has remained

steadfast in its founding ideals such as personal attention, intellectual curiosity, and a deep respect for individuality. The school's faculty, students, and alumni continue to embody these values, carrying forward the founders' dream of education that not only prepares young people for college, but also for meaningful, purposeful lives beyond the classroom.

INTRODUCTION OF THE FEDERAL GOVERNMENT ADVERTISING EQUITY ACCOUNTABILITY ACT

Ms. NORTON. Mr. Speaker, today, I introduce the Federal Government Advertising Equity Accountability Act, which would require all federal agencies to include in their annual budget requests to Congress the amount they spend on advertising contracts with small disadvantaged businesses (SDBs) and businesses owned by minorities and women. Federal agencies would be required to provide prior and projected total expenditures for such contracts. At my request, the Committee on Appropriations has required many federal agencies to provide such information each of the last several years, but this bill would codify this requirement and apply it to all federal agencies.

In 2007, the Government Accountability Office (GAO) examined spending on advertising contracts with minority-owned businesses by five federal agencies—the Department of Defense, the Department of the Treasury, the Department of Health and Human Services, the Department of the Interior and the National Aeronautics and Space Administration—and found that only five percent of the \$4.3 billion available for advertising contracts went to minority-owned businesses. In light of these concerning findings, I, along with several other Members of Congress, sent letters to GAO in 2016 and 2022 requesting updated information on the amount of federal advertising dollars spent with SDBs and businesses owned by minorities and women. In 2018 and 2024, GAO issued reports on the amount of federal advertising dollars spent with SDBs and businesses owned by minorities and women. The 2024 report revealed that only 15 percent of federal advertising contract obligations went to SDBs and businesses owned by minorities and women. The federal government is one of the largest advertisers in the United States, and it has an obligation to ensure equitable access to its contracts for SDBs and businesses owned by minorities and women. GAO's findings demonstrate that there is still much progress to be made.

The regular collection of information on federal advertising contracts with SDBs and businesses owned by women and minorities is essential to bridging the gap between what current statistics show and a more inclusive advertising landscape. This bill would help achieve this goal while also promoting transparency and encouraging federal agencies to strive to reach minorities, who often receive the news from smaller media outlets that serve communities of color. The requirement that agencies submit prior and projected information on the amount of advertising dollars spent with SDBs and businesses owned by minorities and women would allow federal agencies to evaluate their progress. The regular collection of this information would also demonstrate that the promotion of equity in advertising and in all areas of government, is a continuous effort and is important to the mission of every federal agency.

I urge my colleagues to support this bill.
