Everett Timothy Sanders, a former resident of Jackson, Mississippi, graduated from Lanier High School and Tougaloo College with a Bachelor of Arts degree in 1968. Following graduation, he enrolled in the University of Kentucky College of Law. His law school tenure was interrupted by his service in the U.S. Army. After his discharge, he returned to law school and graduated in December 1972.

After graduating from the University of Kentucky College of Law, Mr. Sanders worked for the Kentucky Labor Department. In 1974, he returned home, where he passed the Mississippi Bar Examination. In January 1975, Mr. Sanders entered practice with the law firm of Brown, Alexander, and Sanders.

In 1976, Mr. Sanders was elected County Prosecutor for Claiborne County, Mississippi, becoming the first African American to hold that position. He was also elected to two terms as the Democratic National Committeeman for the State of Mississippi from 2004 to 2012. Mr. Sanders has served in over 30 prestigious positions at both the state and federal levels. He is a member of the Magnolia Bar Association (former president), NAACP, and Alpha Phi Alpha Fraternity, Inc. (life member), among many other organizations. He is also an active member of the Knights of Peter Claver and Holy Family Catholic Church in Natchez, Mississippi.

He is married to Lillie Blackmon Sanders and is the father of two daughters, Aisha and Keshia.

Mr. BEGICH. Mr. Speaker, it is with solemn respect and heartfelt sympathy that we honor the life and legacy of Brenda Itta-Lee. Her passing is a loss not only to family and community, but to the entire State of Alaska. As we reflect on her life, we recognize a trailblazer whose leadership, vision, and cultural heritage shaped the course of Alaska's history.

Brenda was the first Iñupiaq woman elected to the Alaska State Legislature. Her election in 1974 broke barriers and opened doors that had been closed to Indigenous women in public office. Yet her impact extended far beyond that groundbreaking moment. She carried the weight of that role with strength, representing her people with dignity and resolve. From her work in the Governor's Office to her influential

role as a delegate at the 1971 Alaska Federation of Natives Conference, she helped define Indigenous self-determination for many generations.

Raised in Utqiagvik, Brenda understood the responsibility of public service in deeply personal terms. She never forgot her roots, and she never stopped giving back. Her career was marked not only by political leadership, but by mentorship and advocacy. Whether testifying before Congress or encouraging young Alaska Natives to pursue their dreams, she made space for others to rise with her. Her leadership was as much about listening as it was about speaking, and her influence lives on in the many lives she uplifted.

She once said that her greatest accomplishment was simply serving as a role model to young people in her region. But that was not a simple task. It was a conscious, consistent choice to carry herself with grace, pride, and purpose in boardrooms, in classrooms, and in moments of national consequence. Through her life's work, she preserved traditions, advanced representation, and brought the full strength of Iñupiaq values into the halls of government.

Brenda's legacy will remain a guiding light for Alaska.

HONORING THE VICTIMS AND FIRST RESPONDERS OF UNITED FLIGHT 629

Mr. EVANS of Colorado. Mr. Speaker, it is with a solemn heart that I rise today to honor the victims and first responders of United Airlines Flight 629, and to mark the upcoming 70th anniversary of one of Colorado's most heartbreaking tragedies.

On the evening of November 1, 1955, United Airlines Flight 629 departed Denver's Stapleton Field bound for Portland, Oregon. A short time later, the aircraft exploded in midair over Weld County—land now encompassed within my district, killing all thirty-nine passengers and five crew members on board. The cause of that explosion was later revealed to be a bomb—placed in a passenger's suitcase by her son, in an attempt to collect her life insurance benefits.

The wreckage rained down across farms near Longmont, where residents, law enforcement officers, and volunteer firefighters rushed toward the flames, with the hope of saving lives. Among them were local family farmers, whose land bore the brunt of the explosion, and community members who did not hesitate to serve in the face of unimaginable devastation.

In the days that followed, Weld County saw both deep sorrow and remarkable compassion. William "Clayton" Bearly, the longtime manager of Johnson's Corner, witnessed the explosion that night and immediately stepped forward to support first responders, investigators, and National Guard personnel. His quiet service stands as a reflection of the strength and kindness that Colorado communities show in times of crisis.

The Flight 629 tragedy would go on to leave a lasting imprint on Colorado and on the Na-

tion. It became a turning point in aviation security and a somber reminder of the fragility of life. But above all, it revealed the courage of ordinary Coloradans who responded with extraordinary grace.

This year, as we reflect on the tragedy of that night seventy years later, the Denver Police Museum, together with History Colorado, Wings Over the Rockies, the CELL, the University of Denver, FlyteCO Tower, and the Weld County Flight 629 Memorial Committee, will unveil permanent memorials in both Denver and Weld County to honor those who were lost as well as those who answered the call.

Mr. Speaker, every passing year does not diminish the pain of this tragedy, nor does it lessen our duty to remember. Today, we honor the forty-four innocent lives who perished aboard Flight 629 by including their names into the RECORD, that they may never be forgotten:

"Jack" Ambrose, Samuel Arthur, Bror and Irene Beckstrom, John Bomelyn, Frank Brennan, Louise Bunch, Brad and Carol Bynum, Thomas Crouch, Barbara Cruse, Carl Deist, John Des Jardins, James and Sarah Dorey, Gurney and Elizabeth Edwards, Helen Fitzpatrick and son James, Lee Hall, Virgil and Goldie Herman, Elton Hickok, Jacqueline Hinds, Marion Hobgood, John Jungels, Daisie King, Gerald and Patricia Lipke, Lela McClain, Stewart and Suzanne Morgan, Peggy Peddicord, James Purvis, Herbert Robertson, Harold Sandstead, Sally Scofield, Jesse Sizemore, James Straud, Clarence Todd, Ralph and Minnie VanValin, Donald White, and Alma Winsor.

Mr. Speaker, may we remember each of these forty-four souls with reverence, and may we honor the first responders and citizens who ran toward danger that night with gratitude and respect. Their courage, compassion, and resilience continue to define the spirit of Colorado.

May their memory be eternal, and may God grant peace to the families who still carry this loss, knowing that their loved ones are remembered by a grateful state and Nation.

**INTRODUCTION OF THE DISTRICT
OF COLUMBIA GOVERNMENT
TITLE EQUALITY ACT**

Ms. NORTON. Mr. Speaker, today, I introduce the District of Columbia Government Title Equality Act. This bill would amend the District of Columbia Home Rule Act to redesignate the Mayor as the Governor, the Council as the Legislative Assembly, the Councilmembers as Representatives and the Chair of the Council as the Speaker. The new titles are the ones used in the State of Washington, Douglass Commonwealth constitution, which D.C. adopted in 2016 in anticipation of

enactment of the Washington, D.C. Admission Act, which would make D.C. the 51st state.

I introduce this bill to highlight to the American people and Members of Congress that the transition to statehood would be seamless, because D.C. already operates as the functional equivalent of a state, providing state-, county- and city-level services, despite being denied voting representation in Congress and full local self-government. This bill would not change any legal authorities.

I urge my colleagues to support this bill.

Mr. CROW. Mr. Speaker, I rise today to recognize and celebrate the recent opening of the Community College of Aurora's Center for Applied Science and Technology (CAST) Building in Aurora, Colorado.

This is the first new building the college has opened in 20 years, and it marks a significant milestone. The CAST Building will house high-demand programs such as construction, diesel power mechanics, cybersecurity, engineering,

and renewable energy. It will open new pathways for students and create lasting opportunities that will benefit both the college and the surrounding community for years to come.

CAST will host programs in partnership with BuildStrong Academy of Colorado, including industry aligned workforce training programs in construction, skilled trades, and applied technologies. This will open up further pipelines of skilled students who will enter the Colorado workforce in industries that are in considerable demand.

Furthermore, with the leadership of Dr. Mordecai Brownlee, the Community College of Aurora has experienced remarkable growth and progress. In August, the college opened its third campus in Centennial, focused on health care and first responder training. This new campus expands access to career-ready health sciences programs and student support services.

Additionally, the college reached record enrollment levels this year, with more than 9,500 students enrolled for the Fall 2025 semester, an increase of approximately 1,000 students from Fall 2024. This is the highest enrollment in the college's history and is due, in part, to incredible partnerships that the college fostered with Aurora Public Schools to create more accessible pathways to careers and higher education for high school students. These pathways include dual-enrollment, which will allow more high school students to graduate with college credits, OSHA certifications, and industry-recognized credentials—at no cost.

CAST will help meet the needs of this growing and diverse student body by providing expanded access to in-demand career training and education. It is a powerful example of how institutions like the Community College of Aurora are preparing the workforce of tomorrow.

Now, as a valued strategic partner of the United States, our nations work together to advance security, peace, and prosperity.

Kazakhstan inherited a massive nuclear stockpile and legacy sites for chemical and biological weapons research following the dissolution of the Soviet Union. The voluntary commitment to rapidly remove these weapons from its territory and accede to the Non-Proliferation Treaty and other key arms control measures was a model for the region and the world. Kazakhstan has also made significant contributions to UN peacekeeping missions, including independent deployments of peacekeepers from 2024. These efforts support stability and security in both Central Asia and the wider world.

U.S. companies remain the largest source of foreign direct investment in Kazakhstan,

helping build resilient supply chains driving Kazakhstan's economic diversification, supply chain resiliency, and sustainable economic development. Last month, Wabtec Corporation and Kazakhstan Temir Zholy announced a \$4.2 billion locomotive deal, reflecting deepening cooperation between Kazakhstan and American firms.

We reiterate our commitment to advancing repeal of the outdated Jackson-Vanik Amendment, which will allow us to fully realize the potential of this relationship. We also applaud Kazakhstan's efforts to position itself as a key Eurasian transit hub. We believe it is in our shared interest to improve Central Asian connectivity with global markets to boost the resilience of supply chains, and will seek ways to support the realization of the Trans-Caspian "Middle Corridor." In addition to continued dialogue to safeguard critical technologies and improve the investment climate, we hope that the ongoing process of constitutional and political reform in Kazakhstan initiated in 2022 will strengthen governance and human rights.

On the occasion of Kazakhstan's Republic Day, we can reflect on our enduring friendship and the bright future of our strategic partnership. We look forward to continued high-level engagement with Kazakhstan, both bilaterally and in multilateral fora. In particular, we believe the anticipated [EA5] C5+1 Leaders' Summit in Washington, D.C. would be a pivotal opportunity to strengthen longstanding United States cooperation with Kazakhstan and Central Asia.

Mr. GARAMENDI. Mr. Speaker, I rise today to recognize the contributions of Lt. Col. Brenda Strength as she is honored as one of California's 8th Congressional District's Women of the Year for her exceptional leadership, operational excellence, and dedicated service to both the United States Air Force and the Northern California community. Lt. Col. Strength leads a team of 372 military and civilian personnel in managing the Air Mobility Command's largest logistics portfolio, valued at over \$983 million. Under her leadership, her unit executed over 58,000 passenger movements and transported more than 5 million pounds of cargo, while simultaneously planning and executing 12 high-priority Presi-

dential support missions, mobilizing 123 personnel across 22 locations in less than 24 hours. She played a pivotal role in finalizing a 15-year modernization effort involving the transfer of 3,000 legacy weapons systems across three wings. Through innovative joint training with the U.S. Marine Corps, she established three cross-service exercises and embedded 25 Air Force reservists into five critical logistics functions, enhancing operational readiness and joint interoperability. Her logistical acumen led to major advancements: a 30 percent reduction in overdue parts in the "Due In From Maintenance" program, a 15 percent increase in Specialized Fueling qualifications, and the resolution of a vital Base Exchange agreement benefiting over 135,000 members of the Travis AFB community. Further demonstrating her strategic foresight, Lt. Col. Strength oversaw a zero-cost warehouse floor plan redesign that consolidated 124 locations for 11,000 line items, resolved 132 asset discrepancies, and bolstered the Air Force's largest mobility account. Her innovation directly enabled a 26 percent increase in qualified aircrew by resolving a 9-month gap in hot refuel kit certification. Beyond her military service, Lt. Col. Strength has strengthened community bonds by encouraging squadron engagement in local volunteerism, including youth mentorship, highway cleanups, STEM and robotics initiatives, and support for local athletics and the arts. Her commitment to community partnerships highlights the Air Force's enduring connection to the people it serves. care industries as well as our dominant small businesses. Our distinctive multicultural identity, from "pidgin" to fusion foods like spam musubi, meat jun and sainin, to our distinctly local music and way of life, have been uniquely shaped by our immigrant 'ohana.

Nationally, the immigrant experience then and now has strengthened our country immeasurably in equally multiple ways. In pure economic terms alone, in 2022 immigrants generated some \$1.6 trillion in economic activity and contributed more than \$579 billion in local, state and federal taxes, and today millions of American workers are employed at immigrant-founded and immigrant-owned companies. Immigration is and will increasingly be essential to meeting workplace demand. Our immigrant communities maintain ties to their countries of origin and thus strengthen our Nation's indispensable international bonds.

At a time when too many immigrant communities here and elsewhere are being unfairly targeted and villainized, it is more important than ever that we recognize, celebrate and extend our support to our dynamic, diverse and thriving immigrant community and thank all immigrants for your belief in and contributions to our country. This pivotal moment paved the way for Kazakhstan's independence from the Soviet Union and symbolizes the nation's enduring commitment to self-determination, prosperity, and peace.

Kazakhstan has pursued a forward-looking vision rooted in partnership, openness, and modernization. Over the past three decades, Kazakhstan has emerged as a thriving nation with a dynamic economy, an active international presence, and a strong and growing partnership with the United States.

The U.S.-Kazakhstan relationship is grounded in shared values and mutual respect. As we mark this important national holiday, we reaffirm our commitment to deepening cooperation between our two nations to meet global challenges and advance peace, security, and prosperity.

Kazakhstan has become a magnet for American business. U.S. companies remain the largest source of foreign direct investment, helping drive Kazakhstan's diversification and sustainable development. This alignment supports the country's broader goal of becoming a resilient, innovative economy and a hub for regional growth.

Kazakhstan continues to stand as a pillar of stability in Central Asia and a leader on the world stage in nuclear nonproliferation and disarmament. Kazakhstan has remained a peaceful and stabilizing force in Central Asia—a reliable partner and a model of pragmatic, balanced diplomacy. Furthermore, Kazakhstan's active membership in the World Trade Organization reflects its ongoing commitment to international norms and open markets.

Recently, Kazakhstan took another decisive step in its economic modernization. The national railway company, Kazakhstan Temir Zholy, signed a landmark \$4.2 billion agreement with Wabtec Corporation—the largest locomotive order in recent history.

This transformative deal is more than an investment in Kazakhstan's infrastructure; it is a powerful endorsement of American innovation and manufacturing leadership. It will support thousands of good-paying U.S. jobs and strengthen America's manufacturing base, underscoring the mutual benefits of our growing economic partnership.

Kazakhstan is taking bold steps to position itself as a key Eurasian transit hub. The Trans-Caspian International Transport Route (the Middle Corridor), which begins in Kazakhstan and runs through Azerbaijan to

global markets, is strengthening supply chain resilience for the U.S. and its partners.

Another vital area of expanding cooperation is rare earth minerals. The United States and Kazakhstan are working together to build a reliable and diversified supply chain for rare earth elements and other critical materials essential to major U.S. industries, including aerospace, defense, clean energy, and semiconductors.

Rare-earth minerals from Kazakhstan can help power the next generation of U.S. innovation, driving the transformation of the American economy built around Artificial Intelligence, advanced manufacturing, and nuclear energy.

Energy collaboration also remains a cornerstone of our partnership. Earlier this year, Chevron's \$48 billion Future Growth Project at Kazakhstan's Tengiz field began production, underscoring the scale and depth of U.S. investment in the country's energy future. The Tengizchevroil venture operated by Chevron represents Central Asia's largest oil development, ensuring reliable supply and creating thousands of high-skilled jobs. These projects embody the long-term, mutually beneficial nature of U.S.-Kazakhstan energy cooperation.

It is time for the United States to take the next logical step—granting Kazakhstan Permanent Normal Trade Relations (PNTR) by repealing the outdated Jackson-Vanik Amendment. Doing so would send a powerful signal of strategic seriousness, eliminate lingering legal ambiguity for U.S. investors, and unlock the full potential of our bilateral trade and industrial cooperation.

At home, President Kassym-Jomart Tokayev is undertaking an ambitious program of national renewal aimed at building a "Just and Fair State." Over the past three years, the country has implemented far-reaching political and economic reforms.

Kazakhstan's efforts align with President Trump's focus on law and order, emphasizing that governance grounded in common sense and the rule of law is essential to maintain public order and protect citizens' rights.

Our nations also share a strong commitment to interfaith harmony and global dialogue. Kazakhstan—ethnically rich and religiously diverse—has long championed peace and tolerance. Earlier this year, Astana hosted the 8th Congress of Leaders of World and Traditional Religions, welcoming over 100 delegations from 60 countries under the theme "Dialogue of Religions: Synergy for the Future." This same spirit of openness and engagement also guides Kazakhstan's approach to the global economy.

As we look ahead, the upcoming C5+1 Summit on November 6 represents a critical opportunity to reaffirm U.S. leadership and engagement in Central Asia. Marking the 10th anniversary of this important diplomatic forum, the summit will deliver tangible results—demonstrating that the United States values long-term partnership and strengthening our ties with all Central Asian nations.

We urge the Administration to seize this moment, build on the foundation of trust and shared interests, and work with Congress to achieve outcomes that advance stability, prosperity, and lasting friendship across our nations.

Mr. Speaker, as Kazakhstan celebrates Republic Day, we honor the enduring friendship between our two countries and look forward to the continued growth of a partnership rooted in mutual respect, shared progress, and a common vision for a peaceful and prosperous world.
