Recognizing the isolating nature of the Family Child Care profession, she brought together providers from across Solano County for a leadership meeting to reignite collaboration and build a stronger sense of community. She has presented on financial literacy for providers at Solano Family & Children's Services, is a featured speaker at the 2025 Solano ECE Conference, and founded Save California Family Child Care, a grassroots initiative advocating for developmentally appropriate changes to state policy. She was also instrumental in organizing the "A Day Without Child Care" Advocacy Loop in Solano County, collaborating with the Children's Network, Napa providers, and the NorCal Family Child Care Alliance to highlight the urgent need for childcare reform. She also served on the organizing committee of the May 2025 Family Child Care Symposium and led planning for the upcoming "State of the Bay" Summit to bring together stakeholders from all nine Bay Area counties to advocate for children, families, and the providers who serve them. Her tireless efforts have uplifted families, empowered fellow professionals, and shaped policy conversations that will benefit generations to come. Mr. THOMPSON of California. Mr. Speaker, I rise today to honor Grace Episcopal Church

for the organization's 150 years of dedicated service and commitment to the people of our community.

Grace Episcopal Church was founded in 1875 in St. Helena and remains the oldest stone church in Napa County. Episcopal worship in St. Helena began in 1871, when a small group of parishioners gathered as a fledgling congregation. Their efforts culminated on December 12, 1875, when Bishop A.W.D. Wingfield consecrated the newly built church and confirmed fourteen founding members. In 1882, the congregation constructed the stone sanctuary at the corner of Oak and Spring Streets, where the church continues to stand today. What began as a small congregation without a permanent home grew into a mission and, in 1954, achieved full parish status. For nearly a century and a half, generations of families have sustained Grace Episcopal Church as a place of worship, service, and community life in our town.

Grace Episcopal Church's deep commitment to our community is reflected in its long history of service and outreach. For more than a century, the church has been a place of refuge and fellowship for the people of our St. Helena. Since 1975, Grace Church has hosted "Joe's Group," the oldest Alcoholics Anonymous meeting in St. Helena, continuing its tradition of providing support in times of need. Grace Church's "Common Table" program provides free community meals twice a month, offering nourishment and connection to all who attend. The church's community involvement also extends to youth development, with the Reverend Irving Baxter founding Troop One St. Helena Boy Scouts at Grace Church in 1920, just twelve years after the scouting movement began in the United Kingdom.

Grace Church has been recognized for its steadfast response to community needs during times of crisis. It serves as the Red Cross hub for our northern Napa County community, offering disaster relief and shelter when disaster strikes. During recent wildfires, the church distributed more than \$10,000 in assistance to low-income families who were displaced. During the pandemic, the Napa Valley New Deal was founded at Grace Church to provide free food, supplies, and prepared meals to vulnerable residents throughout our region. The church continues to partner with faith-based organizations to provide essential goods, collecting and distributing food staples to families in need.

Grace Church's dedication to service also extends to affordable housing advocacy and spiritual wellness. Its participation in the Adopt-a-Family program for more than 20 years has brought comfort and stability to families during the holidays. Its ongoing advocacy for affordable housing has helped secure homes for more than 30 low-income families. In 1997, the parish committed to tithing 10 percent of its income to support work beyond its walls, producing a lasting impact locally and around the globe. In 2015, the church built and dedicated a community labyrinth modeled after the Chartres Cathedral labyrinth

to serve as a public space for meditation and spiritual reflection. Periodic Taizé services continue this spirit of inclusion, offering ecumenical worship dedicated to Christian unity.

Mr. Speaker, we thank Grace Episcopal Church for its dedication and service to our community. Therefore, it is fitting and proper that we honor them here today on their 150th anniversary.

Ms. STEFANIK. Mr. Speaker, I rise today to recognize Saratoga County Sheriff Michael Zurlo, a lifelong resident of Saratoga County who has dedicated his career to keeping our communities safe, strong, and connected.

Elected Sheriff on November 5, 2013, Sheriff Zurlo brought decades of hands-on experience to the office, having served as a deputy, sergeant, lieutenant, and senior criminal investigator within the Saratoga County Sheriffs Office. A graduate of Mechanicville High School and former Town of Stillwater Judge, Sheriff Zurlo embodies a deep understanding of both law enforcement and public service.

Over more than thirty years, he has worked tirelessly to protect the people of Saratoga County, leading with fairness, integrity, and respect for the men and women who serve beside him. His leadership has advanced several initiatives that have had a lasting impact on the county's safety and quality of life. He placed school resource officers in districts across the county to ensure students and staff have trusted and visible protection. He implemented stricter penalties for those charged with driving while intoxicated, launched the "Blue Envelope" program to assist drivers on the autism spectrum during traffic stops, and oversaw the opening of the county's \$20 million Paul E. Lent Public Safety Facility. Under his leadership, the Sheriffs Office introduced programs in the county jail designed to support veteran inmates and individuals struggling with addiction, offering accountability, rehabilitation, and a path forward.

Mr. HUFFMAN. Mr. Speaker, I rise today in memory of Anthony "Tony" Anello, who passed away at the age of 77 on September 28, 2025. Tony was a beloved and celebrated member of Bodega Bay, a renowned fisherman, and a pillar of this coastal community.

Born in San Francisco, California in 1948, Tony was raised in Guerneville, California. Tony was a rodeo calf roper when he married Carol Zucca, his wife of 58 years. To support their growing family, Tony began an excavation business, while earning additional income as a fisherman and selling produce.

In 1968, Tony joined the Guerneville Fire Department as a volunteer, launching his steadfast career as a firefighter and EMT. He served the Sonoma County fire departments for decades and rose through the ranks of captain, training officer, and battalion chief during his tenure. Tony's excellence and commitment as a training officer is credited for shaping generations of paramedics and firefighters in Sonoma County.

Most notably, Tony had a deep-rooted love for fishing. The grandson of a Sicilian fisherman, Tony purchased his first of many commercial fishing boats in 1969. On his days off from the fire department, Tony would go commercial salmon and crab fishing.

In 2004, Tony and Carol founded Spud Point Crab Co. in Bodega Bay, a small harbor stand that grew to become an iconic, homestyle restaurant for both tourists and locals. Tony and his son, Mark, provided seasonal crab and wild king salmon fresh from the dock of the marina across from the restaurant. The waterfront stand, inspired by Old Fisherman's Wharf in San Francisco, still attracts lines of customers seeking Carol's prize-winning clam chowder and Tony's Dungeness crab. A beacon of the community, Spud Point Co. is a critical hub for the town and a charitable supporter of many local organizations.

Along with his well-respected work ethic, Tony was well known for his larger-than-life character, humor, and generous spirit. Tony was a stalwart advocate for the local fishing community and hosted many vital community gatherings to preserve the future of the fishing industry at Bodega Bay. While he will be greatly missed, Tony's legacy will live on through the innumerable positive impacts he has had on his community. Tony is survived by his wife and their four children, Lori, Gina, Lisa, and Mark, his grandchildren and great-grandchildren, many of whom have carried on his passion for fishing and firefighting.

Currently, Maria is serving her second term as the Vallejo Museum's Board President. Her original musical, Wonderlandia, was workshoped in Vallejo and will be performed in conjunction with Día de Muertos bringing a new Vallejo tradition to the downtown. Maria is most proud of being a mom to four amazing kids. Mr. THOMPSON of California. Mr. Speaker, I rise today to honor Linda Neal, who has been named the 2025 Agriculturist of the Year by the Napa County Farm Bureau. Ms. Neal is being recognized for her decades of dedicated service and lasting contributions to Napa Valley's agricultural community.

Ms. Neal's path to agriculture began after her family moved from Orange County to Oakdale in Stanislaus County during her childhood. Inspired by local students involved in farming, she joined the Future Farmers of America (FFA) at Oakdale High School, where she earned a State Farmer Degree and numerous awards. Ms. Neal has often said that everything good in her life can be traced back to her involvement with FFA, where she came to see agriculture as the only truly essential industry. She went on to earn an Associate of Science degree in Agricultural Business and a Bachelor of Arts degree in Business, graduating summa cum laude, and became a licensed Pest Control Advisor.

Ms. Neal arrived in Napa Valley in 1983, where she initially worked as a sales representative for the French agricultural manufacturer Rhone Poulenc. Soon after, she and her then-husband, Michael Neal, co-founded M&L Vineyard Management, which began with a single quarter-acre vineyard and grew to manage more than 1,000 acres for renowned wineries including Cakebread, Mondavi, and Opus One. In 1986, she represented Napa County at the California Farm Bureau Federation competition in Monterey, earning first

place in debate. The following year, she became a member of the Napa County Farm Bureau and purchased an agricultural property in Oakville. By 1989, she had terraced the hillside and planted four acres of Cabernet Sauvignon on the property her vineyard crew would later name Tierra Roja for its distinctive red volcanic soil.

After two decades leading M&L Vineyard Management, Ms. Neal turned her focus to her own properties. She operated Mellowood Vineyard in El Dorado County before selling the winery in 2018 to concentrate fully on Tierra Roja. Working closely with vineyard manager Ruben Rubio, Ms. Neal manages every aspect of her four-acre vineyard year-round, with each vine individually tended. She produces about 250 cases annually of highly regarded Cabernet Sauvignon from what has been called "Magic Hill" for its location among Oakville's most celebrated vineyards.

In addition to her professional success, Ms. Neal has been a driving force for agricultural education and community engagement. Twenty-five years ago, she worked with local farmers, including Larry Bettinelli, to establish the Agriculture Program at St. Helena High School, where she served as treasurer, secretary, and fundraiser. What began as a vision for a single classroom has grown into a three-teacher program with more than half of St. Helena High School's students participating. Ms. Neal was also elected by local farmers to serve on the USDA Farm Service Agency Committee, where she advocated for agricultural producers across the region. Throughout her career, she has mentored many young people entering agriculture, giving individuals who are now industry leaders their first start in the field.

Ms. Neal's commitment to service extended beyond our Napa Valley when she joined the Peace Corps in 2018 and served in Morocco until 2020, sharing her agricultural expertise with communities abroad before returning to continue her work here at home.

Mr. Speaker, through decades of work in viticulture, dedication to agricultural education, and commitment to mentoring the next generation of farmers, Linda Neal has made lasting contributions to our Napa Valley's agricultural community. It is fitting and proper that we honor her here today as the Napa County Farm Bureau's 2025 Agriculturist of the Year.

Mr. MCCORMICK. Mr. Speaker, I rise today to recognize Medal of Honor winner Major General James E. Livingston, USMC Retired, and the University of North Georgia's permanent dedication of the North Plaza at the Gen. William "Lipp" Livsey Drill Field as the 'Major General James E. Livingston Medal of Honor Plaza'. This permanent naming is in recognition of Major General Livingston's lifelong service to America, his commitment to the mission and work of the University of North Georgia—The Military College of Georgia, and his "conspicuous gallantry and intrepidity at the risk of his life above and beyond the call of duty" for which he earned our Nation's highest award for valor, the Medal of Honor.

A native of McRae, Georgia, in Telfair County, James E. Livingston attended North Georgia College (NGC) from 1957 to 1958. He departed NGC to study engineering and was

commissioned as a second lieutenant in June 1962 from Auburn University. His early assignments included service as a platoon commander, intelligence officer, and as a Recruit Training Regiment series commander. Major General Livingston served as the Commanding Officer of the Marine Detachment aboard the Aircraft Carrier USS *Wasp* and then joined the 3d Marine Division in the Republic of Vietnam in August 1967. On May 2, 1968, while serving as Commanding Officer, Company E, 2d Battalion, 4th Marines, he distinguished himself above and beyond the call of duty in action against enemy forces at the Battle of Dai Do, Republic of Vietnam.

The following is a (short) excerpt from his actions that day:

"Ignoring hostile rounds impacting near him, he fearlessly led his men in a savage assault against enemy emplacements within the village. While adjusting supporting arms fire, Capt. Livingston moved to the points of heaviest resistance, shouting words of encouragement to his marines, directing their fire, and spurring the dwindling momentum of the attack on repeated occasions. Although twice painfully wounded by grenade fragments, he refused medical treatment and courageously led his men in the destruction of over 100 mutually supporting bunkers, driving the remaining enemy from their positions, and relieving the pressure on the stranded marine company." For his incredibly heroic actions on that fateful day, Major General Livingston earned the Medal of Honor which was presented to him on 14 May 1970 by President Richard Nixon in a ceremony at the White House. Today, Major General Livingston stands as one of only 61 living Medal of Honor recipients. Although, he only attended North Georgia College for one year, to this day he credits his North Georgia experience with setting the foundation for his life by instilling timeless leadership principles, fostering maturity, and making him tough. This quote is from Major General Livingston in a recent interview in late 2024: "One of the greatest things to ever happen to me in my life was the opportunity to come to (attend) what was then North Georgia College. . . let me assure you I would have never been successful in what I learned about myself, what I learned about what I needed to know and needed to reinforce through my whole life. Those values of understanding how to live your life, how to be successful in your life, how to achieve in your life . . . all values I learned at North Georgia."

His foundational experience at North Georgia was evidenced by his donation of one of his original Medals of Honor which he received from President Nixon in 1970 to UNG in October 2024. Of note, each medal of honor recipient receives only two medals—Major General Livingston is leaving one to his family and the second to the University of North Georgia, in perpetuity. In a speech to the UNG Corps of Cadets—America's Corps in September 2024, he emotionally shared how the Corps' rigorous training shaped his philosophy of leading by example and maintaining discipline under pressure, qualities evident in his heroic actions at the Battle of Dai Do. Major General Livingston's formative experience in UNG's Cadet Corps laid the groundwork for his distinguished 33-year Marine Corps career. He is the epitome of the UNG Cadet Corps and the mission and work of the University of North Georgia—The Military College of Georgia. As UNG delivers the Corps of the Future—America's Corps, it will be the legacy of leaders like Major General

Livingston who inspire the next generation of selfless Americans to answer our Nation's call.

ing the Flint Water Crisis, members collected and sent 6,000 cases of water to those in need. The church also hosts the InTouch Community Basketball Tournament, fostering unity between first responders and the community.

Mr. THOMPSON of California. Mr. Speaker, I rise today to honor the Lower Putah Creek Coordinating Committee, an outstanding organization in our community. Their 25 years of dedicated service and commitment to restoring Putah Creek demonstrate why they deserve recognition today.

The Lower Putah Creek Coordinating Committee (LPCCC) was established in 2000 under the Putah Creek Accord, a landmark water settlement adopted following years of legal action between Solano County water users and Yolo County environmental advocates. The Accord mandated year-round flows to protect fish and wildlife resources while respecting landowner water rights. The Committee was created to oversee implementation of the settlement, hire a permanent streamkeeper, and coordinate creek studies and restoration. The LPCCC represents the Boards of Supervisors of Solano and Yolo Counties, the Cities of Davis, Fairfield, Suisun, Vacaville, Vallejo and Winters, the Solano County Water Agency, the Solano Irrigation District, the Maine Prairie Water District, the University of California, Davis, the Putah Creek Council and riparian landowners. The Committee's mission is to protect, monitor, and enhance the resources of lower Putah Creek within the framework of the Accord while serving as a forum for dialogue among stakeholders.

The Committee's commitment to our community is clear from their extensive restoration work. Lower Putah Creek stretches 30 miles from below Monticello Dam to the Yolo Bypass through Solano and Yolo Counties. Over the past 25 years, the Committee has led the restoration of over 20 miles of creek habitat by re-meandering channels, removing invasive species such as Arundo and Himalayan Blackberry, replanting native vegetation, and reconnecting the stream to its historical floodplain. Their work has leveraged millions of dollars in funding to enhance ecological function, water quality, flood protection, and climate resilience while maintaining strong partnerships with landowners and agencies. The Committee developed a Watershed Management Action Plan that documents the history and present conditions of the creek and provides comprehensive assessment of biological, physical, and cultural resources.

The Committee has rightfully been recognized for the measurable impact of their restoration efforts. Their work has improved groundwater recharge, reduced erosion, and increased the resilience of the creek corridor



to drought and climate change impacts. They have successfully engaged the community through working groups and annual meetings, with nearly 60 percent of landowners along the creek participating in restoration projects. The Committee owns specialized equipment including earth movers and hydroseeders that allow them to accomplish restoration tasks effectively. Most notably, Chinook salmon have returned to Putah Creek each fall to spawn, a remarkable comeback that has been celebrated by our community members and environmentalists. The Winters Salmon Festival now celebrates the return of these iconic fish each October, honoring both the salmon and the decades of restoration work by countless volunteers.

Mr. Speaker, we thank the Lower Putah Creek Coordinating Committee for their dedicated service to our community and their commitment to protecting our natural resources. Therefore, it is fitting and proper that we honor them here today on the 25th anniversary of the Putah Creek Accord.

Mr. BISHOP. Mr. Speaker, I rise today to honor the life and enduring legacy of Lasmockie Octavia Fountain, who tragically lost her life to domestic violence on May 23, 2015. This year marks the 10th anniversary of her passing, and in that decade, her memory has ignited a movement that continues to bring awareness, healing, and advocacy to families affected by domestic violence in Georgia and across the nation.

Born on April 4, 1985, Lasmockie was the beloved daughter of Stephanie Fountain Burton and Charles Nixon, and a devoted mother to four children: Solano Fountain, Sole Fountain, Shannon Fountain, and London Fountain. Her life was full of promise, and her sudden loss at the age of 30 left an unfillable void in the hearts of her family and community.

In response to this tragedy, Lasmockie's aunt, Dr. Sharon Lynn Fountain Stafford, founded the organization: A Voice for Lasmockie/Lasmockie's L.O.A.D. (Loved Ones Against Domestic Violence). This organization has worked tirelessly to ensure that

Lasmockie's story is not forgotten—transforming grief into advocacy and education for others impacted by domestic violence. Among its many community initiatives, the organization hosts the annual Domestic Violence Awareness Walk on the last Saturday in October, uniting survivors, families, advocates, and community members in remembrance and in action. Additionally, "Lasmockie Day" is observed on October 23rd in Macon, Georgia, honoring her legacy with community outreach and education.

A Tree of Hope has been planted in Macon, GA—a deeply meaningful location as it was the home of Lasmockie's grandparents, the late Willie Frank Fountain, Sr. and Syella Fountain, and is also the location where Lasmockie's life was tragically taken. The tree bears the names of individuals lost to domestic violence and stands as a living memorial—a symbol that their lives mattered, that they are not forgotten, and that their stories continue to inspire change. A memorial bench featuring a mural of Lasmockie was also placed at the site, creating a space for reflection, healing, and remembrance.

Additionally, "Purple Light Day" is observed annually on October 26th in Macon. Initiated by Dr. Stafford, Purple Light Day encourages homes, businesses, and public spaces to be illuminated in purple—the color representing domestic violence awareness as a visual show of support for victims and a call to action for prevention.

Lasmockie's legacy continues to live on through her children, family, and loved ones, including her aunt, Dr. Sharon Lynn Fountain Stafford, who have taken up the fight against domestic violence. They work tirelessly to honor Lasmockie's memory through advocacy, education, and outreach. Together, they actively lead the work of A Voice for Lasmockie/Lasmockie's L.O.A.D., focusing on empowering underserved communities where domestic violence is often underreported and support is limited.

Mr. Speaker, I ask my colleagues in the House of Representatives to join my wife, Vivian, and me, as well as the people of Georgia's 2nd District, in honoring the life and ongoing impact of Lasmockie Octavia Fountain and the work of A Voice for Lasmockie/Lasmockie's L.O.A.D. on the 10th anniversary of her passing. May her memory continue to be a beacon of hope, and may her story inspire continued action to end domestic violence.

Mr. THOMPSON of California. Mr. Speaker, I rise today to honor Judy Ahmann, who has been named the 2025 Member of the Year by the Napa County Farm Bureau. Judy is being recognized for her decades of advocacy for agriculture and her enduring commitment to the Farm Bureau and our Napa County's agricultural community.

Ms. Ahmann was born in Omaha, Nebraska, and later moved with her family to Long Beach, California. She attended Long Beach State College, graduating in 1966, a year after marrying her husband, John. Judy began her professional career at IBM, but her passion for the land soon led her and John to purchase their first 12 acres in California. After a brief relocation to New Jersey for work, they returned to California in 1970 and settled in our Napa County, where they purchased 300 acres and began raising cattle. In 1986, they acquired more than 3,000 acres along Lake Berryessa, establishing Running Deer Ranch. With no prior ranching experience, the Ahmanns turned to the Napa County Farm Bureau and local Cattlewomen's and Cattlemen's Associations for guidance so they could raise their three daughters, Christina, Anna, and Erica, in the ranching tradition.

Ms. Ahmann's commitment to our agricultural community is clear from her extensive advocacy work. She became a long-standing member and leader in California CattleWomen, serving as president at both the local and state levels, including as state president in 2007 and 2008. She later joined the Executive Board of American National CattleWomen, where her leadership earned her recognition as National CattleWoman of the Year in 2014. In 2010, Judy was selected as a member of Common Threads California, which honors women for their volunteer leadership and contributions to agriculture.

Judy has rightfully been recognized for her advocacy at the national level. In 2013, she testified before the House Natural Resources Subcommittee on Public Lands and Environmental Regulation in support of the Berryessa Snow Mountain National Conservation Area Act. Her testimony focused on the need to balance conservation efforts with the preservation of working ranchlands and grazing operations for future generations.

Ms. Ahmann's dedication to agriculture extends to supporting the next generation of farmers and ranchers. She and her family have been generous supporters of youth in agriculture, donating time and raising funds for scholarships benefiting local 4-H and Future Farmers of America students. She has been a steadfast supporter of the Napa County Farm Bureau, actively promoting agricultural policy, education, and community engagement. In 2010, Judy and John placed a conservation easement on 1,275 acres of Running Deer Ranch through the California Rangeland Trust, permanently protecting the ranch as a working landscape while preserving its vital wildlife habitat. They also granted a trail easement to open public access to 9,100 acres of Bureau of Land Management land that had been landlocked for more than 150 years.



Judy remains deeply involved in ranching alongside her daughters and their families, who now operate Running Deer Ranch. Despite the devastation caused by wildfires in 2018 and 2020, the Ahmann family has continued to rebuild, demonstrating resilience and an unwavering commitment to sustainable ranching and responsible land management.

Mr. Speaker, we thank Judy Ahmann for her decades of leadership in the cattle industry, dedication to agricultural education and advocacy, and commitment to supporting the next generation of farmers. Therefore, it is fitting and proper that we honor her here today as the Napa County Farm Bureau's 2025 Member of the Year.
