the Federal Deposit Insurance Act, the Bank Holding Company Act of 1956, and the Home Owners' Loan Act to require the consideration of certain entities and factors when evaluating proposed acquisitions, mergers, consolidations, assumptions of liabilities, or transfers of assets, and for other purposes; with an amendment (Rept. 119-365). Referred to the Committee of the Whole House on the state of the Union.

Mr. HILL of Arkansas: Committee on Financial Services. H.R. 5270. A bill to require the Board of Governors of the Federal Reserve System to issue rules to establish certain methodologies and scenarios used in stress testing, and for other purpose; with an amendment (Rept. 119-366). Referred to the Committee of the Whole House on the state of the Union.

Mr. HILL of Arkansas: Committee on Financial Services. H.R. 5276. A bill to amend the Economic Growth, Regulatory Relief, and Consumer Protection Act to adjust the Community Bank Leverage Ratio, and for other purposes; with an amendment (Rept. 119-367). Referred to the Committee of the Whole House on the state of the Union.
