### RECOGNIZING THE 100TH ANNIVERSARY OF GADSDEN STATE COMMUNITY COLLEGE

Mr. ROGERS of Alabama. Mr. Speaker, I rise today to recognize the 100th anniversary of Gadsden State Community College. Gadsden State is currently under the leadership of President Alan Smith.

One of the initial founding institutions of Gadsden State is the Alabama School of Trades. It was established in 1925 as the first state-operated trade school in Alabama and the entire southern United States.

Classes began on September 16, 1925, with 42 students enrolled in the inaugural class. Four courses were available: printing, electricity, bricklaying and cabinetmaking. All students lived in the newly constructed dormitory equipped with modern conveniences such as steam heat and plumbing that featured hot and cold running water. Students helped government workmen lay bricks to build the school's first permanent two-story buildings.

The Alabama School of Trades continued to thrive as a training center for the area's technical industry with increasing student enrollment and course offerings. In 1942, courses were converted to War Training. At the close of World War II, new courses were added to help veterans re-enter the workforce such as: Radio, TV, Auto Mechanics, Machine Shop, Refrigeration, Drafting, Photography, Upholstery, Auto Body, Barbering, General Farm Dairy, Poultry and Heavy Equipment.

In 1973, the school's name was changed to the Alabama Technical College and began offering associate in applied technology degrees. In 1985, the Alabama Technical College merged with Gadsden State Community College and is now known as the East Broad Campus. It is home to many of Gadsden State's workforce development programs such as Precision Machining, Mechanical Design, Industrial Automation, Welding, Electrical, Electronic Technology, Salon/Spa, Court Reporting, Truck Driving, Skid Steer Training, Certified Nursing Assistant, Phlebotomy and Civil Engineering.

As a result of mergers and expansion of services, Gadsden State is now a sprawling Community College with five campuses including East Broad, Wallace Drive, Valley Street (HBCU), Ayers and Cherokee. Gadsden State serves Etowah, Calhoun, Cleburne, Cherokee and St. Clair counties in northeast Alabama. There are 70 programs of study offered to over 5,000 students.

Mr. GOODEN. Mr. Speaker, I rise today to celebrate the First Baptist Church of Quitman's 175th anniversary. Organized on November 16, 1850, the First Baptist Church of Quitman, commonly known as FBCQ, is the oldest church in Wood County. It was established just nine months after the Texas Legislature voted to create Wood County in February of that same year, and it was the home church of James Stephen Hogg, the first native-born governor of Texas.

At its founding, the Baptist congregation met in public buildings, homes, and in the open air before finding a permanent location on the first floor of the Quitman Masonic Lodge. The church resided in multiple buildings in the early 20th Century. Tremendous growth in the late 1940's led to the construction of FBCQ's fourth and current sanctuary, located on Lane Street, where the congregation still gathers to worship today. I am deeply grateful to the First

Mr. COHEN. Mr. Speaker, I rise today to commend the outstanding public service performed by Memphis' first female Fire Chief, Gina Sweat, who retired last month after more than 33 years with the department. Ms. Sweat joined the Memphis Fire Department in May of 1992, one of two women in her recruiting class of 84, after receiving a bachelor of business administration in 1988 from Freed-Hardeman University in Henderson, Tennessee, where she played collegiate basketball. After joining the department, she continued her education by receiving a bachelor's of professional studies in fire administration in 2000 and a master's of professional studies in strategic leadership in 2013 from the University of Memphis. She rose through the ranks as a driver, lieutenant, battalion chief and division chief, deputy chief of logistics and deputy director until she was appointed Fire Chief by former Mayor Jim Strickland on January 1, 2016. In interviews through the years Chief Sweat said she learned to "over-prepare" for each new assignment. As chief, she undertook initiatives to improve the Insurance Services Office, made multi-million dollar renovations of the 911 Communications Center, the Office of Emergency Management building and built three new state-of-the-art fire stations and a new fire administration building. Chief Sweat's tenure also saw the department expand into responding to medical emergencies. It also included the Covid epidemic period when the fire department was the lead local agency conducting vaccinations. In my contacts with Chief Sweat, she was always pleasant. She was easy to communicate with and she certainly had a professional demeanor, which inspired my belief that the Fire Department was in good hands. Sweat had "the most appropriate name for the job" joked a local columnist, and her tenure as chief led to significant advances. I wish her well in retirement.

Ms. NORTON. Mr. Speaker, today, I introduce the Service Academies District of Columbia Equality Act, which would give the District of Columbia the same number of appointments and nominations to the U.S. service academies as states. Currently, each member of the House and each senator is allocated five appointments to each service academy—the U.S. Military Academy, the U.S. Naval Academy and the U.S. Air Force Academy—and each member of the House and each senator is allowed 15 nominations for each appointment. Therefore, since D.C. has no senators, D.C. is deprived of 10 appointments and, assuming all appointments are vacant, 150 nominations to each service academy. Senator TIM Kaine has introduced the companion bill.

This bill would provide equality for D.C. residents who choose to serve their country by applying to a service academy. It is remarkable that D.C. residents volunteer to fight and die for a country that denies them statehood, voting representation in Congress and full home rule. D.C. servicemembers have helped secure voting rights for people around the world, yet have always been denied those same rights when they returned home. D.C. residents, who pay the same federal taxes as residents of states, deserve the same opportunity as residents of states to attend our prestigious service academies.

I urge my colleagues to support this bill.

Mr. McGARVEY. Mr. Speaker, I rise today to thank the Okolona Fire Protection District for their bravery and heroism in response to the tragic crash of UPS Airlines Flight 2976 in Louisville, Kentucky.

On Tuesday, November 4th, a cargo jet bound for Hawaii crashed moments after take-off. Unable to gain altitude, the jet went down just beyond the airfield, erupting into flames as hundreds of thousands of pounds of jet fuel ignited. The resulting fire engulfed an area the size of nine football fields, and the thick, black plume of smoke could be seen from anywhere in the city. I have lived in Louisville my whole life and could never have imagined seeing something like this. For a moment, Louisville looked apocalyptic—it was heartbreaking.

But in these trying times, we saw the best of our community. Within minutes, Okolona firefighters were there, the first on site, confronting a scene of unimaginable destruction

with discipline and resolve. In this moment, they showed that heroism is not found in comfort—it is revealed in crisis. They chose duty over fear. Their rapid, coordinated response contained the flames, protected nearby homes, and stopped the disaster from spreading. Their courage in horrific circumstances saved lives and protected hundreds of families from losing their homes to the inferno.

Louisville is safer because of the men and women of Okolona Fire and the more than twenty departments who came from across the city and the Commonwealth to assist. Their bravery and selflessness reflect their deep love for this community and stand as a testament to what it means to serve. I ask all my colleagues to join me in honoring these brave first responders for their extraordinary service and sacrifice.

Mr. ROGERS of Alabama. Mr. Speaker, I rise today to recognize the retirement of Gary Fuller, Mayor of the City of Opelika, Alabama.

Mayor Fuller has tirelessly served the City of Opelika for over 20 years. He served on the City Council from 2000 to 2004 and was first elected Mayor August 24, 2004.

As Mayor, he established Opelika as the first gig city in Alabama. He helped establish a first-class Pre-K program and helped with plans to renovate Opelika High School. He led the charge for a new sports complex, library, fire department, police building and municipal court facility.

He was instrumental in the development of the Tiger Town shopping district and revitaliza-

tion of Opelika's downtown. Because of the influx of citizens, over 2,500 new single-family homes have been built. He created the Commission on Crime & Violence in 2018 to help decrease crime.

A graduate of Southern Union State Community College, Fuller was President and CEO of Fuller Broadcasting Company, Inc. from 1985 until 1998. Brian has been a solid partner in public safety and fire protection for many years, and I am grateful that we became friends along the way. Always a man of deep integrity, I know I could trust his judgement and clarity in any issue before us. He will be missed by myself and my office. Despite being a Los Angeles Dodgers fan, we have much in common and I wish him the

Chief Estes earned a bachelor's degree from California State University, Chico, in Information and Communications Studies with a minor in Fine Art. His first assignment in San Diego County at a bustling fire station along the international border would further his enthusiasm for public safety.

Chief Estes would join a CAL FIRE Helicopter crew in Tuolumne County in 1995. This assignment would ignite a passion for fire aviation, where he would coordinate with California National Guard's Blackhawk and Chinook Squadrons. He would then be promoted and assigned to the Amador-El Dorado Unit. In 2000, he advanced to the rank of Captain and then Battalion Chief in 2005 overseeing the Unit's Training and EMS Bureau before transferring to the Headquarters Field Battalion Chief Position.

Chief Estes would continue to rise through the ranks serving as Assistant Chief of Operations, overseeing a Fire Crew Camp, Deputy Chief of Operations, and ultimately Unit Chief for the Nevada-Yuba-Placer Unit and Fire Chief of Placer County Fire Department. In these roles, he led over 450 personnel in one of CAL FIRE's most complex units, managing operations, administration, and a \$100 million budget across 1.7 million acres of State Responsibility Area (SRA). During his career Chief Estes has prioritized professional development, serving on department committees and instructing the next generation of firefighters.

Chief Estes, as a key member of the 2006 branding committee, would transition the department from CDF to CAL FIRE, designing the department's patch logo, apparatus fleet identity, and aviation fleet livery. This rebranding efforts elevated CAL FIRE's public image and highlighted the professionalism of its more than 10,000 firefighters. For over 15 years Chief Estes has chaired the statewide uniform and standards committee, further reinforcing the department's professional standards.

Chief Estes' impact and leadership in public safety will be felt not just in California but far beyond. In 2023, he was deployed to Maui, Hawaii, for incident management for the devastating Lahaina fire. He would also travel to Germany, building partnerships with fire services in over 10 cities and speaking at a major Western European fire symposium.

On behalf of Northern California and our grateful rural communities that Chief Brian Estes has fought tirelessly to defend throughout his career, I thank him for his dedicated service and congratulate him on his well-earned retirement.
