Senate passed H.R. 5371, Continuing Appropriations, Agriculture, Legislative Branch, Military Construction and Veterans Affairs, and Extensions Act, as amended.

Continuing Appropriations, Agriculture, Legislative Branch, Military Construction and Veterans Affairs, and Extensions Act: By 60 yeas to 40 nays (Vote No. 618), Senate passed H.R. 5371, making continuing appropriations and extensions for fiscal year 2026, after agreeing to the motion to proceed, and after taking action on the following amendments and motions proposed thereto:

By 60 yeas to 40 nays (Vote No. 616), Thune (for Collins) Amendment No. 3937, in the nature of a substitute. **Pages S8125, S8129–30**

Rejected:

Thune (for Paul) Amendment No. 3941 (to Amendment No. 3937), to strike a provision modifying the definition of hemp for purposes of the Agriculture Marketing Act of 1946. (By 76 yeas to 24 nays (Vote No. 614), Senate tabled the amendment.)

By 60 yeas to 40 nays (Vote No. 617), three-fifths of those Senators duly chosen and sworn, having voted in the affirmative, Senate agreed to the motion to close further debate on the bill. **Page S8130**

Permitting Collections for Charitable Purposes: Senate agreed to S. Res. 497, permitting the collection of clothing, toys, food, and housewares during the holiday season for charitable purposes in Senate buildings. **Page S8183**

50th Anniversary of the Sinking of the SS Edmund Fitzgerald: Senate agreed to S. Res. 494, observing the 50th anniversary of the date on which the SS *Edmund Fitzgerald* sank in Lake Superior, and remembering the 29 lives lost in one of the worst storms ever recorded on the Great Lakes. **Page S8183**

50th Anniversary of the End of the Vietnam War: Senate agreed to S. Res. 495, recognizing the 50th anniversary of the end of the Vietnam War and honoring the United States veterans who served during the conflict. **Page S8183**

National First-Generation College Celebration Day: Senate agreed to S. Res. 496, expressing support for the designation of November 8, 2025, as “National First-Generation College Celebration Day”. **Page S8183**

Honoring Dr. Jane Goodall: Senate agreed to S. Res. 498, honoring Dr. Jane Goodall and her legacy as an ethologist, conservationist, and activist. **Page S8183**

Signing Authority—Agreement: A unanimous-consent agreement was reached providing that all members of the Republican Conference be authorized to sign duly enrolled bills or joint resolutions from November 11, through November 18, 2025. **Page S8183**

Pro Forma Sessions—Agreement: A unanimous-consent agreement was reached providing that the Senate convene for pro forma sessions, with no business being conducted on the following dates and times: Thursday, November 13, 2025, at 6:30 p.m.; and Monday, November 17, 2025, at 3 p.m.; and that when the Senate adjourns on Monday, November 17, 2025, it next convene at 3 p.m., on Tuesday, November 18, 2025. **Page S8183**

Nieh Nomination—Cloture: Senate began consideration of the nomination of Ho Nieh, of Alabama, to be a Member of the Nuclear Regulatory Commission for the remainder of the term expiring June 30, 2029. **Page S8131**

A motion was entered to close further debate on the nomination, and, in accordance with the provisions of Rule XXII of the Standing Rules of the Senate, and pursuant to the unanimous-consent agreement of Monday, November 10, 2025, a vote
