HONORING THE LATE JUDGE BABATUNDE AKOWE

Mr. THOMPSON of Mississippi. Mr. Speaker, I rise today to honor the life, leadership, and public service of Judge Babatunde Akowe, a distinguished jurist, community advocate, husband, father and public servant whose recent passing leaves a profound void in the many communities he faithfully served.

Judge Akowe's life was defined by family, community and an unwavering belief in the power of civic engagement to transform lives. Judge Akowe was born and raised in Crown Heights, Brooklyn, and his life's work remained deeply rooted in his community.

His public service career was broad and impactful. Before ascending to the bench, he held roles across numerous institutions: he worked in the Brooklyn District Attorney's Office, served in the New York State Unified Court System, and served in the NYC Department of Consumer and Worker Protection.

In 2015, Judge Akowe completed the Congressional Black Caucus Institute (CBCI) Political Leadership Boot Camp, a significant milestone in his development as a civic leader. When the CBCI began its annual bootcamp, it was conceived to help to train young, ambitious public servants just like Judge Akowe. Notably, he went on to become one of the first members of that cohort to run for and win public office, underscoring both his ambition and his readiness to serve. His success signaled to aspiring leaders across the country that dedication, preparation, and audacity could indeed shape a pathway to elected office.

His distinguished judicial career reflected the same qualities that guided him throughout life: an unshakeable sense of fairness, a commitment to equity, and a belief that justice must be both principled and compassionate. On the bench, Judge Akowe quickly earned a reputation for wisdom, humility, and an extraordinary ability to listen deeply—the facts, to the law, and to the humanity of those before him.

Judge Akowe was not only a public servant—he was a beloved family man. He is survived by his wife, Lauren, and their two daughters, Adia and Amara. His loss has deeply saddened his community, family and friends—with many noting that his life and judicial service were cut far too short. He was a friend to all, and for many, the first call made when visiting New York.

Mr. Speaker, the passing of Judge Babatunde Akowe is a tremendous loss to his family, his community, and the many institutions enriched by his service. Yet his legacy endures—as a trailblazer in political leadership training, as a respected judge, and as a public servant who believed deeply in democracy's promise.

I ask my colleagues to join me and the board and many alumni of the Congressional Black Caucus Institute's leadership training programs in honoring his memory, celebrating his service, and extending our heartfelt condolences to his family, friends, and all who knew and admired him.

In 1950, Bert married Irene Cichon, and they were married for nearly 65 years raising three sons. He went on to a long career with Bendix, later Honeywell, where he designed brakes and earned 65 patents. He remained active in retirement and valued time with his growing family.

Bert is a devoted Notre Dame sports fan, a longtime attendee of Bendix retiree breakfasts, and a man rooted in family, faith, and community.

Mr. Speaker, reaching 100 years is a remarkable milestone. Bert Gumkowski's life reflects service, resilience, and dedication to those around him.

It remains the only Korean Bell Garden of its kind in the Western Hemisphere, distinguished by its intricate engravings of flora and fauna native to both Korea and Virginia, symbols of the deep and natural connection between our cultures. The garden's traditional architecture, totem poles, and statuary further embody centuries of Korean artistry and philosophical reflection, offering visitors an enduring space for contemplation, appreciation, and peace.

As we mark this milestone, we recognize that the Korean Bell Garden represents far more than a place of beauty, it is a living testament to the bonds of friendship and cooperation between Korea and the United States, and to the shared values that continue to strengthen our partnership.

Captain Petty has dedicated his post-service life to ensuring that those who served our Nation receive the care, respect, and honors they have earned. As Director of the Veterans Resource Center in Ocala, Florida, he has led groundbreaking efforts to provide free Galleri blood testing for veterans exposed to carcinogens such as Agent Orange and burn pits—conditions that have claimed far too many lives long after the battles ended. Through his

leadership, veterans who served “boots on the ground” in the Vietnam War, Gulf War, and the Global War on Terrorism can now access this \$950 cancer screening at no cost, right in their own community. This lifesaving initiative—made possible through partnerships with the Marion County Hospital District and the Marion County Community Development Block Grant—stands as a model of community collaboration, compassion, and unwavering commitment to those who have borne the battle.

Beyond his work in advancing preventive care, Captain Petty has also been instrumental in ensuring that every Marion County veteran interred at the Bushnell National Cemetery receives full military honors—a solemn and sacred recognition of their service to our Nation. Captain Petty's dedication exemplifies the very best of the veteran community: leadership through service, compassion through action, and a steadfast refusal to leave any brother or sister behind. His induction into the Florida Veterans Hall of Fame is not only well-deserved—it stands as a testament to what one individual can accomplish when driven by love of country and devotion to those who have borne the battle.

Mr. WALKINSHAW. Mr. Speaker, I rise today to honor the life of Officer Howard “Howie” Liebengood for his tremendous service to our Nation as a U.S. Capitol Police officer on January 6, 2021. Officer Liebengood proudly served with the U.S. Capitol Police for over 15 years and demonstrated incredible courage, commitment, and honor during his decorated career.

Officer Liebengood was on duty at the U.S. Capitol during the events of January 6, 2021. In the days that followed, he continued to serve, carrying the immense and often unseen toll felt by so many officers in the aftermath of that tragic day. He tragically passed on January 9, 2021, at the age of 51. At the time of his passing, he lived in Vienna, Virginia, where he was a valued member of the community.

Officer Liebengood's story is quieter and harder to speak about, not because his service was any less meaningful, but because the nature of his loss reflects the unseen burdens that many public servants carry. It is precisely for that reason that his life and service must be remembered with dignity. Service and suffering that go unseen still matter, and those who bear such weight in silence deserve our lasting gratitude.

Officer Liebengood's colleagues would often describe him as steady, kind, and deeply committed to the shared mission. These qualities made him an incredible officer, a trusted partner, and a genuine friend within the U.S. Capitol Police.

Officer Liebengood's life and legacy have been recognized with several significant hon-

ors. In 2022, he was posthumously awarded the Defenders of Democracy Award by the University of Virginia's Center for Politics for his brave service on January 6th and his efforts to protect our democracy alongside his fellow officers. That same year, Officer Liebengood was awarded the Congressional Gold Medal, the oldest and highest civilian award in the Nation. In 2023, he was awarded the Presidential Citizens Medal, which recognizes citizens who have performed exemplary deeds of service for their country or fellow citizens.

Mr. Speaker, I ask my colleagues to join me in remembering Officer Howard “Howie” Liebengood and in extending our deepest condolences to his family, friends, and fellow officers. His steadfast service to the United States Capitol Police will not be forgotten.

Phil Davis proudly served in the United States Army from January 21, 1970, to December 3, 1971. He deployed to Vietnam from January to October 1971, serving his country during one of the most challenging periods in our Nation's history.

On November 28, 1988, the Veterans of the Vietnam War, Post 52 was established in Meadville, Pennsylvania. Phil was among the founding members who helped launch the post and shape its mission of supporting veterans in need. When the National Organization later went bankrupt and closed, Post 52 refused to let its mission end. In 2019, the post reorganized, completed all necessary work to become an independent 501(c)(19) organization, and expanded membership eligibility to veterans of all eras, ensuring that no veteran seeking help would be turned away. This decision dramatically increased the number of veterans they have been able to serve.

It was at Post 52 that Phil and Laurie met, forming a partnership rooted in service and compassion. They were married in 1995, and together they have dedicated decades to supporting their fellow veterans. Phil has served as Commander of Post 52 many times over the years, and has held the position continuously since 2020. Laurie has long served as the Quartermaster, ensuring that the post remains organized, responsive, and financially sound. Their leadership has been essential to sustaining the post's mission and expanding its impact.

Phil and Laurie's commitment goes far beyond titles. They provide Walmart gift cards and gas cards to the Crawford County Veterans Service office so that any veteran who walks in without food, resources, or fuel can receive immediate assistance. Their generosity has provided critical support to veterans in crisis and has exemplified the values of honor, service, and community.

Phil and Laurie Davis represent the very best of what it means to serve. Their decades of dedication have strengthened our community and improved the lives of countless veterans and their families. It is my honor to extend deep appreciation and recognition for their unwavering commitment to those who have worn our Nation's uniform.

Mr. Gilbert's many contributions to public service have been recognized throughout his career, including receiving the Outstanding Contribution to Outdoor Recreation award from the Virginia Department of Conservation & Recreation and the Land Manager of the Year award from the Mid-Atlantic Mountain Bike Enthusiasts. Along with his tremendous service to NOVA Parks, Mr. Gilbert has also dedicated his time as an Executive-in-Residence for George Mason University's Recreation Management Program, Chairman of the Board of Visit Fairfax, and a member of the Board for The Community Foundation for Northern Virginia.

HONORING CICELY MULDOON

Mr. HUFFMAN. Mr. Speaker, I rise today in recognition of Cicely Muldoon upon her retirement from the National Park Service after 40 years of extraordinary public service.

A Bay Area native, Cicely was born on the Presidio Army base in San Francisco. Her father was a World War II Army infantryman. She grew up in Sausalito and after earning her bachelor's degree in zoology from the University of California, Davis, began her first job with the National Park Service (NPS) in 1985 as a ranger at the Sitka National Historic Park in Alaska. During her tenure, Cicely had the wonderful opportunity to work in many parks across the United States, including Buffalo River National Park in Arkansas and the San Juan Island National Historic Park in Washington, before being appointed Superintendent of Pinnacles National Park in San Benito County in 2002. After three dedicated years, and significant progress in expanding the condor release program, Cicely became a deputy regional director for NPS. For five years she

oversaw community partnerships, fire and safety initiatives, and education programs across the region while providing direct management of 10 parks including Death Valley and Joshua Tree.

In 2010, Cicely was named Superintendent of Point Reyes National Seashore (PRNS), a position she held for a decade. My staff and I worked closely with her in this role on many challenging matters including the aftermath of the Secretary of the Interior Ken Salazar's decision to let the NPS lease to Drakes Bay Oyster Company expire and the ensuing years trying to deliver on the directive to pursue 20-year leases to the historic working ranchers in Point Reyes National Seashore. During her time in PRNS she also managed several vital infrastructure renovations, including the restoration of the 150-year-old Point Reyes Light-house.

In January 2020, Cicely left PRNS to assume the role of acting superintendent of the iconic Yosemite National Park. After 10 months, she was promoted to permanent superintendent, overseeing the 750,000-acre park, its 1,200 employees, and more than 40 million visitors annually. The second female superintendent in Yosemite's 156-year history, Cicely led the park through historic reforms and unprecedented challenges. At the start of her tenure, she skillfully navigated the pandemic, successfully preventing any major COVID-19 outbreaks among visitors or employees. She also managed Yosemite as it faced wildfire challenges, an unexpected winter closure in 2023, and the introduction of the new day-use reservation system to manage long-term overcrowding concerns.

Mr. Speaker, I personally worked with Cicely Muldoon for more than a decade on critical issues affecting the Point Reyes National Seashore and our natural resources. She is smart, committed, and has a great sense of humor. Always dedicated to the welfare of her employees and the protection of our natural lands, Cicely leaves an indelible positive impact on the National Park Service and all those visitors and staff whom she has taught and inspired. I respectfully ask that you join me in expressing heartfelt gratitude to Cicely for her generosity of spirit, innumerable good deeds, and in sending her best wishes on her next endeavors.

Officer Hall carried out his corrections work with professionalism, integrity and strength. But he is also remembered for showing up to every shift with a smile and with pride in his work.

The attitude that Officer Hall carried to work can be attributed to his deep love for his family. Like so many of our corrections officers, Officer Hall received great support from his family and community.

He is survived by his wife Dawn Marie Hall, of the home; daughter, Amaya Hall (Bland, Virginia); mother, Mary Susan Richardson (Wytheville, Virginia); father, Michael L. Hall (Debra) Elk Creek, Virginia; Mother-in-law, JoAnn Bollin (Dorchester, South Carolina); brother, Drew Hall (Wytheville, Virginia); maternal grandmother, Edna Ruth Burcham (Galax, Virginia); paternal grandmother, Ruth Hall (Elk Creek, Virginia); stepchildren, Felix and Sophie Johnson (Durham, North Carolina); beloved dogs, Chia and Willow; and several loved aunts, uncles and cousins also survive. Jeremy is proceeded in death by paternal grandfather, James Hall.

Officer Hall was about to celebrate his 41st birthday at the time of his death. While our region grieves his loss, River North Correctional Center and the Virginia Department of Corrections remain resolute in providing protection, safety and care to our communities. They will continue to operate according to the very same mission that Officer Hall supported and they will remember his service and sacrifice.
