Report Filed: A report was filed today as follows:

H.R. 4305, to direct the Chief Counsel for Advocacy of the Small Business Administration to establish a Red Tape Hotline to receive notifications of burdensome agency rules, and for other purposes, with an amendment (H. Rept. 119–383). **Page H4894**

Speaker: Read a letter from the Speaker wherein he appointed Representative Newhouse to act as Speaker pro tempore for today. **Page H4881**

Whole Number of the House: The Chair announced to the House that, in light of the resignation of the gentlewoman from New Jersey, Ms. Sherrill, the whole number of the House is 432. **Page H4883**

Denouncing the horrors of socialism: The House agreed to H. Con. Res. 58, denouncing the horrors of socialism, by a yea-and-nay vote of 285 yeas to 98 nays with two answering “present”, Roll No. 305. **Pages H4883–90**

H. Res. 879, the rule providing for consideration of the joint resolutions (S.J. Res. 80), (H.J. Res. 130), (H.J. Res. 131), the concurrent resolution (H. Con. Res. 58), and the bills (H.R. 1949), (H.R. 3109), (H.R. 5107), and (H.R. 5214) was agreed to Tuesday, November 18th.

Work Period Designation: Read a letter from the Speaker wherein he designated the period from Friday, November 21, 2025, through Sunday, November 30, 2025 as a “district work period” under clause 13 of rule 1. **Page H4890**
