In 1969, the parish broke ground on a new church, which was completed in 1971. Since then, the parish has continued to expand its missionary work in the surrounding community. Saint James Catholic Church has proven to be a place where families can flourish in faith and fellowship. Jon was best known for his passion for local history. He loved to share details about the Farmington community with audiences who came to appreciate their heritage more because of the way Jon brought their hometown story to life.

Dr. Jon Cozean is part of the fabric of Farmington. He leaves a legacy of caring that's exemplified by the many lives he touched. I join with the Farmington community in mourning his loss but celebrating his life of service today before the United States House of Representatives.

Jim Bernhard was born on April 9, 1954, in Baton Rouge, Louisiana. He founded The Shaw Group and guided it from a small pipe-fabrication business in Baton Rouge into a Fortune 500 global industrial services firm. Under his leadership, the company grew to employ thousands and to serve major sectors including energy, engineering, and construction. Jim's deft vision transformed The Shaw Group into a major economic engine for Louisiana, creating jobs, attracting investment, and elevating the state's prominence in national and international markets.

After the sale of The Shaw Group, Jim continued to innovate and lead. He co-founded Bernhard Capital Partners, an internationally recognized private-equity firm managing billions of dollars in assets with investments in energy services, industrial operations, and utility infrastructure. Through this transformative work, he continued to strengthen critical industries, support innovation, and expand economic opportunities across Louisiana and beyond.

Jim's extraordinary professional achievements were matched only by his deep commitment to civic life. He was a trusted mentor to many young leaders and a steadfast supporter of numerous charitable, cultural, and educational causes. His philanthropy played a defining role in the revitalization of downtown Baton Rouge through his pivotal support of the Shaw Center for the Arts, a landmark institution that continues to enrich the region's cultural landscape.

He was a champion for education at every level, frequently advocating for stronger invest-

ment in both K-12 schools and higher education. Jim's generosity made significant financial support possible for schools and students throughout the Baton Rouge area, and his advocacy helped strengthen public understanding of the critical link between education, workforce development, and long-term state prosperity.

Jim's compassion reached far beyond Louisiana's borders. He provided vital assistance to communities recovering from hurricanes in North Carolina, supported a nonprofit organization in California dedicated to assisting people experiencing homelessness, and contributed to relief efforts throughout the United States, the Caribbean, and other regions across the globe. His philanthropy was often quiet and unpublicized, guided by a belief that those blessed with success have a duty to help those in need.

At the center of Jim's life was his family. He was a devoted husband to his beloved wife, Dana, and a proud father to his five children: Benjamin Bernhard, Michael Bernhard, Patrick Bernhard, Kathryn Gerry, and Tres Bernhard. He was equally proud to be the grandfather of eight grandchildren, each of whom brought him tremendous joy and inspiration.

Jim Bernhard's unwavering love for Louisiana, his commitment to public service, and his conviction that the state's potential is limitless will continue to shape the region for generations to come. His legacy is one of leadership, generosity, innovation, and hope—a legacy that will forever enrich the state he cherished and the people for whom he worked tirelessly.

Louisiana deeply mourns the loss of Jim Bernhard, honors his remarkable life, and celebrates the enduring impact he leaves behind.

Mr. GUTHRIE. Mr. Speaker, I rise today to celebrate an extraordinary milestone of the Mammoth Cave Park Association. Today, we are celebrating not only 100 years of the Association, but a century of guardianship, protection, and partnership. The Mammoth Cave Park Association ensures one of the world's greatest natural wonders remains preserved and protected. Mammoth Cave is the longest known cave system in the world, with over 400 miles surveyed to date.

Mammoth Cave is more than just a place, it is a testament to Kentucky's history. This natural wonder has inspired people for thousands of years, playing a foundational role in the culture of our region. Established as a National Park in 1941, it hosts incredible amounts of biodiversity and history. 40 years later, the park was named a World Heritage Site, and in 1990 a Biosphere Reserve. It encompasses approximately 52,830 acres in Hart, Edmonson, and Barren counties in the Commonwealth of Kentucky.

The Mammoth Cave Park Association is deeply woven into the identity of our Commonwealth. It has witnessed thousands of years of

human history from its discovery to the visitors that walk its passages today. To continue preservation of this national treasure, Senator McCONNELL and I introduced the bicameral Mammoth Cave National Park Boundary Adjustment Act to provide the park the ability to acquire an additional 551.14 acres of land from the Nature Conservancy. This newly acquired land would enhance protection in the Green River watershed, further conserving the area's wildlife and cultural heritage while generating additional tourism to Kentucky's 2nd District. I am proud to have introduced the Mammoth Cave National Park Boundary Adjustment Act to expand protection for the cave system's important biodiversity and rich history, ensuring that it can be studied, maintained, and enjoyed by future generations of Americans.

From funding projects to community engagement, the Mammoth Cave Park Association has been a cornerstone of Mammoth Cave's success, thanks to the dedication of countless individuals who continue giving their time and heart to this cause. Their dedication is not overlooked, and we appreciate their hard work. They have helped ensure that both the cave and Kentucky's history are protected for future generations to come.

Mr. CALVERT. Mr. Speaker, I rise today to honor and pay tribute to my good friend, a visionary entrepreneur, civic leader, and philanthropist, Duane Roberts, who passed away on Saturday, November 1, 2025. Duane was a dedicated leader in Riverside County, and he will be deeply missed.

Duane was born and raised in Riverside, California. His parents, Harry and Mary Roberts, instilled in him the values of hard work and generosity. Duane graduated from Riverside Polytechnic High School, where he competed on the swim team and participated in the ROTC. He ultimately joined the family business—meat provider Butcher Boy—after high school, in addition to serving his country in the Army National Guard. Duane keenly identified an economic opportunity and seized on it by developing the frozen burrito. After surging into popularity, the frozen burrito propelled Butcher Boy Food Products into the world's largest frozen Mexican food manufacturer before the company was sold by Duane.

In 1992, Duane launched himself into a challenge that has forever changed downtown Riverside. By acquiring the Historic Mission Inn, he took on a rescue and restoration project of epic proportions. Duane's vision and determination have transformed the Mission Inn into a jewel and world-renowned destination that has hosted presidents, dignitaries, and guests from across the world. Together with his wife, Kelly, the Roberts established the Historic Mission Inn Hotel & Spa's Festival of Lights, which has become one of the most cherished holiday season traditions in the region.

Duane, a lifelong philanthropist, established the Mary S. Roberts Foundation in honor of his mother, supporting children and families in

need, victims of crime, the hungry and homeless, and the care and protection of animals. He also supported numerous organizations, including Olive Crest, UC Riverside, Riverside City College, and Pepperdine University, where he and Kelly endowed the position of Dean of the School of Law. To support conservative causes and campaigns in Riverside County, Duane and I worked together to establish the Lincoln Club of Riverside County.

Duane is survived by his wife, Kelly Roberts; his stepchildren, Casey Brown and Doug Reinhardt; his grandchildren; and countless friends and colleagues. He was predeceased by his sons Duane, Jr. and Darrell. I extend my personal and heartfelt condolences to the Roberts family, his friends, and everyone fortunate enough to know Duane. Although he may be gone, the many contributions he made to our community have left an enduring legacy.

Res. 88, and H.J. 89 which were signed into law in June of this year.

After serving the U.S. House of Representatives for nearly four years, Kaitlyn will depart the House Committee on Energy and Commerce to take a position with the Senate Committee on Environment and Public Works, handling a portfolio of energy, fish, and wildlife issues. I thank her for her service to the committee and wish her well in her new endeavor.
