INTRODUCTION OF THE DISTRICT OF COLUMBIA SPECIAL ELECTIONS HOME RULE ACT

Ms. NORTON. Mr. Speaker, today, I introduce the District of Columbia Special Elections Home Rule Act. This bill would give the District of Columbia complete authority to set the date of special elections for local offices, like other jurisdictions. This bill would remove a limitation on D.C. that is not only inconsistent with the purpose of the D.C. Home Rule Act, which is to grant D.C. self-government, but is also harmful.

In 2012, I got legislation enacted that gave the D.C. Board of Elections (Board) more flexibility to set the date of special elections for local offices. Although I sought complete authority for D.C. to set the date of special elections, the 2012 law did not include this homerule principle.

The Home Rule Act originally required the Board to hold special elections on the first Tuesday occurring more than 114 days after a vacancy and allowed the Board to schedule special elections on the same day as the next general election if that election occurred within 60 days from when a special election would otherwise have been held. This inflexibility led to special elections being held on religious holidays and forced D.C. to hold a special election separate from an upcoming general election, costing D.C. hundreds of thousands of dollars. The 2012 law requires the Board to hold a special election on a Tuesday occurring between 70 and 174 days after a vacancy. I urge my colleagues to support this bill.

Mr. BISHOP. Mr. Speaker, I rise today to honor the life and remarkable service of a loving husband, dedicated father, doting grandfather, ingenious advocate for agriculture, and my longtime friend and steadfast supporter, Schley Louis "Big Louie" Perry, Jr., who passed away on November 26, 2025, at the age of 86. A memorial service to celebrate his remarkable life will be held on Monday, December 1, 2025, at the Baker Funeral Home in Moultrie. Georgia.

Born on March 10, 1939, on Pineywoods Farms in Colquitt County, to the union of Schley Louis Perry, Jr. and Lois Perry, Big Louie was the fifth generation to steward the family land. Pineywoods Farms, established in 1830, is a Centennial Farm and the oldest continually owned business in the county-a legacy Louie treasured, protected and preserved. Except for his college years, Louie lived and worked on the farm his entire life, and today his children and grandchildren continue that tradition as the sixth and seventh generations.

Louie's devotion to agriculture began early. He joined the Georgia Farm Bureau at 13, was an active FFA member, and earned an associate's degree in agriculture from ABAC in 1959 before studying Agribusiness at the University of Georgia. Returning to Pineywoods Farms in 1962, he modernized operations, expanded production, and partnered with UGA Extension on on-farm research. An early adopter of center-pivot and variable-rate irrigation, Louie transitioned to a nationally recognized Limousin seedstock operation and marketed cattle nationwide. His commitment to innovation and stewardship made him a leader among Georgia producers.

Big Louie believed deeply in service. To him, farming was more than a business—he considered it a duty to the land and the next generation, a sentiment that guided his life. His advocacy advanced producer-driven programs, policy, and markets; he counseled elected officials to include me, Former President Jimmy Carter, Former United States Senator Saxby Chambliss, Former United States Senator Johnny Isakson, and former Governors Roy Barnes and Sonny Perdue, hosted farm tours, and mentored emerging leaders. As I have often observed, "Service is the rent that we pay for the space that we occupy here on this earth" and Louie embodied that truth in every role he held.

His leadership spanned commodity boards and associations-including three decades on the Georgia Cotton Commission (Chair, 2000 to 2012), Cotton, Inc. (Chair, 2006), the National Cotton Council, Georgia and regional Limousin organizations, and more. He served 19 years on the Colquitt County Commission under the slogan "Young, Able and Willing to Serve," and contributed to health care, education, and civic life through the Colquitt Regional Medical Center Foundation, the Pineland School Board, the Chamber of Commerce. Kiwanis Club and his church.

Honors reflecting his lifetime of service include the Georgia Cotton Commission Inaugural Trustees Award (2023), ABAC Family Legacy Award (2022), Centennial Family Farm Award (2020), and the J. Lamar Branch Leadership in Agriculture Award (2020).

Louie created the Pineywoods Farms Scholarship at UGA in 2007 and endowed scholarships at ABAC and UGA to support future agricultural leaders. He leaves a legacy of mentorship, innovation, and civic responsi-

On a personal note, Big Louie was my friend and one of my biggest supporters. His support and loyalty were unquestioned, and he was always brutally honest in his advice and counsel to me. I will be forever grateful for the fidelity of his friendship. The great agricultural chemist George Washington Carver once said that "How far you go in life depends on your being tender with young, compassionate with the aged, sympathetic with striving and tolerant of the weak and the strong, because some day in your life you will have been all of these." Big Louie went far in life because he treated all people with dignity and respect, and he followed God's purpose for his life.

He is survived by his wife of 61 years, Rebecca Clark Perry; children Laura Perry Johnson (Scott), Schley Louis Perry, III (Lisa), and Jonathan Johnson Perry (Jackie); and grandchildren Bill and Libba Johnson, Jack and Alex

Perry, and Zach and Alli Perry.

Mr. Speaker, I ask my colleagues to join my wife, Vivian, and I, along with the more than 765,000 people of Georgia's 2nd Congressional District in honoring the life and legacy of Schley Louis "Big Louie" Perry, Jr. He lived a life defined by duty to family, land, and community. Bruce has been an active volunteer in our community as well. He has served as the Past Chair of the Tennessee Theatre Foundation and has been part of many great organizations, including the East Tennessee Foundation, the United Way Campaign, In Leadership Knoxville, the Knoxville Chamber Partnership, the Board of South College, and Tenn Path. Additionally, he has also served on the boards of Friends of the Smokies and the Bijou Theatre, and currently serves on the boards for South College, the UT School of Nursing, the East Tennessee Foundation, Cherokee Country Club, and Leadership Tennessee. He has left a legacy throughout East Tennessee, and his service to this community will be greatly

He later worked on farms, in factories, and as a bus driver, eventually retiring after decades of service. His career included driving for Dick's Drive-In and the local school system, and he served as a custodian and bus driver at Goodman-Pickens Elementary School, where he left a lasting impact on countless children. He retired from the school in 2005, continuing a life of labor, love, and service.

Mr. Anderson was drafted and completed both basic and combat training in the U.S. military during World War II. Although he was never deployed into combat and was discharged without explanation, he has allways maintained a deep respect for those who serve, and he continues to honor veterans with dignity and gratitude.

A pillar in both his family and his faith, Mr. Anderson was ordained a deacon in 1947 and remained steadfast in that calling. He was married to the late Annie Lou Anderson for 73 years, until her passing in 1993. Today, at the remarkable age of 102, he still tends his yard, grows vegetables, and lives beside one of his daughters, Mrs. Dorothy Falls, who lovingly cares for him in Goodman. Mississippi.

Mr. Anderson's philosophy is simple yet profound: "All I know is love one another and be good to each other." In those words, and in the quiet witness of his life, lies the essence of what it means to be a good neighbor, a faithful servant, and a great American.

Speaker, I ask my colleagues to join me in honoring Mr. James Anderson, a living bridge between our Nation's past and future and a reminder that love, work, and faith remain the pillars of a meaningful life.

THE TRIUMPH OF LIFE

Mrs. KIGGANS of Virginia. Mr. Speaker, I include in the RECORD remarks submitted at the request of a Virginia Beach constituent, Rabbi Dr. Israel Zoberman of Temple Lev Tikvah, and are a reflection of his views:

THE JEWISH HIGH HOLY DAYS 5786

The Jewish High Holy Days of Rosh Hashanah and Yom Kippur, an ancient people's peak spiritual drama of courageous con-

templation and heartfelt contrition, are captured in the life and work of Rabbi Irving Greenberg, acclaimed modern Orthodox rabbi and author. His latest book, The Triumph of Life (A Narrative Theology of Judaism), is Greenberg's own triumphant accomplishment offering Jews and non-Jews alike an encompassing scholarly yet accessible work of theological art, bound to rank high as a pioneering beacon of light, learning and enlightenment in our postmodern new age with revolutionary promise as well as colossal dark threats to human life, the painstakingly garnered civilization and the very survival of all life on our planet Earth. Greenberg attributes the impetus to writing this inspirational guide—which aims to reassure readers from all persuasions that covenantal life of the spirit is worth laboring and fighting for—to his shaking 1961 experience in Israel while attending Tel Aviv University as a Fulbright scholar and encountering the enormity of the Holocaust for the first time.

Referring to the famous Adolf Eichmann trial of the notorious SS officer in Jerusalem, with profound impact on an entire mesmerized nation. I vividly recall as a teenager living then in Israel and myself son of Polish Holocaust survivors, the shock of the horrific events described by shaken witnesses. The author offers us a touching confessional of a crisis of faith of an Orthodox raised Jew, challenging his basic assumptions about God, covenant and life's meaning. "My loving wife (Blu is a distinguished feminist Orthodox Jew and author) and familv saved me from nihilism and despair by showing me the incredible tenacity and unspent power of embracing life. The emergent State of Israel suggested to me that the Divine was still operating in the world, and testified to the human capacity to take power for reestablishing life and reasserting its value.

Referring to his book with its far-reaching conclusions of ushering in the hoped for messianic era which Greenberg testifies is within human reach in our postmodern era with its new opportunity for creative human unity within enriching diversity, upholding universal human dignity and equality via restoring God's violated image, "I hope it will appeal to non-Jewish readers as well, especially to Christians, partners in the struggle to overcome millennia of hostility and delegitimization. People of all religions must work together to repair the world politically, economically, and culturally, and turn the Earth into the paradise all humans deserve." The admirable Orthodox rabbi who found his way back to faith and his own particular belief structure following a most challenging crisis impacted by the shattering Holocaust, was enabled to reach beyond the confines of his own faith's traditions and give credit where it's due.

His own Jewish people historically have not lacked fracturing divisions among opposing ideologies not allowing for urgently required unity at times of grave danger, such as during the Holocaust. The prosecution of the Gaza War following Hamas's barbarism both united and divided Israelis with a backlash of antisemitism in the United States and Europe. It is evident that events in Israel affect the Jewish Diaspora, even as the author emphasizes the debt of the latter to the Israeli partner. It is clear though that influential American Jewry is the glue to the essential relationship between Israel and the United States. Greenberg hails Israel's 1948 creation as reassuring that God's covenant with the Jewish people yet continues in spite of the Holocaust's heavy toll. The world's only Jewish state's robust democracy with multiple accomplishments benefiting humanity has served as a source of pride and unity to world Jewry even though

challenges to Israel's existence and character persist from within and without. May life's universal blessing yet triumph!

HONORING THE LIFE AND LEGACY OF CLIFTON LEWIS

Mr. SCOTT FRANKLIN of Florida. Mr. Speaker, I rise today to honor the life and legacy of Clifton Lewis, a beloved constituent from Bartow, Florida, who passed away on Sunday at the age of 82. Clifton was a veteran, a community leader, a tireless advocate for historic preservation and the driving force behind one of Florida's most important cultural landmarks, the L.B. Brown House.

Clifton devoted more than two decades of his life to preserving and sharing the extraordinary story of Lawrence B. Brown, a man born into slavery who rose to become a respected builder, businessman and community leader in Bartow. When the Victorian home Brown constructed faced demolition in the late 1990's, Clifton stepped forward. He rallied neighbors, secured state support and carefully led the restoration of the structure. Thanks to his conviction and leadership, the L.B. Brown House stands today as one of the only known surviving homes in Florida built by a formerly enslaved person.

But Clifton did far more than save a building, he revived a legacy. He founded and directed the L.B. Brown Heritage Festival, which celebrated its twenty-fourth year in 2025 and now attracts thousands of visitors. Through historical presentations, reenactments, music, food and fellowship, Clifton brought people together to honor the resilience, faith and contributions of African Americans in Polk County and across our Nation.

His work gained national recognition. The Smithsonian displayed artifacts from the site, and the National Museum of African American History and Culture in Washington, D.C., includes an exhibit dedicated to Brown and the Bartow home, a testament to Clifton's perseverance in telling this remarkable American story.

Clifton also served his country honorably in the United States Army and broke barriers as the first Black telephone technician in Washington, D.C. Throughout his life, he remained a man of deep faith, boundless positivity and unwavering commitment to his community. Even as he battled serious health challenges, he continued welcoming visitors to the museum, guiding tours and encouraging others to carry the work forward.

His friends and fellow historians remember him as gracious, diplomatic and always focused on preserving not just facts, but the humanity and soul of a community. His leadership inspired a generation of local preservationists, and his legacy will live on through the museum, the festival and the many lives he touched.

Mr. Speaker, Clifton Lewis was a remarkable Floridian and a guardian of our shared history. On behalf of Florida's 18th District, I extend my deepest condolences to his wife, Vendarae, his family, his friends and all who continue the mission he championed. May his

Throughout her tenure, Sharon championed the work of South San Francisco's dedicated

City teams and their many accomplishments. Under their leadership, the city has grown as a global hub for biotechnology, accelerated the construction of new housing, and maintained a high standard for public safety and emergency response. South San Francisco has continued to expand access to responsive, technology-driven police services, collaborative library and recreation programming. and reliable public works and infrastructure maintenance—the award-winning Water Quality Control Plant and strong internal operations reflect a commitment to service excellence. Central to these efforts has been a focus on sustainability and on creating a thriving environment for both residents and businesses.

Sharon played a key role in the planning, development, and improvement of many public buildings and spaces throughout the city. Her work helped bring to life the Municipal Services Building, Alice Peña Bulos Recreation Center and Preschool, Terrabay Gymnasium and Recreation Center, Roberta Teglia Senior Center, Community Learning Center, and after-school facilities on South San Francisco Unified School District campuses.
