Ms. Brugger is a lifelong resident of our community; in 1961, she graduated from Montclair High School, and in 1963, she earned her associate's degree from Chaffey College. Later on, she earned a bachelor's in social work from Cal Poly Pomona, which kick-started her journey to becoming a social worker.

In 1977, Ms. Brugger ran for the Ontario-Montclair School District board. She served on the board for 16 years before joining the Chaffey College Governing Board in 1993. Under her leadership, Chaffey College championed the expansion of the college from one to three campuses, the opening of the Industrial Technical Learning Center, and the development of critical support services.

When serving on the Governing Board of Chaffey College, Kathleen participated in longterm planning, budget oversight, and policy decisions, helping ensure continuity across multiple phases of the district's development. Her work also spanned multiple accreditation cycles, budget planning periods, and district governance processes, and her expertise and familiarity with the operational requirements of a multi-campus institution were invaluable to the college.

Kathleen's widespread involvement demonstrates her enthusiasm for public education systems in the Inland Empire. Her hard work has left a lasting impact on many, as seen by her recognition as Chaffey College's 2002 Alumni of the Year, and with Chaffey College being named a top-10 finalist for the 2017 Aspen Prize for Community College Excellence.

Beyond her contributions to Chaffey College, Kathleen has also served on several critical boards and organizations in the Inland Empire community, including the San Bernardino County Committee on School District Organization, the Montclair Chamber of Commerce, the Ontario YMCA, the Assistance League, and the Ontario-Montclair School District Board of Trustees.

Kathleen's retirement concludes more than three decades of service to education in the Inland Empire, including roles with Chaffey College, the Ontario-Montclair School District, and several local organizations. Even after retiring from the Chaffey College Governing Board, Kathleen will continue to support students across the region as a member of the Chaffey College Foundation Board.

For her outstanding service to our students and community, it is my honor to recognize Kathleen Brugger. Her commitment to the Inland Empire and beyond is worthy of the highest commendation.

As one of the 37 tribal colleges in the United States, and the only fine arts college in the world dedicated to the study of contemporary Native American and Alaskan Native arts, the IAIA fills a vital space in the academic world.

A world class arts education institution doesn't just happen overnight; it takes leadership and vision. Dr. Martin spent the last eighteen years providing that vision as he expanded IAIA from 2007 to 2025.

The student body represents 99 tribes and includes individuals from 35 states. Dr. Robert Martin has inspired not only Congress, but philanthropists to invest in the school. The many famous alumni, like Sherman Alexie, a celebrated author, poet, and screenwriter, to Roxanne Dunbar-Ortiz a historian and author known for works in indigenous issues to the next generation who are active in helping him guide the school and inspire present day students in the classroom and in the studio.

He has also championed tribal colleges beyond IAIA because he knows that they nurture the languages that keep tribal cultures alive and vibrant like the Navajo, and the Zuni that even have programs offered at the college.

As a champion for indigenous art and education, he nurtures the university mission to empower creativity and mold the indigenous leaders we need. His extensive experience in higher education is a testament to his commitment to indigenous students and stories.

I know the impact of his work lives on in the students, faculty, and staff of every institution he has been a part of. His legacy as an outstanding leader in higher education has even earned him his own day in Santa Fe, November 8, called "Dr. Martin Day".

His dedication to education and cultural preservation has also earned him distinguished recognition from the White House, as one of the recipients of the 2022 National Humanities Medal.

I am honored to include his name into the Record, so history will remember him. There is strength in culture and tradition, there are leaders who answer the call. Let Dr. Martin be remembered as one of those leaders.

HONORING SIRICO'S CATERERS ON ITS 100TH ANNIVERSARY OF SERVICE TO THE BROOKLYN COMMUNITY

Ms. MALLIOTAKIS. Mr. Speaker, I rise today to recognize Sirico's Caterers of Brooklyn, New York, on the occasion of its 100th anniversary and to honor a century of family tradition, community service, and culinary excellence.

Originally, Frank and Rose Sirico brought their children from Little Italy, where they had lived for about ten years on Spring Street, to 13th Avenue in Brooklyn.

They moved to Dyker Heights after purchasing a property on 13th Avenue to expand their bread business, which they had established in New York City. Frank and Rose lived above the store and began their workday each morning at 3:30 a.m., turning on the ovens and preparing fresh Italian bread. Their oldest sons, Sal and Carmine, were responsible for baking the bread. During that time, Sirico's served both commercial and residential clients, delivering bread directly to customers' homes.

In the 1930s, when pizza gained popularity in America, the Sirico family began serving it as well, utilizing the same ovens used for baking bread and drawing on their Neapolitan heritage. This expansion soon led to the addition of pasta dishes and, ultimately, to the opening of a full-service restaurant, with Grandma serving as the first chef. The restaurant offered both indoor and outdoor dining and flourished following the repeal of Prohibition. Sirico's Restaurant and Bar endured throughout World War II. even as the sons left to serve their country. Frank and Rose, assisted by their daughters, continued to operate the business. Upon returning from the war, Carmine and Hercules helped grow the family enterprise further.

By the early 1960s, Sirico's had developed into three distinct businesses, managed by brothers Carmine and Hercules: a pizzeria in one building, a restaurant in another, and a catering hall where the outdoor garden had once been. By 1980, the catering operation had become so successful that the res-

taurant and pizzeria were closed in order to focus entirely on catering. Under the leadership of Jim and Hercules, Jr., Sirico's has continued to serve the Dyker Heights community, hosting thousands of weddings, communions, sweet sixteens, and dinner dances, and remaining a proud Brooklyn institution for generations.

As Sirico's celebrates a century of success and four generations of family leadership, it stands as a testament to Brooklyn's enduring spirit of hard work, hospitality, and community.

Mr. HUDSON. Mr. Speaker, I rise today to honor Sergeant Michael Verardo.

As the Representative from North Carolina's 9th District, I have the honor of representing Fort Bragg.

I am devastated, but grateful. It is the honor of my life to represent the incredible men and women of our Airborne and Special Operation's community, including my friend Michael.

To his wife Sarah and their precious three girls, Renee and I are so deeply sorry for this loss, and we were honored to stand together last week at Arlington National Cemetery.

We lost a true American hero with the passing of our friend Sergeant Michael Verardo.

An infantryman in the 82nd Airborne Division, Mike was severely wounded by an IED in Afghanistan that nearly took his life in 2010. He fought for his life and he fought to stay with his family, resulting in more than 120 surgeries and years of painful recovery.

Most of us would look at that day in 2010 as the worst day of our lives. Michael called it his "Alive Day." He chose to see every day after that as a gift. Another chance to love Sarah, to be a dad to his three little girls, to cheer on his New England Patriots (nobody is perfect), to enjoy his dogs, and to live in the country he believed was worth fighting for.

Michael did more than survive. Together with Sarah, he turned his own suffering into service. Their work with the Independence Fund and their advocacy in Washington and around the country changed lives.

Presidents listened. Cabinet Secretaries listened. Members of Congress listened.

Michael and Sarah helped shift how our Nation thinks about the most severely wounded veterans and the families who are right there with them.

His story advanced care at the Department of Veterans Affairs and the Department of War, evident by the presence of Secretary Collins and Secretary Hegseth at his interment ceremony at Arlington National Cemetery on November 19th.

Back home in North Carolina, Michael was a leader in his church and community. He showed up for Veterans. He competed in adaptive sports. And through it all, he was first and foremost a loving father and husband.

Sarah has said something I believe every American needs to hear: when it comes to our military and our veterans, everything should be purple. There should be nothing political in how we honor them, how we care for them, or how we remember them. Michael had that rare ability to make people on both sides of the aisle want to do better for our troops and their families.

Sarah called it the honor of her lifetime to be Michael's wife and caregiver. All of us have watched her live that out with strength and grace. Sarah, is a true inspiration. In a moment like this, when answers are hard to find, I am reminded of Proverbs 3:5: "Trust in the Lord with all your heart and lean not on your own understanding." She has walked that verse, day after day.

Michael's daughters should know their dad is a hero. Not only because of that tragic day in Afghanistan, but because of how he lived every day afterward. They will always be able to say, "My dad was Sergeant Michael Verardo," and our country will know exactly what that means.

For the rest of us, the way forward is clear. We must honor Michael's legacy by caring for the heroes he fought beside and their families. We must keep working to deliver real care and real support for those who come home bearing the scars of war. And we must especially take care of those who come home with hidden scars. We must remember that we stand together as Americans, united in gratitude for men like my friend Michael.
