H.R. 452, to award 3 Congressional Gold Medals to the members of the 1980 U.S. Olympic Men's Ice Hockey Team, in recognition of their extraordinary achievement at the 1980 Winter Olympics where, being comprised of amateur collegiate players, they defeated the dominant Soviet hockey team in the historic "Miracle on Ice", revitalizing American morale at the height of the Cold War, inspiring generations and transforming the sport of hockey in the United States. Signed on December 12, 2025. (Public Law 119–53)

H.R. 970, to amend title 38, United States Code, to require the Secretary of Veterans Affairs to periodically review the automatic maximum coverage under the Servicemembers' Group Life Insurance program and the Veterans' Group Life Insurance program. Signed on December 12, 2025. (Public Law 119–54)

H.R. 983, to Amend title 38, United States Code, to direct the Secretary of Veterans Affairs to disapprove courses of education offered by a public institution of higher learning that does not charge the in-State tuition rate to a veteran using certain edu-
