## Senate

### *Chamber Action*

(Legislative Days of January 7, 2026 and January 8, 2026)

**Routine Proceedings, pages S95–S119, S121–S122**

**Measures Introduced:** Fifteen bills and six resolutions were introduced, as follows: S. 3596–3610, S. Res. 576–580, and S. Con. Res. 25. **Page S115**

**Measures Passed:**

*January 6, 2021 plaque:* Senate agreed to S. Res. 580, directing the Architect of the Capitol to prominently display, in a publicly accessible location in the Senate wing of the United States Capitol, a plaque honoring the members of law enforcement responding on January 6, 2021, until the plaque can be placed in its permanent location. **Pages S111–12, S118**

*Southern California wildfires anniversary:* Senate agreed to S. Res. 577, observing the 1-year anniversary of the 2025 Southern California wildfires. **Pages S117–118, S119**

*Congratulating University of Washington Men's soccer team:* Senate agreed to S. Res. 578, congratulating the University of Washington men's soccer team on winning the 2025 National Collegiate Athletic Association Division 1 Men's Soccer National Championship. **Pages S118, S119**

*Social Security program:* Senate agreed to S. Res. 579, affirming the importance of the Social Security program to the people of the United States and expressing the sense of the Senate that Social Security must be preserved, protected, and strengthened for current and future generations. **Pages S118, S119**

**Measures Considered:**

**Hostilities Within or Against Venezuela:** By 52 yeas to 47 nays (Vote No. 5), Senate agreed to the motion to discharge the Committee on Foreign Relations of S.J. Res. 98, to direct the removal of United

States Armed Forces from hostilities within or against Venezuela that have not been authorized by Congress. **Page S100**

**Commerce, Justice, Science; Energy and Water Development; and Interior and Environment Appropriations Act, 2026—Cloture:** Senate began consideration of the motion to proceed to consideration of H.R. 6938, making consolidated appropriations for the fiscal year ending September 30, 2026. **Pages S119, S121**

A motion was entered to close further debate on the motion to proceed to consideration of the bill, and, in accordance with the provisions of Rule XXII of the Standing Rules of the Senate, and pursuant to the unanimous-consent agreement of Thursday, January 8, 2026, a vote on cloture will occur at 5:30 p.m., on Monday, January 12, 2026. **Pages S121–22**

A unanimous-consent agreement was reached providing that at approximately 3 p.m., on Monday, January 12, 2026, Senate resume consideration of the motion to proceed to consideration of the bill; and that notwithstanding Rule XXII, the motion to invoke cloture with respect to the motion to proceed to the bill ripen at 5:30 p.m. **Pages S121–22**

H.R. 178, to require the Secretary of Agriculture to carry out activities to suppress wildfires, and for other purposes, with an amendment (H. Rept. 119–429, Part 1);

H.R. 179, to direct the Secretary concerned to coordinate with impacted parties when conducting a forest management activity, and for other purposes, with an amendment (H. Rept. 119–430, Part 1);

H.R. 2250, to reauthorize the National Landslide Preparedness Act, and for other purposes, with an amendment (H. Rept. 119–431, Part 1);

H.R. 435, to amend title 5, United States Code, to provide direct hire authority to appoint individuals to Federal wildland firefighting and firefighting support positions in the Forest Service or the Department of the Interior, and for other purposes (H. Rept. 119–432, Part 1);

H.R. 1110, to require the Secretary of Agriculture to develop and implement a strategy to increase opportunities to utilize livestock grazing as a means of wildfire risk reduction, with amendments (H. Rept. 119–433, Part 1);

H.R. 2405, to direct the Secretary of Agriculture and the Secretary of the Interior to carry out activities to provide for white oak restoration, and for other purposes, with an amendment (H. Rept. 119–434, Part 1); and

H.R. 839, to prohibit the implementation of a Land Protection Plan for Muleshoe National Wildlife Refuge, with an amendment (H. Rept. 119–435).

**Commerce, Justice, Science; Energy and Water Development; and Interior and Environment Appropriations Act, 2026:** The House passed H.R. 6938, making consolidated appropriations for the fiscal year ending September 30, 2026, by a yea-and-nay vote of 397 yeas to 28 nays, Roll No. 7. Earlier, the House agreed to retain Divisions B and C by a yea-and-nay vote of 419 yeas to 6 nays, Roll No. 6, and to retain Division A by a yea-and-nay vote of 375 yeas to 47 nays, Roll No. 5.

H. Res. 977, the rule providing for consideration of the bills (H.R. 4593), (H.R. 5184), and (H.R. 6938) was agreed to yesterday, January 8th.

**Miccosukee Reserved Area Amendments Act—Presidential Veto:** The House voted to sustain the President's veto of H.R. 504, to amend the Miccosukee Reserved Area Act to authorize the expansion of the Miccosukee Reserved Area and to

carry out activities to protect structures within the Osceola Camp from flooding, by a yea-and-nay vote of yeas to nays, Roll No. 8 (two-thirds of those present not voting to override).

Subsequently, the veto message (H. Doc. 119–120) and the bill were referred to the Committee on Natural Resources.

**Finish the Arkansas Valley Conduit Act:** The House voted to sustain the President's veto of H.R. 131, to make certain modifications to the repayment for the Arkansas Valley Conduit in the State of Colorado, by a yea-and-nay vote of 248 yeas to 177 nays with one answering "present", Roll No. 9 (two-thirds of those present not voting to override).

Subsequently, the veto message (H. Doc. 119–119) and the bill were referred to the Committee on Natural Resources.

**Breaking the Gridlock Act:** The House passed H.R. 1834, to advance policy priorities that will break the gridlock, by a yea-and-nay vote of 230 yeas to 196 nays, Roll No. 11. **Pages H212–13, H213–27**

H. Res. 780, providing for consideration of the bill (H.R. 1834) was agreed to by a yea-and-nay vote of 224 yeas to 202 nays, Roll No. 10.

**Quorum Calls—Votes:** Seven yea-and-nay votes developed during the proceedings of today and appear on pages H209–10, H210, H210–11, H211–12, H212, H213, and H226–27.
