The Committee on Rules, having had under consideration House Resolution 328, by a record vote of 7 to 3, report the same to the House with the recommendation that the resolution be adopted.

SUMMARY OF PROVISIONS OF THE RESOLUTION

The resolution provides for consideration of H.J. Res. 68, authorizing the limited use of the United States Armed Forces in support of the NATO mission in Libya, under a closed rule. The resolution provides one hour of debate on H.J. Res. 68 with 40 minutes equally divided and controlled by the chair and ranking minority member of the Committee on Foreign Affairs and 20 minutes equally divided and controlled by the chair and ranking minority member of the Committee on Armed Services. The resolution waives all points of order against consideration of H.J. Res. 68. The resolution provides that H.J. Res. 68 shall be considered as read. The resolution waives all points of order against provisions in H.J. Res. 68. The resolution provides one motion to recommit H.J. Res. 68.

The resolution further provides for consideration of H.R. 2278, to limit the use of funds appropriated to the Department of Defense for United States Armed Forces in support of North Atlantic Treaty Organization Operation Unified Protector with respect to Libya, unless otherwise specifically authorized by law, under a closed rule. The resolution provides one hour of debate on H.R. 2278 equally divided and controlled by the chair and ranking minority member of the Committee on Armed Services. The resolution waives all points of order against consideration of H.R. 2278. The resolution provides

that H.R. 2278 shall be considered as read. The resolution waives all points of order against provisions in H.R. 2278. Finally, the resolution provides one motion to recommit H.R. 2278.
