## R E P O R T

[To accompany H. Res. 838]

The Committee on Rules, having had under consideration House Resolution 838, by a record vote of 8 to 3, report the same to the House with the recommendation that the resolution be adopted.

### SUMMARY OF PROVISIONS OF THE RESOLUTION

The resolution provides for consideration of H.R. 4821, the Department of the Interior, Environment, and Related Agencies Appropriations Act, 2024, under a structured rule. The resolution waives all points of order against consideration of the bill. The resolution provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their respective designees. The resolution provides that the bill shall be considered as read. The resolution waives all points of order against provisions in the bill. The resolution makes in order only those amendments printed in part A of the Rules Committee report, amendments en bloc described in section 3 and pro forma amendments described in section 4. Each amendment shall be considered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, shall be debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, shall not be subject to amendment except as pro-

vided by section 4 of the rule, and shall not be subject to a demand for division of the question. All points of order against the amendments printed in part A of the Rules Committee report or amendments en bloc described in section 3 of the resolution are waived. The resolution provides that the chair of the Committee on Appropriations or her designee may offer amendments en bloc consisting of amendments printed in part A of the report not earlier disposed of. Amendments en bloc shall be considered as read, shall be debatable for 20 minutes equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their respective designees, shall not be subject to amendment except as provided by section 4 of the rule, and shall not be subject to a demand for division of the question. The resolution provides that the chair and ranking minority member of the Committee on Appropriations or their respective designees may offer up to 10 pro forma amendments each at any point for the purpose of debate. The resolution provides one motion to recommit. The resolution further provides for consideration of H.R. 4820, the Transportation, Housing and Urban Development, and Related Agencies Appropriations Act, 2024, under a structured rule. The resolution waives all points of order against consideration of the bill. The resolution provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their respective designees. The resolution provides that the bill shall be considered as read. The resolution waives all points of order against provisions in the bill. The resolution makes in order only those amendments printed in part B of the Rules Committee report, amendments en bloc described in section 8, and pro forma amendments described in section 9. Each amendment shall be considered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, shall be debatable for the time specified in the report equally divided and controlled by the proponent and an opponent, shall not be subject to amendment except as provided by section 9 of the rule, and shall not be subject to a demand for division of the question. All points of order against the amendments printed in part B of the Rules Committee report or amendments en bloc described in section 8 of the resolution are waived. The resolution provides that the chair of the Committee on Appropriations or her designee may offer amendments en bloc consisting of amendments printed in part B of this report not earlier disposed of. Amendments en bloc shall be considered as read, shall be debatable for 20 minutes equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their respective designees, shall not be subject to amendment except as provided by section 9 of the rule, and shall not be subject to a demand for division of the question. The resolution provides that the chair and ranking minority member of the Committee on Appropriations or their respective designees may offer up to 10 pro forma amendments each at any point for the purpose of debate. The resolution provides for one motion to recommit. The resolution further provides for consideration of H.R. 6126, the Israel Security Supplemental Appropriations Act, 2024, under a closed rule. The resolution waives all points of order against consideration of the bill. The resolution provides that the bill shall be considered as read. The

resolution waives all points of order against provisions in the bill. The resolution provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their respective designees. The resolution provides one motion to recommit.

#### EXPLANATION OF WAIVERS

The waiver of all points of order against consideration of H.R. 4821 includes:

—Section 306 of the Congressional Budget Act, which prohibits consideration of legislation within the jurisdiction of the Committee on the Budget unless referred to or reported by the Budget Committee.

The waiver of all points of order against provisions in H.R. 4821 includes:

—Clause 2(a) of rule XXI, which prohibits unauthorized appropriations or legislative provisions in an appropriations bill.

—Clause 2(c) of rule XXI, which prohibits consideration of amendments to an appropriations bill if it changes existing law.

—Clause 5(a) of rule XXI, which prohibits a bill or joint resolution carrying a tax or tariff measure from being reported by a committee not having jurisdiction to report tax or tariff measures.

—Section 3(aa) of H. Res. 5, which prohibits an unauthorized appropriation in an appropriations bill in excess of the most recent enacted level.

Although the resolution waives all points of order against the amendments printed in part A of the Rules Committee report or amendments en bloc described in section 3 of the resolution, the Committee is not aware of any points of order. The waiver is prophylactic in nature.

The waiver of all points of order against consideration of H.R. 4820 includes:

—Section 3(f) of H. Res. 5, which requires the Spending Reduction Account in a general appropriation bill to include either a recitation of the amount by which an applicable allocation of new budget authority under section 302(b) of the Congressional Budget Act of 1974 exceeds the amount of new budget authority proposed by the bill or if no such allocation is in effect, “\$0”.

The waiver of all points of order against provisions in H.R. 4820 includes:

—Clause 2(a) of rule XXI, which prohibits unauthorized appropriations or legislative provisions in an appropriations bill.

—Clause 2(c) of rule XXI, which prohibits consideration of amendments to an appropriations bill if it changes existing law.

—Clause 5(a) of rule XXI, which prohibits a bill or joint resolution carrying a tax or tariff measure from being reported by a committee not having jurisdiction to report tax or tariff measures.

—Section 3(aa) of H. Res. 5, which prohibits an unauthorized appropriation in an appropriations bill in excess of the most recent enacted level.

SUMMARY OF THE AMENDMENTS TO H.R. 4821 IN PART A  
MADE IN ORDER

1. Griffith (VA): Decreases the Bureau of Land Management's Wild Horse and Burro program funds by \$74.232 million to Fiscal Year 2019 levels. (10 minutes)

2. Hageman (WY): Reduces BLM funding by 50%. (10 minutes)

3. Buchanan (FL): Provide \$1.15 million to the Prescott Grant Program to provide for more funding into the rescue and rehabilitation of manatees. Reduces funding for the DOI Office of the Secretary. (10 minutes)

4. Molinaro (NY): Provides a \$2 million increase to the FWS Delaware River Basin Restoration Program. Offset by a \$2 million reduction from the DOI Office of the Secretary. (10 minutes)

5. Adams (NC), Raskin (MD), Blumenauer (OR), Fitzpatrick (PA), Norton (DC), McClellan (VA): Increases and decreases funding to the United States African-American Burial Grounds Preservation Program by \$3 million. Expresses support for funding at amount authorized to be appropriated. (10 minutes)

6. Castro (TX): Increases and decreases funding to the Operation of the National Parks budget to bring attention to the need for ad-

ditional funding to the San Antonio Missions for security and maintenance purposes. (10 minutes)

7. Lawler (NY), Beyer (VA): Increases and decreases funding for the National Park Service to enhance maintenance and conservation of the Appalachian National Scenic Trail. (10 minutes)

8. Neguse (CO): Increases and decreases funding for the National Park Service by \$266,124,000 to highlight the funding level requested in the President's Budget Request for the NPS and their funding needs. (10 minutes)

9. Norton (DC): Increases/decreases by \$1 million the National Park Service's operations account to direct NPS to submit a report to Congress identifying statutes and regulations that inhibit active use of urban parks in the National Park System. Active use is defined as use that prioritizes current enjoyment by people and improves quality of life, and includes playgrounds, pedestrian- and bicycle-friendly infrastructure, sports and recreation facilities, community events, programming, and concessions. (10 minutes)

10. Garbarino (NY), Goldman (NY), D'Esposito (NY), Nadler (NY): Reduces by \$15 million and increases by \$15 million the National Recreation and Preservation account with the intent to provide \$15 million for 9/11 Memorial Act grants. (10 minutes)

11. Lawler (NY): Provides a \$2 million increase to the National Recreation and Preservation Account to support NPS Heritage sites nationwide, including the Maurice D. Hincey Hudson River Valley National Heritage Area in the Hudson River Valley. Offset by a \$2 million reduction to the DOI Office of the Secretary. (10 minutes)

12. Molinaro (NY): Provides a \$2 million increase to the National Recreation and Preservation Account to support NPS Heritage sites across the country, including the Erie Canal National Heritage Area in Upstate New York. Offset by a \$2 million reduction to the DOI Office of the Secretary. (10 minutes)

13. Espaillat (NY): Increases and decreases funding to highlight the importance of the Historic Preservation Fund, which rehabilitates important historical sites. (10 minutes)

14. Jackson Lee (TX): Increases and decreases funds for the Historic Preservation Fund by \$3,000,000 with the intent of enhancing activities for the preservation, restoration, and maintenance of nationally significant sites, artifacts, and structures through competitive grants at the local, state, and federal levels focusing on projects involving HBCUs, sites and stories linked to the Civil Rights movement, landmarks associated with communities that are historically underrepresented, and sites related to the histories of Indigenous peoples. (10 minutes)

15. Collins (GA): Transfers the Council on Environmental Quality's funding to the National Parks Service for construction activities. (10 minutes)

16. DeSaulnier (CA): Strikes section 447, which would prohibit funds from being used to consider the social cost of carbon. (10 minutes)

17. Barr (KY): Increases funding for USGS by \$5 million to implement the Biden Administration's 2021 100 Day Supply Chain Review recommendation for the Department of Interior to identify potential sites where critical minerals could be sustainably and responsibly produced and processed in the United States. (10 minutes)

18. Buchanan (FL): Provide \$2.5 million to the National Water Quality Program to bolster research into harmful algal blooms. Reduces funding for the DOI Office of the Secretary. (10 minutes)

19. Perry (PA), Van Drew (NJ): Reduces funding for the Bureau of Ocean Energy Management by \$28 million for the purpose of eliminating funding for the Office of Renewable Energy Programs. (10 minutes)

20. Boebert (CO): Takes funding from EPA bureaucracy to fund Bureau of Indian Affairs for dirt school bus routes by \$1.5 million. (10 minutes)

21. Clyde (GA), Buck (CO): Transfers the \$15,000 reception/representation allowance for the Secretary of the Interior to the spending reduction account. (10 minutes)

22. Gottheimer (NJ): Increases funding for the Holocaust Memorial Museum by \$5 million to study Holocaust education efforts in public schools nationwide; determine which states and school districts require or do not require Holocaust education in their curriculum; determine which states and school districts offer optional Holocaust education; identify the standards and requirements schools mandate on this Holocaust education; identify the types and quality of instructional materials used to teach; and identify the approaches used by schools to assess what students learn. (10 minutes)

23. Kamlager-Dove (CA), González-Colón (PR): Increases and decreases by \$3 million to highlight the need to conduct a Workplace Environmental Survey to measure progress and direct interventions regarding sexual harassment/assault and other toxic workplace issues at the Department of the Interior. (10 minutes)

24. Molinaro (NY): Provides a \$4 million increase for rural water technical assistance authorized under the Grassroots Rural and Small Community Water System Act. Offset by a \$4 million decrease from DOI Office of the Secretary. (10 minutes)

25. Neguse (CO): Increases funding for the DOI and USFS Wildland Fire Management Accounts by \$2 million each. (10 minutes)

26. Norcross (NJ): Increases and decreases funding to direct the Bureau of Ocean Energy Management to conduct a study on the impacts of commercial fishing on endangered marine mammals. (10 minutes)

27. Plaskett (VI), Moylan (GU), Radewagen (AS), Sablan (MP): Provides level funding for Department of the Interior assistance to territories of the United States by redirecting \$12.5 million from the Office of the Secretary general fund to territorial assistance. (10 minutes)

28. Boebert (CO): Transfers \$5,000,000 from EPA bureaucracy to hazardous fuels reduction activities within BLM. (10 minutes)

29. Neguse (CO), Harder (CA): Increases and decreases by \$575 million for Department-Wide Wildland Fire Management Programs with the intent that the \$575 million will be used to maintain the 2021 pay increase for Federal Wildland Firefighters. (10 minutes)

30. Castro (TX): Increases and decreases funding for the Energy Community Revitalization Program for the purpose of bringing attention to plugging, reclaiming, and remediating orphaned wells that have created bodies of water that contain and emit dangerous amounts of hydrogen sulfide. (10 minutes)

31. Connolly (VA): Increases and decreases funding for EPA's Science and Technology account by \$1 million to highlight the need for EPA's Office of Air and Radiation to develop and document a business case for a new IT system for air quality data based on considerations for how such a system could address the challenges currently posed by the Air Quality System (AQS) and AirNow. (10 minutes)

32. Massie (KY): Increases and decreases funding to encourage EPA to reduce the significant backlog of pesticide registrations in the Antimicrobial Division of the EPA Office of Pesticide Programs and to be more transparent with stakeholders seeking conditional registrations. (10 minutes)

33. Molinaro (NY), Lawler (NY): Provides a \$13 million increase to the Toxic Substances Superfund account to support the clean up and restoration of deeply contaminated sites across the country, including the Hudson River PCB Superfund Site. Offset with a \$13 million reduction to the Science and Technology Account. (10 minutes)

34. Blunt Rochester (DE), Magaziner (RI), Dingell (MI): Increases the ensure safe water program funding of the Environmental Programs and Management account by \$3,000,000 for needs assessment completion authorized in section 50108 of the Infrastructure Investment and Jobs Act and decreases the account by \$3,000,000. (10 minutes)

35. Boebert (CO): Transfers \$5,000,000 from EPA bureaucracy to fund active forest management at USFS. (10 minutes)

36. Boebert (CO): Transfers funding from EPA bureaucracy to the Holocaust Memorial Museum account. (10 minutes)

37. Feenstra (IA): Increases and decreases funding for EPA salaries to emphasize that the EPA should not promulgate any new rules that would affect over 50% of American farmland without explicit congressional approval. (10 minutes)

38. Gonzales, Tony (TX): Increases funding for the Southwest Water Infrastructure program to \$71 million and decreases EPA's Environmental Programs and Management account by \$71 million. (10 minutes)

39. McCormick (GA): Reduces funding for the Environmental Protection Agency (EPA) Environmental Programs and Management account by \$17 million. Reallocates \$10 million for increased oversight of the EPA and cuts spending by \$2 million. (10 minutes)

40. Neguse (CO): Increases and decreases the EPA Environmental Programs and Management account by \$12 million to support funding for the EPA's Office of Noise Abatement and Control. (10 minutes)

41. Sessions (TX): Increases the Forest Service Capital Improvement and Maintenance account by \$15 million for the purpose of improving roads in National Forests. Reduces the Environmental Protection Agency (EPA) Environmental Programs and Management account by \$16 million. (10 minutes)

42. Lawler (NY): Increases and decreases funding for the Hazardous Substance Superfund with the intent of further comprehensive tests of water contaminants in the Lower Hudson River. (10 minutes)

43. Scott, David (GA): Increases and decreases funding for the State and Tribal Assistance Grants Account by \$1 million to high-

light the need for increased air quality monitoring in urban communities. (10 minutes)

44. Sykes (OH): Increases and decreases funding to highlight the funding deficiencies proposed for the Clean Water and Drinking Water State Revolving Funds. (10 minutes)

45. Neguse (CO): Increases and decreases funding for the Clean Water State Revolving Fund and Drinking Water State Revolving Fund to highlight the additional funding needed to support these critical programs. (10 minutes)

46. Molinaro (NY), Gluesenkamp Perez (WA): Increase/decrease amendment to highlight the importance of the Clean Water and Drinking Water State Revolving Fund programs for assisting rural community's water systems. (10 minutes)

47. Moylan (GU): Increases share of certain grants available to insular areas. (10 minutes)

48. Peters (CA), Jacobs (CA), Vargas (CA), Levin (CA): Increases and Decreases the Border Water Infrastructure Program to emphasize the need for more funding to repair and expand the South Bay International Wastewater Treatment Plant. (10 minutes)

49. Dingell (MI): Increases and decreases the EPA's Brownfields Program funding by \$20 million to emphasize the need to continue investing in the clean up of contaminated sites. (10 minutes)

50. Lee (PA): Increases and decreases funding for lead testing at schools and child care facilities to protect children from lead in drinking water. (10 minutes)

51. Trahan (MA): Increases and decreases Sec. 221 of the Federal Water Pollution Control Act to emphasize the need to provide funding for combined sewer overflows. (10 minutes)

52. Gluesenkamp Perez (WA): Increases and decreases funding for the Water Infrastructure Finance and Innovation Program Account to emphasize the critical importance of supporting our nation's drinking water and wastewater infrastructure. (10 minutes)

53. Neguse (CO): Increases funding to the USFS National Forest System administrative account by \$2 million to direct additional funding to the Arapaho Roosevelt National Forest in Colorado for the purposes of hiring additional staff for the Sulphur Ranger District. (10 minutes)

54. Barr (KY): Increases and decreases funding to highlight the importance of the Forest Service's efforts to regenerate white oak in our national forests and to increase private forest landowner outreach and education to establish white oak forests for future generations. (10 minutes)

55. Neguse (CO): Increases and decreases funding for National Forest System by \$409,843,000 to highlight the additional funding requested in the President's Budget Request and address staff capacity issues. (10 minutes)

56. Panetta (CA): Increases and decreases funding for the U.S. Forest Service to manage and maintain firebreaks in the wildland urban interface. (10 minutes)

57. Yakym (IN), Panetta (CA): Increases and decreases the funding for the White House Council on Environmental Quality to resume reporting on National Environmental Policy Act litigation, Environmental Impact Statement (EIS) page counts, and average EIS timelines. (10 minutes)

58. Westerman (AR), Moylan (GU): Reduces funding for the operation of the Council on Environmental Quality by \$2,750,000 to its currently authorized level of \$1,000,000. (10 minutes)

59. Perry (PA): Strikes funding for the Council on Environmental Quality. (10 minutes)

60. Perry (PA): Strikes funding for the National Endowment for the Arts. (10 minutes)

61. Perry (PA): Strikes funding for the National Endowment for the Humanities. (10 minutes)

62. Rouzer (NC): Revises language regarding borrow sites for coastal storm risk management projects within the Coastal Barrier Resources Act system. (10 minutes)

63. Nehls (TX), Gosar (AZ): Prohibits funds made available by this Act for the National Park Service to place any limitation on the number of air tours at national parks. (10 minutes)

64. Graves (LA): Prohibits the use of funds under this act to issue new major rules if OMB determines that the rule will have a significant negative effect on the economy, increase inflation, or adversely impact American international competitiveness. (10 minutes)

65. Hageman (WY): Prohibits the finalization, enforcement, administration, and implementation of the Rock Springs draft Resource Management Plan Revision from the Bureau of Land Management, which severely restricts grazing, mining, recreation, and other activities on 3.6 million acres in Wyoming. (10 minutes)

66. Harshbarger (TN): Prohibits funds to the United States Board on Geographic Names. (10 minutes)
