The Committee on Rules, having had under consideration House Resolution 977, by a record vote of 8 to 3, report the same to the House with the recommendation that the resolution be adopted.

SUMMARY OF PROVISIONS OF THE RESOLUTION

The resolution provides for consideration of H.R. 4593, the SHOWER Act, under a closed rule. The resolution waives all points of order against consideration of the bill. The resolution provides that the bill shall be considered as read. The resolution waives all points of order against provisions in the bill. The resolution provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Energy and Commerce or their respective designees. The resolution provides for one motion to recommit. The resolution further provides for consideration of H.R. 5184, the Affordable HOMES Act, under a closed rule. The resolution waives all points of order against consideration of the bill. The resolution provides that the amendment in the nature of a substitute recommended by the Committee on Energy and Commerce now printed in the bill shall be considered as adopted and the bill, as amended, shall be considered as read. The resolution waives all points of order against provisions in the bill, as amended. The resolution provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Energy and Com-

merce or their respective designees. The resolution provides for one motion to recommit. The resolution further provides for consideration of H.R. 6938, the Commerce, Justice, Science; Energy and Water Development; and Interior and Environment Appropriations Act, 2026, under a closed rule. The resolution waives all points of order against consideration of the bill. The resolution provides that the bill shall be considered as read. The resolution waives all points of order against provisions in the bill. The resolution provides one hour of general debate equally divided and controlled by the chair and ranking minority member of the Committee on Appropriations or their respective designees. The resolution provides that the Chair shall put the question on retaining Division A and retaining Divisions B and C of the bill in the order specified by the Chair; provides that the yeas and nays shall be considered as ordered on each of the questions; and provides that the Chair shall then put the question on engrossment and third reading of the text comprising those portions of the bill retained. The resolution provides for one motion to recommit. The resolution directs the Clerk, in the engrossment of H.R. 6938, to make technical and conforming changes in the event a portion of the bill is not retained. The resolution further provides that the chair of the Committee on Appropriations may insert in the Congressional Record not later than January 9th, 2026, such material as he may deem explanatory of H.R. 6938.

EXPLANATION OF WAIVERS

—Clause 12 of rule XXI, which prohibits consideration of a bill or joint resolution pursuant to a special order of business reported by the Committee on Rules that has not been reported by a committee.
