**SUMMARY:** The Federal Communications Commission, as part of its continuing effort to reduce paperwork burden invites the general public and other Federal agencies to take this opportunity to comment on the following information collection, as required by the Paperwork Reduction Act of 1995, Public Law 104-13. Applicants must demonstrate that any new area predicted to lose service as a result of interference has adequate service remaining. In addition, licensees are required to serve a copy of any application for co-channel or first-adjacent channel stations proposing predicted interference caused in any area where interference is not currently predicted to be caused upon the licensee(s) of the affected short-spaced station(s).

The data are used by Commission staff to determine if the public interest will be served and that existing levels of interference will not be increased to other licensed stations. Providing copies of application(s) to affected licensee(s) will enable potentially affected parties to examine the proposals and provide them an opportunity to file informal objections against such applications.

*Abstract:* The National Flood Insurance Program (NFIP) is authorized by Public Law (Pub. L.) 90-448 National Flood Insurance Act of 1968 and expanded by Public Law 93-234, Flood Disaster Protection Act of 1973 to provide low-cost federally subsidized flood insurance for existing buildings exposed to flood risks. In return communities must enact and administer construction safeguards to ensure that new construction in the flood plain will be built to eliminate or minimize future flood damage. The forms included in this collection of information provide the information that is necessary for the continued proper performance of the Agency's functions related to indemnifying policyholders for flood damage to their properties.

*Affected Public:* Individuals and households, Business or other for-profit, Not-for-profits institutions, Farms, Federal government and State, local or tribal governments.

*Number of Respondents:* 77,634.

*Estimated Time per Respondent:* 4 hours.
