Other agenda items include: a presentation on the new Worker Health Chartbook, 2000, which has just been released by NIOSH; a panel presentation by the National Institute of Environmental Health Sciences (NIEHS) related to its Worker Education and Training Program Partnership; a presentation by the

Veterans Health Administration (VHA) related to its safety and health partnership; and a presentation by Dr. Rita C. Richey of Wayne State University related to the evaluation of training programs.

Written data, views or comments for consideration by the committee may be submitted, preferably with 20 copies, to Joanne Goodell at the address provided below. Any such submissions received prior to the meeting will be provided to the members of the Committee and will be included in the record of the meeting.
