**Authority:** Section 582 of the Public Health Service Act, as amended and subject to the availability of funds.

**Funding Opportunity Description:** The Substance Abuse and Mental Health Services Administration (SAMHSA), Center for Mental Health Services (CMHS), is accepting applications for Fiscal Year 2003 cooperative agreements to expand the National Child Traumatic Stress Initiative (NCTSI) Community Treatment and Services Centers. The purpose of the NCTSI is to improve treatment and services for all children and adolescents in the United States who have experienced traumatic events or witnessed such events. A network of centers, the NCTSN, has been established to promote the development and use of effective treatment and services, to develop resources on trauma for professionals, consumers, and the public, and to develop trauma-focused public education and professional training and other field development activities.

**Eligible Applicants:** The following domestic public and private non-profit entities are eligible to apply. Community-based and faith-based organizations, out-patient clinics, public or private universities, psychiatric or general hospitals, units of State or local governments, Indian tribes, partnership of multiple clinical centers, programs and/or community service providers applying as a single center (in which case one of the participating organizations must be designated as the applicant organization).

It is SAMHSA's intent to ensure the broadest possible distribution of NCTSI grant funds across the U.S. Therefore, applicant organizations from the following States will be given priority consideration for grant awards for the Community Treatment and Services Center program because they do not currently have a NCTSI center: Alaska, Arizona, Arkansas, Delaware, Georgia,
