**ACTION:** Notice; Defense Base Closure and Realignment Commission—open meeting regarding consideration of certain installations located in the States of Indiana, Maine, North Carolina and Ohio not recommended for closure or realignment by the Secretary of Defense (Washington, DC).

**SUMMARY:** Notice is hereby given that a delegation of Commissioners of the Defense Base Closure and Realignment Commission will hold an open meeting on August 10, 2005 from 8:30 a.m. to 12:30 p.m. at Senate Hart Hearing Room 216, Constitution Avenue, Washington, DC 20510. The delay of this change notice resulted from the short time-frame established by statute for the operations of the Defense Base Closure and Realignment Commission and the necessity of coordinating this meeting with Federal, State and local government officials. The Commission requests that the public consult the 2005 Defense Base Closure and Realignment Commission Web site, <http://www.brac.gov>, for updates.

The Commission delegation will meet to receive comment from Federal, State and local government representatives

and the general public on certain base closure and realignment actions under consideration by the Commission in the States of Indiana, Maine, North Carolina and Ohio that were not recommended by the Department of Defense (DoD). The installations concerned are listed in FR Doc. 05-14596, published in the **Federal Register** of July 22, 2005, on page 42311. The purpose of this regional meeting is to allow communities an opportunity to voice their concerns, counter-arguments, and opinions related to the proposed action in a live public forum. This meeting will be open to the public, subject to the availability of space. Sign language interpretation will be provided. The delegation will not render decisions regarding the DoD recommendations at this meeting, but will gather information for later deliberations by the Commission as a whole.

## **POLICY JUSTIFICATION**

### **Israel - Fleet Management Program**

**The Government of Israel has requested a possible sale of a fleet management program for U.S. Government and contractor management and logistics support of Israeli Air Force F-15 and F-16A/B Pratt and Whitney F-100 model engines, spare and repair parts, support equipment, publications and technical documentation, personnel training and training equipment, U.S. Government and contractor engineering and logistics personnel services and other related elements of logistics support. The estimated cost is \$600 million.**

**This proposed sale will contribute to the foreign policy and national security of the U.S. by helping to improve the security of a friendly country that has been, and continues to be, an important force for economic progress in the Middle East. This proposed sale will help Israel to maintain its qualitative edge by supporting its existing systems, promoting Israeli readiness and self-sufficiency, and standardizing weapon system operability with the U.S. forces.**

**The Israel fleet management program for U. S. Government management and contractor sustainment support consists of spare parts forecasting, inventory management, and maintenance prioritization to ensure 95 per cent flying hour capability for the existing Israeli Air Force (IAF) fleet of 202 Pratt and Whitney F-100 engines in support of both F-15 and F-16 fleet aircraft for a period of ten (10) years. Contractor support will include, but not be limited to, management, maintenance, support, overhaul, repair, testing, spare and repair parts, support equipment, engineering and technical support, training and other related elements of program support of F-100-PW-100DPI engines installed in IAF F-15 Fighter aircraft and F100-PW-200DPI engines installed in IAF F-16A/B fighter aircraft for a period of ten years.**

**The proposed sale of this equipment and support will not affect the basic military balance in the region.**

**The prime contractor will be Pratt and Whitney of East Hartford, Connecticut. There are no known offset agreements proposed in connection with this potential sale.**

**Implementation of this proposed sale will require the assignment of 2 U.S. Government and 12 contractor representatives for 10 years to Israel.**

**There will be no adverse impact on U.S. defense readiness as a result of this proposed sale.**
