(vii) Sensitivity of Technology:

1. **Generation (Gen) II Single Tube Night Vision Goggle – A typical Gen II night vision goggle uses a high-end Gen II image intensifier tube with a signal to noise ratio which equates to a Figure of Merit of 1250 or less.**

2. **Commercial AN/PVS-17 - The Mini Night Sight (MNS) is a lightweight, compact, high performance system. It weighs less than two pounds and is submersible to twenty meters (66ft.). It is mounted on the extended carbine rail that has been optimized to allow other systems to be used in conjunction with the sight such as a laser illuminator.**

3. **Commercial AN/PVS-10 - The Sniper Night Sight (SNS) is a lightweight, weapon-mounted, self-contained image-intensified passive device designed primarily for use by the sniper in day and night operations. A day/night lever enables the user to alternate between day and night modes of operation. SNS employs a variable gain image intensifier that can be adjusted by the user depending on the ambient light levels. SNS includes a black-line reticle for day use and illuminated for night use.**

2. **If a technologically advanced adversary were to obtain knowledge of the specific hardware and software elements, the information could be used to develop countermeasures which might reduce weapon system effectiveness or be used in the development of a system with similar or advanced capabilities.**
