The property consists of one parcel roughly located in the Northeast quadrant of the airport on the west side of Tinker Drive. This property is currently shown on the approved Airport Layout Plan as non-aeronautical use land and the proposed use of this property is compatible with airport operations. The City will ultimately sell the property for future industrial use with proceeds of the sale providing funding for future airport development.
