Jefferson, Springfield, 08000266			Notice is hereby given that on March 11, 2008, a Modification of 1994 Consent Decree Affecting Operable Unit 9 ("Consent Decree Modification") in <i>State of Colorado v. ASARCO Incorporated et al.</i> , Civil Action No. 86- cv-1675-WYD (consolidated with 83- cv-2388-WYD) was lodged with the United States District Court for the District of Colorado.
<i>Jackson County</i>			The United States previously entered into a consent decree with ASARCO Incorporated (now ASARCO LLC) ("ASARCO") concerning, among other things, ASARCO's implementation of the remedial action addressing residential soil contamination designated as Operable Unit 9 ("OU9") of the California Gulch Superfund Site located in Lake County, Colorado. That consent decree was approved and entered by the United States District Court for the District of Colorado on August 26, 1994 (the "1994 Decree"). The proposed Consent Decree Modification implements a settlement of that portion of the claim filed by the United States in <i>In re ASARCO LLC</i> , a bankruptcy case pending in the Southern District of Texas, Corpus Christi Division, Case No. 05-21207, concerning OU9. Pursuant to the terms of the settlement ASARCO will pay approximately \$1 million to the United States, a trust fund established by ASARCO to fund the remedial action addressing residential soil lead contamination at the Site will be modified to provide sole access to the account to the U.S. Environmental Protection Agency, the Colorado Department of Public Health and Environment, and the Lake County Health Department (pursuant to their separate agreement), and ASARCO will have no further obligation for the implementation of the OU9 remedy.

Notice of Lodging of Settlement Agreement Pursuant to the Comprehensive Environmental Response, Compensation and Liability Act

Notice is hereby given that on March 11, 2008 a proposed settlement agreement in *In re W.R. Grace & Co.*, Case No. 01-01139 (JFK), was lodged with the United States Bankruptcy Court for the District of Delaware. The proposed Settlement Agreement would resolve the United States' proofs of claim filed in W.R. Grace & Co.'s bankruptcy proceeding for environmental response costs at the Libby Asbestos Site in Montana pursuant to section 107 of the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA), 42 U.S.C. 9607.

Under the terms of the Settlement Agreement, W.R. Grace & Co. will, among other things, pay the United States \$250 million within 30 days of Bankruptcy Court approval of the settlement.

The Department of Justice will receive, for a period of thirty (30) days from the date of this publication, comments relating to the proposed settlement agreement. Notice is hereby given that, on February 14, 2008, pursuant to Section 6(a) of the National Cooperative Research and Production Act of 1993, 15 U.S.C. 4301 et seq. ("the Act"), SSPC: The Society for Protective Coatings ("SSPC") has filed written notifications simultaneously with the Attorney General and the Federal Trade Commission disclosing (1) the name and principal place of business of the standards development organization and (2) the nature and scope of its standards development activities. Development of voluntary consensus standards for compositions and performance of generic types of heavy-duty industrial and maintenance protective coatings, coating systems, and abrasives; cleanliness requirements for steel and concrete prior to the application of industrial and maintenance protective coatings; techniques and procedures for application of industrial and maintenance protective coatings; and requirements for third-party programs enabling facility owners to evaluate the qualifications of firms that apply industrial coatings to steel and concrete in the field and in paint shops, coating inspection companies, and coating applicators.
