SUPPLEMENTARY INFORMATION: The National Science Foundation, as directed by the Antarctic Conservation Act of 1978 (Pub. L. 95-541), as amended by the Antarctic Science, Tourism and Conservation Act of 1996, has developed regulations for the establishment of a permit system for various activities in Antarctica and designation of certain animals and certain geographic areas requiring special protection. The regulations establish such a permit system to designate Antarctic Specially Protected Areas.

Activity for Which Permit Is Requested

Enter Antarctic Specially Protected Areas. The applicant plans to enter Cape Royds (ASPAs 121), Cape Crozier (ASPAs 124), Tramway Ridge (ASPAs 130), Cape Evans (ASPAs 155), and Backdoor Bay (ASPAs 157) to film Adelie penguins, scientists working on Mount Erebus to capture key science and wildlife stories for the Discovery/BBC series, "Frozen Planet".

The applicant plans to enter Emperor Island, Dion Islands (ASPAs 107), Lagotellerie Island (ASPAs 115), Avian Island (ASPAs 117), Rothera Point, Adelaide Island (ASPAs 147), Ablation Valley, Ganymede Heights (ASPAs 147), Green Island (ASPAs 108), Litchfield Island (ASPAs 113), Biscoe Point (ASPAs 139), South Bay, Doumer Island (ASPAs 146), East Dallman Bay (ASPAs 153), Cierva Point (ASPAs 134), Western

Bransfield Strait (ASPAs 152), Mount Flora, Hope Bay (ASPAs 148), Byers Peninsula (ASPAs 126), Port Foster (ASPAs 145), Deception Island (ASPAs 140), Cape Shirreff (ASPAs 149), Potter Peninsula (ASPAs 132), Western Shore Admiralty Bay (ASPAs 128), Lions Rump (ASPAs 151), Chile Bay (Discovery Bay) (ASPAs 144), Coppermine Peninsula (ASPAs 112), Harmony Point (ASPAs 133), Ardley Island (ASPAs 150), and Fildes Peninsula (ASPAs 125) to collect surface samples and rocks from the beaches in order to reconstruct the record of sea-level changes over the last 10,000 years.
