Conferences issued on January 6, 2015,<sup>2</sup> the Federal Energy Regulatory Commission (Commission) staff will hold a Central region<sup>3</sup> technical conference to discuss implications of compliance approaches to the Clean Power Plan proposed rule, issued by the Environmental Protection Agency (EPA) on June 2, 2014.<sup>4</sup> The technical conference will focus on issues related to electric reliability, wholesale electric markets and operations, and energy infrastructure in the Central region. The Commission will hold the Central region technical conference on March 31, 2015, from approximately 8:45 a.m. to 5:00 p.m. at the Renaissance St. Louis Airport Hotel, 9801 Natural Bridge Road, St. Louis, MO 63134 (Phone: (314) 429–1100). This conference is free of charge and open to the public. Commission members may participate in the conference.
