Updated Disclosure Requirements and Summary Prospectus for Variable Annuity and Variable Life Insurance Contracts

Correction

In rule document 2020–05526 in the issue of Friday, May 1, 2020, make the following corrections:

1. On page 26058, in the first column, footnote 1056 should read “¹⁰⁵⁶The Commission recently adopted rules requiring registrants to include a hyperlink to each exhibit identified in

the exhibit index in any registration statement or report that is required to include exhibits under 17 CFR 229.601 (Item 601 of Regulation S–K) or under Form F–10 or Form 20–F. In connection with this rulemaking, commenters indicated that hyperlinking would make it easier and reduce the amount of time required for investors to navigate to related documents. See Exhibit Hyperlinks and HTML Format, Release No. 34–80132 (Mar. 1, 2017) [82 FR 14130 (Mar. 17, 2017)] at nn.85 and 86. In 2019, the Commission adopted amendments to its investment company registration forms, including Forms N–3, N–4, and N–6, to require hyperlinks to exhibits required to be filed with the registration statement. Safety Zone; Tug Kimberly Anne and Barge Big Digger Operating in the Straits of Mackinac, MI

AGENCY: Coast Guard, DHS.

ACTION: Temporary final rule.

SUMMARY: The Coast Guard is establishing a temporary safety zone for navigable waters within a 500-yard radius of a tug and barge in the Straits of Mackinac. The safety zone is needed

to protect personnel, vessels, and the marine environment from potential hazards created by the work, inspection, and surveying of underwater infrastructure. Entry of vessels or persons into this zone is prohibited unless specifically authorized by the Captain of the Port Sault Sainte Marie or their designated representative.

DATES: This rule is effective without actual notice from May 13, 2020 through October 30, 2020. For the purposes of enforcement, actual notice will be used from May 4, 2020 through May 13, 2020.
