**SUPPLEMENTARY INFORMATION:** The Vietnam Era Veterans’ Readjustment Assistance Act of 1974 (“VEVRAA”), 38 U.S.C. 4212(d), requires Federal contractors and subcontractors subject to the Act’s affirmative action provisions in 38 U.S.C. 4212(a) to track and report annually to the Secretary of Labor the number of employees in their workforces, by job category and hiring location, who belong to the specified categories of protected veterans. VETS maintains regulations to implement the reporting requirements under VEVRAA, and uses the VETS–4212 form for providing the required information on the employment of covered veterans. The regulations in 41 CFR part 61–300 require contractors and subcontractors with a covered Federal contract entered into or modified in the amount of \$150,000 or more to use the Federal Contractor Veterans’ Employment Report VETS–4212 form for reporting information on their employment of covered veterans under VEVRAA.

For additional substantive information about this ICR, see the related notice published in the **Federal Register** on November 20, 2020 (85 FR 74390).

This information collection is subject to the PRA. A Federal agency generally cannot conduct or sponsor a collection of information, and the public is generally not required to respond to an information collection, unless the OMB approves it and displays a currently valid OMB Control Number. In addition, notwithstanding any other provisions of law, no person shall generally be subject

to penalty for failing to comply with a collection of information that does not display a valid OMB Control Number. See 5 CFR 1320.5(a) and 1320.6.

**SUMMARY:** OSHA invites interested persons to submit nominations for membership on the National Advisory Committee on Occupational Safety and Health (NACOSH).

**DATES:** Nominations for NACOSH membership must be submitted (postmarked, sent, transmitted or received) by May 10, 2021.

**ADDRESSES:** You may submit nominations and supporting materials by one of the following methods:

OSHA will place comments and requests for a hearing, including personal information, in the public docket, which will be available online. Therefore OSHA cautions interested parties about submitting personal information such as Social Security numbers and birthdates.

**SUPPLEMENTARY INFORMATION:** The Secretary of Labor (Secretary) invites interested individuals to submit nominations for membership on NACOSH.

#### I. Background

The Occupational Safety and Health Act of 1970 (OSH Act) (29 U.S.C. 651, 656) established NACOSH to advise, consult with, and make recommendations to the Secretary and the Secretary of Health and Human Services (HHS Secretary) on matters relating to the administration of the OSH Act. NACOSH is a continuing advisory committee of indefinite duration.

NACOSH operates in accordance with the Federal Advisory Committee Act (FACA) (5 U.S.C. App. 2), implementing regulations (41 CFR part 102–3), the OSH Act, and OSHA’s regulations on NACOSH (29 CFR part 1912a).

The Committee shall meet at least two times a year (29 U.S.C. 656(a)(2)). Committee members serve without compensation, but OSHA provides

travel and per diem expenses. NACOSH members serve staggered terms, unless the member becomes unable to serve, resigns, ceases to be qualified to serve, or is removed by the Secretary. The terms of six NACOSH members expire on July 31, 2021.

## II. NACOSH Membership

NACOSH is comprised of 12 members, all of whom the Secretary appoints. Accordingly, the Secretary seeks six committed members to serve a two-year term. If a vacancy occurs before a term expires, the Secretary may appoint a new member who represents the same interest as the predecessor to serve the remainder of the unexpired term. The U.S. Department of Labor (Department) is committed to equal opportunity in the workplace and seeks a broad-based and diverse NACOSH membership. The Department will conduct a public records check of nominees before their appointment using publicly available sources.

Nominations of new members, or resubmissions of current or former members, will be accepted in all categories of membership. Interested persons may nominate themselves or submit the name of another person whom they believe to be interested in and qualified to serve on NACOSH. Nominations may also be submitted by organizations from one of the categories listed.

OSHA invites nominations for the following NACOSH positions:

- Two (2) public representatives;
- One (1) management representative;
- One (1) labor representative;
- One (1) occupational safety professional representative; and
- One (1) occupational health professional representative.

Pursuant to 29 CFR 1912a.2, the HHS Secretary designates both of the occupational health professional representatives and two of the four public representatives for the Secretary's consideration and appointment. OSHA will provide to HHS all nominations and supporting materials for the membership categories the HHS Secretary designates.

## III. Submission Requirements

Any individual or organization may nominate one or more qualified persons for membership on NACOSH. Nominations must include the following information:

1. The nominee's name, contact information, and current employment or position;
2. The nominee's resume or curriculum vitae, including prior

membership on NACOSH and other relevant organizations and associations;

3. The categories that the nominee is qualified to represent;

4. A summary of the background, experience, and qualifications that address the nominee's suitability for membership;

5. A list of articles or other documents the nominee has authored that indicates the nominee's experience in worker safety and health; and

6. A statement that the nominee is aware of the nomination, is willing to regularly attend and participate in NACOSH meetings, and has no conflicts of interest that would preclude membership on NACOSH.

OSHA will conduct a basic background check of candidates before their appointment to NACOSH. The background check will involve accessing publicly available, internet-based sources.

## IV. Member Selection

The Secretary of Labor will select six NACOSH members based on their experience, knowledge, and competence in the field of occupational safety and health (29 CFR 1912a.2). Nominees will also be evaluated in accordance with Secretary's Order 10-2020 (85 FR 71104) to ensure they are sufficiently financially independent from the Department programs and activities for which they may be called upon to provide advice. Information received through this nomination process, in addition to other relevant sources of information, will assist the Secretary of Labor in appointing members NACOSH. In selecting NACOSH members, the Secretary will consider individuals nominated in response to this **Federal Register** notice, as well as other qualified individuals. OSHA will publish a list of NACOSH members in the **Federal Register**.

**MATTERS TO BE CONSIDERED:** The Commission and Committee will meet to consider the effects of low salinity exposure on bottlenose dolphins. Specifically, meeting participants will review the findings of the Northern Gulf of Mexico bottlenose dolphin unusual mortality event (<https://www.fisheries.noaa.gov/national/marine-life-distress/2019-bottlenose-dolphin-unusual-mortality-event-along-northern-gulf>), provide information on the potential impacts of low-salinity exposure on dolphins and their prey, identify data needs, and discuss options for mitigating and monitoring impacts to dolphins and their prey from future low-salinity exposure.
