### Endangered and Threatened Wildlife and Plants; Draft Recovery Plan for White Fringeless Orchid

**AGENCY:** Fish and Wildlife Service, Interior.

**ACTION:** Notice of availability and request for public comment.

**SUMMARY:** We, the U.S. Fish and Wildlife Service, announce the availability for public review and comment of the draft recovery plan for the *Platanthera integrilabia* (white fringeless orchid), a plant listed as threatened under the Endangered Species Act. We request review and comment on the draft recovery plan
