SUMMARY: The Laboratory Division-RSU, Federal Bureau of Investigation, Department of Justice, will be submitting the following information collection request to the Office of Management and Budget (OMB) for review and approval in accordance with the Paperwork Reduction Act of 1995.

SUPPLEMENTARY INFORMATION: Written comments and suggestions from the public and affected agencies concerning the proposed collection of information are encouraged. Your comments should address one or more of the following four points:

- > Evaluate whether the proposed collection of information is necessary for the proper performance of the functions of the Federal Bureau of Investigation, Laboratory Division-RSU, including whether the information will have practical utility;
- > Evaluate the accuracy of the agency's estimate of the burden of the proposed collection of information, including the validity of the methodology and assumptions used;
- > Evaluate whether and if so how the quality, utility, and clarity of the information to be collected can be enhanced; and
- > Minimize the burden of the collection of information on those who are to respond, including through the use of appropriate automated, electronic, mechanical, or other

technological collection techniques or other forms of information technology, e.g., permitting electronic submission of responses.

Overview of This Information Collection

1. *Type of Information Collection:* New collection.

2. *The Title of the Form/Collection:* Law Enforcement Use of Geophysical Methods.

3. *The agency form number, if any, and the applicable component of the Department sponsoring the collection:* FBI IRB number 645–22. The applicable component within the Department of Justice is the Laboratory Division-RSU, Federal Bureau of Investigation.

4. *Affected public who will be asked or required to respond, as well as a brief abstract:* Federal Government, State, Local or Tribal Government. This questionnaire is to gather information from active and retired law enforcement on the applications of geophysical methodologies, such as ground penetrating radar (GPR) and magnetometers, to detect concealed targets (for example: homicide graves, drugs, or weapons) as part of criminal investigations. The respondents will give insight on who performed the geophysical surveys, the suspected targets, the survey environment, along with summaries of 1 to 3 geophysical surveys conducted. The results may be published and used to understand practical uses of geophysical methods for law enforcement investigations.

5. *An estimate of the total number of respondents and the amount of time estimated for an average respondent to respond:* We expect no more than 100 individuals completing the questionnaire. On average we expect an average of 10–15 minutes to complete the survey.

6. *An estimate of the total public burden (in hours) associated with the collection:* The estimated public burden associated with this collection is 25 hours.

DEPARTMENT OF JUSTICE**Notice of Lodging of Proposed Consent Decree Under the Clean Air Act**

On July 25, 2022, the Department of Justice lodged a proposed consent decree with the United States District Court for the District of Colorado in the lawsuit entitled *United States and State of Colorado v. DCP Operating Company, LP, et al.*, Civil Action No. 1:22–cv–01829–NRN.

The United States and the State of Colorado jointly filed this lawsuit under the Clean Air Act against Defendants DCP Operating Company, LP; DCP Midstream Holding, LLC; DCP LP Holdings, LLC; DCP Partners Colorado LLC; DCP Assets Holding, LP; and DCP Lucerne 2 Plant LLC, alleging violations of leak detection and repair requirements at seven natural gas processing plants in Colorado. The complaint seeks injunctive relief and civil penalties for the defendants' alleged failures to monitor and repair leaking equipment across the seven natural gas processing plants. The consent decree requires the defendants to perform injunctive relief to address the alleged violations, implement a mitigation project to help offset excess emissions caused by the alleged violations, and pay a \$3,250,000 civil penalty. The civil penalty will be split evenly between the United States and the State of Colorado.

The publication of this notice opens a period for public comment on the consent decree. Comments should be addressed to the Assistant Attorney General, Environment and Natural Resources Division, and should refer to *United States and State of Colorado v. Notice of Lodging of Proposed Modification of Consent Decree Under the Comprehensive Environmental Response Compensation and Liability Act

On July 1, 2022, the Department of Justice lodged a proposed Modification of Consent Decree with the United States District Court for the Western District of Pennsylvania in the lawsuit entitled *United States and the Territory of American Samoa v. Starkist Co. and Starkist Samoa Co.*, Civil Action No. 2:17 CV 01190–DSC.

The proposed Modification of Consent Decree pertains to a consent decree entered by the United States District Court for the Western District of Pennsylvania, Pittsburgh Division on March 7, 2018, (“Modification”), which resolved claims arising under sections 301(a) and 311(j) of the Clean Water Act, 42 U.S.C. 7412, sections 312 and 313 of the Emergency Planning and Community Right-to-Know Act, 42 U.S.C. 11022 and 11023, and section 3010 of the Resource Conservation and Recovery Act, 42 U.S.C. 6930, and the regulations promulgated under those statutes. The Modification would, among other things, require Starkist Co. and Starkist Samoa, Co. to achieve and maintain compliance with the effluent limits in its National Pollution Discharge Elimination System (NPDES) permit in an alternative manner than that set forth in the original consent decree.

Pursuant to 28 U.S.C. 50.7, the United States will publish a notice of the lodging of the proposed Modification of the consent decree in the **Federal Register**. The date that notice is published will open a 30-day period for public comment on the proposed Modification of the consent decree. Comments should be addressed to the Assistant Attorney General,

SUMMARY: NARA is proposing to request that the Office of Management and Budget (OMB) renew approval of an information collection our Office of Government Information Services (OGIS) uses to obtain customer intake information and consent as part of its mediation services program.
