They collaborate nationally with state falls prevention collaboratives and host the annual Age + Action Conference, a grantee gathering to explore solutions to ensure equitable aging for all, connecting with colleagues, sharing innovative ideas, and discussing policy solutions that can be achieved together on behalf of older adults.
