Robertson Power Company, LLC; Notice Extending Comment Period

On October 31, 2024, Robertson Power Company, LLC, filed an application for a preliminary permit, pursuant to section 4(f) of the Federal Power Act (FPA), proposing to study the feasibility of the Somersworth Mill Hydroelectric Project No. 15380-000 (project), to be located at the Somersworth Mill dam on the Salmon Falls River near the Town of Somersworth in Strafford County, New Hampshire, and Berwick, York County, Maine.

On October 15, 2025, the Commission issued public notice of the application and established December 15, 2025, as the deadline for filing comments, interventions, and competing applications. However, the Commission's October 15, 2025 notice was inadvertently not distributed to all parties required to be notified pursuant to the Commission's regulations [18 CFR

4.32(a)(2)]. Therefore, we are extending the deadline for filing comments, interventions, and competing applications until on or before 5:00 p.m. Eastern Time on January 5, 2026.
