### Fresh Mushrooms From Canada: Initiation of Less-Than-Fair-Value Investigation

### SUPPLEMENTARY INFORMATION:

#### The Petition

On September 16, 2025, the U.S. Department of Commerce (Commerce) received an antidumping duty (AD)

petition concerning imports of fresh mushrooms from Canada filed in proper form on behalf of the Fresh Mushrooms Fair Trade Coalition and its individual members (collectively, the petitioners), domestic producers of fresh mushrooms.<sup>1</sup> The AD Petition was accompanied by a countervailing duty (CVD) petition concerning imports of fresh mushrooms from Canada.<sup>2</sup>

Due to the lapse in appropriations and Federal Government shutdown, on November 14, 2025, Commerce tolled all deadlines in administrative proceedings by 47 days.<sup>3</sup> Additionally, due to a backlog of documents that were electronically filed via Enforcement and Compliance’s Antidumping and Countervailing Duty Centralized Electronic Service System (ACCESS) during the Federal Government shutdown, on November 24, 2025, Commerce tolled all deadlines in administrative proceedings by an additional 21 days.<sup>4</sup>

Between September 18 and September 24, 2025, Commerce requested supplemental information pertaining to certain aspects of the Petition in supplemental questionnaires.<sup>5</sup> Between September 23 and 26, 2025, the petitioners filed timely responses to these requests for additional information.<sup>6</sup>
