This addition to the Committee's Procurement List is effectuated because of the expiration of the DEPT OF THE NAVY, NAVFAC NORTHWEST, Base Operation Services, NAVFAC NW, West Sound, Bremerton, WA contract. The Federal customer contacted and has worked diligently with the AbilityOne Program to fulfill this service need under the AbilityOne Program. To avoid performance disruption, and the possibility that the DEPT OF THE NAVY, NAVFAC NORTHWEST will refer its business elsewhere, this addition must be effective on 2/1/2026, ensuring timely execution for a 2/1/2026 start date. The Committee published an initial notice of proposed Procurement List addition in the **Federal Register** on 11/20/2025 (90 FR 52358) but did not receive any comments. This addition will not create a public hardship and has limited effect on the public at large. Rather, this addition will create new jobs for other affected parties—people with significant

disabilities in the AbilityOne program who otherwise face challenges locating employment. Moreover, this addition enables the Federal customer to continue operations without interruption.
