Brown Bear II Hydro, Inc.; Notice of Reasonable Period of Time for Water Quality Certification Application

On September 8, 2026, the Maine Department of Environmental Protection (Maine DEP) submitted to the Federal Energy Regulatory Commission (Commission) notice that it received a request for a Clean Water Act section 401(a)(1) water quality certification as defined in 40 CFR 121.5, from Brown Bear II Hydro, Inc., in conjunction with the above captioned project on August 27, 2026.
