REGULATION 11 OF THE COTTON REGULATIONS

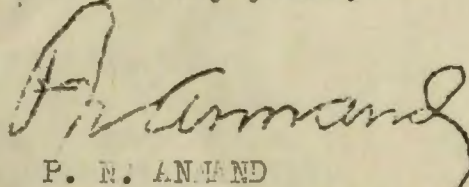
Gentlemen:

Attached hereto is a revised list of licensees authorized under the rules and regulations governing the importation of cotton and cotton wrappings into the United States to deal in, or to utilize in the manufacture of paper, or in other approved manufacture or treatment, certain classes of imported burlap as the equivalent of the disinfection required by Regulation 11.

In this list the license number of each firm precedes its name, and the symbol "ID" is used to denote an Importer or Dealer's license.

Should you desire to sell or distribute such burlap or other fabric to a firm whose name does not appear on this list, information as to whether or not the firm in question is licensed may be secured from this Bureau or from the inspectors of the Bureau in the enforcement of foreign plant quarantines at the several ports of entry, the latter being immediately advised of the issuance of licenses.
