ANIMAL CASINGS OF FOREIGN ORIGIN

Certificates required by B. A. I. Order 305 and instructions issued thereunder which bear the official title of the high official of the foreign country as specified below, will be acceptable with animal casings offered for importation into the United States.

The certificates must also bear the signature of the high official of the national government having jurisdiction over the health of animals in the foreign country in which the casings originated, but owing to the fact that the high officials are changed from time to time it is impracticable to publish their names.

ANIMAL CASINGS FROM EGYPT

The permission granted in Service and Regulatory Announcements of May, 1929, for the importation through foreign certification of animal casings from Egypt, is hereby revoked. All animal casings which leave Egypt on and after August 1, 1931, shall be disinfected as required by previous instructions as a condition for admission into the United States.

ANIMAL CASINGS FROM VENEZUELA

The permission granted in Service and Regulatory Announcements of October, 1927, for the importation through foreign certification of animal casings from Venezuela, is hereby revoked. All animal casings which leave Venezuela on and after July 1, 1931, shall be disinfected as required by previous instructions as a condition for admission into the United States.

EXPORT STAMPS FOR MEAT, MEAT FOOD PRODUCTS, AND HORSE MEAT

The bureau is informed that consignments of meat, meat food products, and horse meat are arriving in Sweden with some of the export stamps missing. As the stamps no doubt became detached in transit due to the careless manner in which they were affixed to the packages, attention of inspectors in charge and others is directed to the necessity of seeing that export stamps are securely affixed to withstand varying weather conditions, as contemplated by paragraph 2, section 1, regulation 24 of B. A. I. Order 211 (revised).

CERTIFICATION OF LARD FOR COLOMBIA

The bureau has been officially advised that the Government of Colombia, South America, now requires lard exported to that country to be accompanied by a special certificate in quadruplicate with the Spanish translation on the reverse side. Accordingly M. I. Form 121-E, which is now available for distribution, shall be issued in quintuplicate in the future for lard destined to Colombia, South America.

Both sides of each copy of the certificate should be fully executed and bear the signature of the inspector in charge. The fifth copy should be duly forwarded to Washington.
