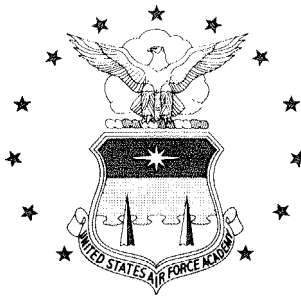

INTRODUCTION

This highly selective bibliography was prepared for use at the Tenth Military History Symposium on "The Home Front and War in the Twentieth Century" held at the United States Air Force Academy, 20-22 October 1982.

The resources cited were selected to show the impact of armed force on culture, economy, politics, and the social structure, as well as the vagaries of popular opinion and support on the domestic front. United States home front experience is emphasized, but works on other nations are also cited.
