Explanation

Words and figures inclosed in brackets [] are given for information, but do not appear on the title-pages of the publications catalogued. When size is not given, octavo is to be understood. Size of maps is measured from outer edge of border, excluding margin. The dates, including day, month, and year, given with Senate and House documents and reports, are the dates on which they were ordered to be printed. Usually the printing promptly follows the ordering, but various causes sometimes make delays. When Congress and session are not given with the number of Senate and House documents and reports, 62d Congress, 2d session, is to be understood.

GENERAL INFORMATION

The Superintendent of Documents is authorized to sell at cost any public document in his charge, the distribution of which is not otherwise provided for.

Documents can not be supplied by this Office free to individuals, **nor can they be forwarded in advance of payment.**

Documents entered in this catalogue that are for sale by the **Superintendent of Documents, Washington, D. C.**, are indicated by a star (*) preceding the price named. A dagger (†) indicates that application should be made to the Department, Bureau, or Division issuing the document, a double dagger (‡) indicates that the document is not obtainable, and whenever additional information concerning the method of procuring a document seems necessary it will be found under the name of the Bureau. The Senate and House documents and reports are issued in limited editions and, unless otherwise indicated, may be obtained only through Members of Congress.

In ordering a publication from the Superintendent of Documents give the name of the issuing Department, Bureau, or Division, and title. If publication is numbered give number also. Do not order by Library of Congress card number.

Read carefully the instructions "How to remit," found at the bottom of the next page.

The accumulation of publications in this Office amounts to over a million, of which several hundred thousand are assorted, forming the sales stock. Many rare books are included, but under the law all must be sold "at cost," regardless of their age or scarcity.

In ordering, it should be borne in mind that many of the books have been in stock some time and are apt to be shop-worn. In filling orders, however, the best copy available is sent.

No general price-list of public documents is available, but lists on special subjects will be furnished on application.

The Monthly catalogue is sent to each Senator, Representative, Delegate, and officer in Congress, to designated depositories and State and Territorial libraries, to substantially all Government authors, and to as many school, college, and public libraries as the limited edition will supply.

Subscription price to individuals, \$1.10 a year, including indices. Back numbers can not be supplied. Please notify the Superintendent of Documents of any change in address.

LIBRARY OF CONGRESS CARDS

Numbers to be used in ordering the L. C. catalogue cards will be found at the end of the titles of the more important monographic documents. The figure following the card number (separated from it by a slanting line) indicates the number of cards required for entries suggested (title entry not included) on the cards. The price of the cards is 2c. for the first card and $\frac{7}{16}$ c. for each additional card for the same title ordered at the same time. **Remittances should be made to the Librarian of Congress.** Cards can not be furnished by the Superintendent of Documents.

CUMULATIVE INDEX

Beginning with July, 1912, the Index to the Monthly catalogue will be issued semiannually instead of quarterly, as heretofore, and will cumulate for the twelve months ending June, 1913. That is, the December number will be an Index to the Monthly catalogue for July to December, 1912, and the June number will be the Index for the fiscal year 1913. Persons desiring to bind the catalogue at the end of the year should be careful to retain the numbers received monthly, as duplicate numbers can not be supplied.

HOW TO REMIT

Remittances for the documents marked with a star (*) should be made to the **Superintendent of Documents, Washington, D. C.**, by postal money order, express order, or New York draft. Currency may be sent at sender's risk.

Postage stamps, foreign money, defaced or smooth coins will positively not be accepted.

To facilitate the payment of the cost of documents, the Superintendent of Documents will hereafter accept coupons issued by him instead of cash. Coupons of the value of 5 cents each are sold in sets of 20 for \$1.00. Address order to Superintendent of Documents, Government Printing Office.

No charge is made for postage on documents forwarded to points in United States, Guam, Hawaii, Philippine Islands, Porto Rico, or to Canada, Cuba, or Mexico. To other countries the regular rate of postage is charged, and remittances must cover such postage.

NOTES OF GENERAL INTEREST

The director of the United States Geological Survey states that a careful examination of Water-supply paper 295 has disclosed errors so numerous and important that it is desirable to reprint the paper. It was prepared by the Geological Survey under a coöperative agreement with the State Water Commission and the State Conservation Commission of California and an understanding that it should be pushed rapidly. It therefore became necessary to dictate the text from maps to a stenographer temporarily employed, and thus errors which could not be detected in the manuscript or proof sheets resulted. The reprint has been ordered. The title of the publication is *Gazetteer of surface waters of California, Part 1, Sacramento River basin*.

House report 1127, 62d Congress, 2d session, in 3 parts, is the various reports of the Stanley special committee to investigate the Steel Trust. First there is the committee report, to which Messrs. Stanley, Bartlett, Beall, Littleton, and McGillicuddy subscribe. Then there is a separate statement by Mr. Littleton, another by Mr. Young, another by Mr. Sterling, and another by Mr. Gardner—five reports in all, but all are bound together in the latest print.

The Manufactures Bureau (now Foreign and Domestic Commerce Bureau) continues to issue new numbers in its attractive and useful Special agents series. No. 49 is Shoe and leather trade in the United Kingdom; no. 55, Electrical instruments in England; no. 59, Mining in the Federated Malay States. These 5 Federated States form one of the minor English protectorates and supply nearly the whole of the world's supply of tin, while rubber trees are successfully and largely cultivated. The special agent reports that the Federated States are enjoying a high degree of prosperity.

The Geological Survey's Professional paper 74, *Geology and ore deposits of the Butte district of Montana*, is a very elaborate work, with many illustrations, and the first one in this series to be issued in a permanent binding, a dark buckram being the material chosen. It would seem that papers of such authority and importance are worthy of a better dress than the paper covers in which they have been hitherto issued.

Director Page of the Public Roads Office has finally issued his report on Oil-mixed Portland cement concrete. This new form of concrete, which Mr. Page originated and which he has extensively tested, is damp-proof and has other valuable qualities peculiar to itself. A public patent has been taken out, thus preventing its ever being made the subject of a monopoly. Anybody is free to mix it by Mr. Page's formula and use it as may be found desirable. The report is published as Public Roads Office Bulletin 46 and is sold by the Superintendent of Documents at 10 cents.

The bill proposing to make moving picture films eligible to copyright is now a law.

Congress has ordered a reprint of 3,000 copies of the *Handbook of American Indians north of Mexico* (Ethnology Bureau Bulletin 30, 2 parts). Sold by the Superintendent of Documents for \$3.00 the set.

Senate bill 2371, introduced May 17, 1911, during the 1st session of the 62d Congress, and still pending, proposes to amend "sec. 3224 of the United States Compiled statutes." As the Compiled statutes is not a Government publication, and hence not subject to amendment by Congress, no doubt the publication intended is the United States Revised statutes. Sec. 3224 of that work provides as follows: "No suit for the purpose of restraining the assessment or collection of any tax shall be maintained in any court," and this is evidently the one which it is proposed to amend.

In the 62d Congress, 2d session, Senate document 902 is the speech of Senator Root notifying President Taft of his renomination and the President's speech accepting the same. Senate document 903 is Senator-elect James's speech notifying Governor Wilson of his nomination as a candidate for President and the latter's speech of acceptance. Senate document 904 is ex-President Roosevelt's speech at the 2d Chicago Convention known as the Confession of faith. All three are for sale by the Superintendent of Documents. 5 cents each.

The 17th general conference of the International Geodetic Association, which meets triennially, is to be held in Hamburg, Germany, in September of the present year. Superintendent Tittman of the United States Coast and Geodetic Survey will attend as delegate and will make a report on geodetic operations in the United States, 1909-1912, which will be published by the Survey.

There is a new edition of Patent laws with annotations, dated Aug. 1, 1912. 5 cents.

There is a 3d edition, with amended footnotes, of the Immigration laws and rules of Nov. 15, 1911. 10 cents.

Public health bulletin 55 is A word to ship captains about quarantine. On the cover it carries this legend:

Rats carry plague, mosquitoes carry yellow fever.

Plague and yellow fever cause quarantine.

Quarantine means expense.

Ship captains, destroy your rats and mosquitoes, and not only save your owners money, but save lives.

And on page 3 it carries in capital letters this variation of its theme:

No rats—no plague.

No mosquitoes—no yellow fever.

Vaccinate and—no smallpox.

Pure food, pure water, and cleanliness—no cholera.

No lice—no typhus.

These two legends give the substance of the book. The remainder is merely an amplification of them. The amplification is given in plain nontechnical English, describing the symptoms of the worst infections and telling the best ways to get rid of the vermin that carry them. 5 cents.

Reprint 88 from the weekly Public health reports is entitled The eradication and prevention of bubonic plague. For the sake of brevity a few comprehensive terms are used in it. The most notable of these, "deratization," is defined "to rid a certain area of rats." Plague is declared to be "primarily a disease of rodents, and secondarily and accidentally a disease of man." The only rodents affected thus far in this country are rats and ground squirrels. "Fleas carry it from rat to rat and from rat to man. No rodents, no plague."

Entomology Bureau Bulletin 115 has for general title Papers on deciduous fruit insects and insecticides. It is to be published in parts. The subtitle of Part 1 is Life-history studies on the codling moth in Michigan. The price of part 1 is 15 cents.

The 28th Annual report of the Bureau of American Ethnology, now in plate and about going to press, will contain, besides the Administrative report, 2

papers by Dr. J. Walter Fewkes, both reporting researches in Arizona, the first entitled Casa Grande, the other Antiquities of the upper Verde River and Walnut Creek, and one paper by Dr. Truman Michelson, Preliminary report on the linguistic classification of Algonquin tribes.

The Geological Survey has ordered printed the unusual number of 10,000 copies of a pamphlet on The production of natural gas in 1911 (calendar year), to be later reprinted as a chapter of the Mineral resources for that year. The same number has been ordered of the chapters on Petroleum production and The stone industry for 1911.

The custom of promptly sending a trained inspector to the scene of each railroad disaster for the purpose of looking into its causes and reporting thereon, and publishing his report for general information, is one of the best plans yet set afoot by the Interstate Commerce Commission. The reports thus far printed appear to be thorough-going, pointing out whether the employees are in fault because of neglect or incompetence or whether the railroad companies are in fault by supplying imperfect or obsolete or worn-out equipment or vague and indefinite rules. The disasters concerning which reports were published during August are those at Eastabuchie, Miss., May 6, 1912 (9 killed, 56 injured), and at East Corning, N. Y., July 4, 1912 (39 killed, 88 injured). The language of the reports, though positive, is restrained in tone, but the photographs of the wrecks are horrifying. If there is virtue in publicity, these reports should do something toward securing greater safety for the traveling public.

The First annual report of the Sales Agent of the Philippine Islands has been published at Manila. Mr. G. A. O'Reilly is the Sales Agent and he has written a report of 91 pages in which are many points of interest to American readers. In his effort to find markets and make markets for Filipino products he has visited the United States and Europe and has come to the conclusion that the Islands must look to this country for their chief market. "Handicrafts are practically unknown as American products," he says, "while the American handicraft market is the best in the world." Philippine products are mostly baskets, hats, mats, embroidery, lace, and other like handmade articles. "The Philippine Islands," he says, "at the present time represent the most favorable home-industry field in the world." He adds that "the temperament, training, and manner of life of the Filipinos peculiarly fit them for the favorable acceptance and development of home industries. Constant attention to small details constitutes for them a most pleasing occupation." Coupling this fact with what he calls "the extravagant purchasing power and tendency of the American people and the well defined modern American revulsion in taste in favor of expensive handmade goods as against those of a cheaper class made by machinery," he finds a hopeful prospect for Filipino handicrafts. The so-called "Bangkok" hat for men, sold in this country, is, he says, a Filipino product known in the Islands as the "buntal" hat. Filipino basketry, he declares, is unequalled, and industrial education is the great need of the Islands. Altogether the first report of the Sales Agent is an interesting document.

Examination papers for admission to the United States Naval Academy is the name of a Navy Department pamphlet which certifies on its title-page that it is "printed for general information." No young aspirant need suppose, however, that he can "cram" for an examination on this pamphlet. The questions given have all been used and will not be used again. They are of value only as giving an idea of the general character of the examinations. It does not take a long look at the questions to determine that they are "tough."

The State Department has very recently published Distribution of Alsop award by the Secretary of State; Opinion by Solicitor for the State Department. The so-called Alsop claim was made by the United States Government against the Government of Chile in behalf of the heirs of members of an American firm which did business in Valparaiso from 1820 to 1873. The award was made in favor of the American claimants by the King of England, acting as "*amiable compositeur*" (friendly adjuster) and was for \$906,666.78. Expenses of laying the case before the King, transferring the money, and sundries were \$43,173.78, leaving \$863,493.00 to be divided among the estates of the nine original claimants, who are all dead. The distribution apparently involved much computation, five of the estates receiving each $7\frac{1}{2}$ per cent. plus $\frac{1}{9}$ of $20\frac{1}{2}$ per cent, these fractions amounting in each case to \$71,957.41. The other dividends vary in amount but are all fractional.

A new bibliography from the Library of Congress is Select list of references on capital punishment. It has been compiled in coöperation with State and legislative reference librarians. The matter is gathered under three heads—General discussions, writings in favor of capital punishment, writings opposed to capital punishment. Both author and subject indexes are provided. Sold by the Superintendent of Documents at 10 cents.

House document 827, 62d Congress, 2d session, is the Congressional edition of Public health bulletin 51, The causation and prevention of typhoid fever, with special reference to conditions observed in Yakima County, Wash. This bulletin bears date Nov. 1911, but was first actually published in Feb. 1912, and a 2d edition in July, 1912. By concurrent resolution, Congress has ordered a special edition of 50,000 copies. It is under this resolution that House document 827 is published. It is distinctively a bulletin for popular circulation. It describes in the plainest terms the methods of transmission of the typhoid parasite and the measures that should be taken to check such transmission. No person of ordinary intelligence need remain in doubt about these things after reading Public health bulletin 51. Sold by the Superintendent of Documents at 20 cents.

Senate simple resolution 282, agreed to Aug. 14, 1912, is quite indefinite, providing merely "that the manuscript of the laws, agreements, executive orders, proclamations, etc., relating to Indian affairs, be printed as a Senate document." Though the resolution is indefinite, the action to be taken under it will be definite. The work to be published by authority of Senate resolution 282 will be a 3d volume of Kappler's Indian affairs, laws and treaties, the new compilation having been made by Mr. Kappler. His vols. 1 and 2 were published in 1902 and a 2d edition in 1904. Vol. 3 will contain such material as has accumulated since 1902. Whether provision has been made for the printing of copies additional to the "usual number," which alone can be printed under the resolution, is not known at the date of this writing.

House report 1021, 62d Congress, 2d session, from the Committee on Military Affairs, on the status of Army officers in aviation service, recommends that officers detailed or volunteering for aviation duty have their pay doubled, because of the great risk incurred, and states that insurance companies refuse to insure officers engaged in this duty and cancel the policies of those already insured. The Committee say also that "the importance of developing in the Army the science of aviation is obvious and cannot be too strongly insisted upon."

The 6-page document listed in this catalogue under the heading President of the United States is the Memorandum which the President sent to Congress with his approval of the Panama Canal bill. It has been cabled to Europe

and much commented on in foreign countries as well as at home. It does not, however, appear anywhere in the Congressional record, nor has it been printed as a Congressional numbered document. The only print of it is in a very limited edition made for the use of the White House.

Apr. 9 last the law providing for the establishment of a Children's Bureau in the Commerce and Labor Department was approved by the President, and Apr. 17 he appointed Miss Julia C. Lathrop of Illinois to be its chief. Her appointment was confirmed by the Senate Apr. 23—more than 4 months ago—but the Bureau has not been able to progress for want of an appropriation. This was finally provided by the legislative, executive and judicial appropriation bill, which became a law Aug. 23, and the new Bureau is now going ahead. The provision made is of \$5,000 salary for the chief and she has the aid of an assistant chief, a statistical expert, a private secretary, 7 clerks, 2 special agents, a copyist, and a messenger, 15 in all.

The report on the Lawrence, Mass., strike of textile workers, made for the commissioner of labor by Mr. Fred C. Croxton, has been published as Senate document 870, 62d Congress, 2d session. It is an important document of 511 pages.

The new law known as Public—no. 301 makes important amendments to the Food and drugs act of June 30, 1906, usually known as the Pure food law.

The Post Office Department appropriation act provides for a new edition of Postal laws and regulations, 110,000 copies to be printed, 105,000 for the Department and 5,000 to the Public Printer for sale.

Farmers' bulletin 510 is Game laws for 1912. 5 cents.

Bulletin 52, Bureau of American Ethnology, title, Early man in South America, is now ready at 70 cents in cloth. It is a work of 405 pages, 68 plates, and 51 text figures. It presents the results of personal researches by Dr. Aleš Hrdlička, anthropologist, and Dr. Bailey Willis, geologist, and is generally adverse to the hypothesis of the great antiquity of man.

NEW LAWS

The number of laws enacted at the recent Congressional session, which closed Aug. 26, is unusually large. All are for sale by the Superintendent of Documents in the separately printed form, each law, no matter how brief, being a distinct publication. This is the first form in which the new laws are printed, and in this form they are known as "slip laws." The price is 5 cents each, or \$1.00 for the whole set for the 2d session of the 62d Congress, which began Dec. 4, 1911, and ended Aug. 26, 1912.

In the slip-law print each public law is numbered in one series, each private law in another series, and the public and private joint resolutions are similarly arranged. Private laws are those which are passed for individual benefit, as granting a pension, increasing a pension, or granting some kind of claim.

The numbers of some of the public laws which are most often called for are:

- 155. New pension law.
- 238. Requiring wireless apparatus and two operators on passenger steamers on ocean and Great Lakes.
- 241. River and harbor appropriation act.
- 264. Regulating radio communication.
- 290. Naval appropriation act.
- 299. Legislative, executive, and judicial appropriation act.
- 301. Amending pure food law.
- 302. Sundry civil appropriation act.
- 303. Amending copyright law.

- 320. Fur seal convention with Great Britain, Japan, and Russia.
- 334. Act to create a legislature in Alaska.
- 335. Indian appropriation act.
- 336. Postal appropriation act, containing provision for a parcel post, creating a Congressional joint commission to further investigate and report on parcel post, and granting to Government employees the right to organize and to petition and protecting them from removal except after reasons given in writing and opportunity granted for reply.
- 337. Panama Canal act.
- 338. Army appropriation act.
- 340. Deficiency appropriation act.

The first collected and bound edition of the laws of the recent session will appear in a month or two in a pamphlet having for title "Statutes of the United States of America passed at the second session of the 62d Congress." These pamphlets, which are issued after each session of Congress, are usually called Pamphlet laws or Session laws. The next and permanent form will be in the leather-bound volume entitled Statutes at large. This will not be issued till the conclusion of the 62d Congress, which has still another session to serve, and will contain all the laws of that Congress, whether passed at the 1st, 2d, or 3d session.

BANKRUPTCY LAWS

As the Constitution makes a special grant to Congress of the right to establish "uniform laws on the subject of bankruptcies throughout the United States," it was natural enough that a correspondent should ask the Superintendent of Documents for copies of all the bankruptcy laws *prior* to the one now in force. The required material having been supplied to the correspondent, the information is herewith passed along to others who may need it.

The 1st bankruptcy law was approved Apr. 4, 1800, and by its terms was limited to a duration of 5 years, but did not last that long, having been repealed Dec. 19, 1803.

The 2d bankruptcy law was approved Aug. 14, 1841, to take effect Feb. 1, 1842, and was repealed Mar. 3, 1843, having lasted little more than one year.

The 3d bankruptcy act became a law Mar. 2, 1867, and was repealed in 1878, having become odious because of abuses practised under it.

The 4th bankruptcy law became effective June 1, 1898, and is still in force, though it has been extensively amended.

COMMITTEE PUBLICATIONS

Though claims of American citizens and their descendants against the Government of the United States for reparation because of illegal seizures of American merchant vessels by French privateers and vessels of war during the years 1790-1800, have been pending before Congress for more than a hundred years, and before the Court of Claims for more than 25 years, but little is generally known of them. Everybody has heard of the French spoliation claims, but knowledge seldom goes beyond the mere title.

Four recent publications of the House War Claims Committee supply much information and also give references to old-time documents in which more information may be found. Three times Presidents have vetoed these claims and their vetoes are discussed in the Committee's Memorandum as to French spoliation claims, a thin volume bound in buckram. The three veto messages, of 1846, 1855, and 1896, have been published by the War Claims Committee in one pamphlet. The second pamphlet published by this committee is entitled

French spoliation claims: Epitome. Its 4th publication is a bound volume of 628 pages containing the Opinions of the Court of Claims in French spoliation cases, 1886 to 1911, and Digest of opinions. The Opinions fill 587 pages, the Digest 41 pages. The four publications present virtually the whole literature of the subject.

The Senate Claims Committee has printed A review of the history of the French spoliation claims and some of the principles of international law applying to them; and also A condensed report of the findings of the Court of Claims. The latter gives a list of 131 claims that have been acted upon by the Court of Claims, and statements of the findings of the Court.

Of course these historical reviews and finding lists relating to cases which have a history going back to the infancy of the Republic will be desired by all the large libraries at least and probably also by many of the smaller collections.

It is doubtful whether any will be able to get them. They are not in the class of numbered Congressional documents of which a library allotment is printed. They are unnumbered publications "printed for the use of the committee." The whole number printed goes to the Committee and the Committee has unlimited control of the entire edition. There are no copies set apart for distribution to libraries and none provided for sale. The only chance to get them is from the chairman or some other member of the committee, and as the number printed is usually small and soon exhausted and as few committees are organized for the orderly preservation of surplus documents, it thus comes about that at every session many documents really of permanent value are compiled, printed, given temporary use, and then disappear, leaving no trace behind.

One of the most urgently needed economies in the publishing work of the Government is provision for the regular supply of hearings and other Committee publications to libraries which would give them permanent preservation and make them accessible to the reading and studying and compiling public.

OF ESPECIAL INTEREST TO LIBRARIANS

The Treasury Department bureau known formerly as the Marine Hospital Service and recently as the Public Health and Marine-Hospital Service has within the last month become, by virtue of a new legal provision, the United States Public Health Service. Its activities have so expanded in recent years that the care of the marine hospitals has become but a minor part of them. The Public Health Service is one of the most prolific publishers among the Government bureaus and its publications are in active demand. Its weekly magazine, Public health reports, is in its 27th annual volume, and 89 articles from it have been separately printed in pamphlets known as "separates." Its bulletins from the Hygienic Laboratory number 84 and those from the Yellow Fever Institute 17. In the series called Public health bulletins there are 53 separate publications. The Annual reports of the Service began in 1872. Quarantine regulations and other official publications further swell the list.

The Bureaus of Manufactures and of Statistics, Commerce and Labor Department, have been consolidated, the resulting enlarged bureau having received the title Bureau of Foreign and Domestic Commerce. Chief Baldwin of the former Manufactures Bureau becomes chief of the new bureau and Chief Austin of the former Statistics Bureau becomes Assistant Chief. Former Assistant Chief Brand of the Manufactures Bureau is retained as an additional assistant chief of the new bureau. Both of the consolidated bureaus have been active publishers of popular documents.

The separate numbered prints of the Opinions of the Interstate Commerce Commission began with Opinion 1994 the improved practice of printing with the Opinion the Order which is promptly issued for the carrying out of the Opinion.

Hereafter the annual reports of the superintendent of the United States Coast and Geodetic Survey will be purely administrative in character. The results of the work of the Survey and other scientific papers which it may find advisable to print will be issued as separate publications.

Foreign tariff notes no. 7, Manufactures Bureau, carries a cumulative index to nos. 1-7. No. 1 was issued in Dec. 1910. The series contains much convenient and practical information for all who are interested in the export trade.

Through the operation of sec. 3, Public—no. 338, An act making appropriation for the support of the Army for the fiscal year ending June 30, 1913, Pay Department, Quartermaster's Department, and Subsistence Department disappear as author headings from the Catalogues of United States public documents, and their respective chiefs, the Paymaster General, the Quartermaster General, and the Commissary General, presumably disappear from the monthly Army list and directory and from the annual Army register. The first two sentences of sec. 3 read thus: "That the office establishments of the Quartermaster General, the Commissary General, and the Paymaster General of the Army are hereby consolidated and shall hereafter constitute a single bureau of the War Department, which shall be known as the Quartermaster Corps, and of which the Chief of the Quartermaster Corps created by this act shall be the head. The Quartermaster's, Subsistence, and Pay Departments of the Army are hereby consolidated into and shall hereafter be known as the Quartermaster Corps of the Army."

Few citizens are more interested than librarians in the establishment of a parcel post. The provisions for its establishment are found in the Post Office Department appropriation act, technically known as Public—no. 336, 62d Congress, 2d session, sec. 8, beginning on page 20. It provides for a system of zones of distance and rates for weight which will need to be mapped, computed, and tabulated by experts before the ordinary wayfarer can see his way clearly through them. The limit of weight is 11 pounds and of size six feet in length and girth combined. A large discretion is given the Postmaster General as to changing zones or weight limit and a joint Congressional committee is created to make further inquiry into the general subject of parcel post. The zone and rate provisions of sec. 8 do not become effective till Jan. 1, 1913.

Congress adjourned without making an appropriation for the continuance of the Tariff Board, but allotted \$75,000 for the continuance of the work of the President's Efficiency and Economy Commission, adding a condition that a report shall be made to Congress on or before Dec. 31, 1912.

Sec. 8 of the legislative, executive, and judicial appropriation bill (Public—no. 299) provides that the mailing work on public documents of all kinds shall be concentrated in the Government Printing Office instead of being, as now, scattered through numerous Departments and bureaus. This does not mean, however, that applications for free copies should be sent to the Public Printer or the Superintendent of Documents. Such applications should go, as heretofore, to the various publishing offices, by which mailing lists or directed franks will be supplied to the Printing Office. It is only the mechanical work of the distribution—that is transferred, not control of the distribution otherwise. So far as the libraries and the general public are concerned, the transfer will not make any perceptible difference.

The appropriation made by Congress for the Commerce Court will keep it alive only till Mar. 4, 1913.

The Foreign and Domestic Commerce Bureau has issued a circular stating that as no appropriation has been made for the publication of the report known as Monthly summary of internal commerce, it has been discontinued, the number for June, 1912, being the last.

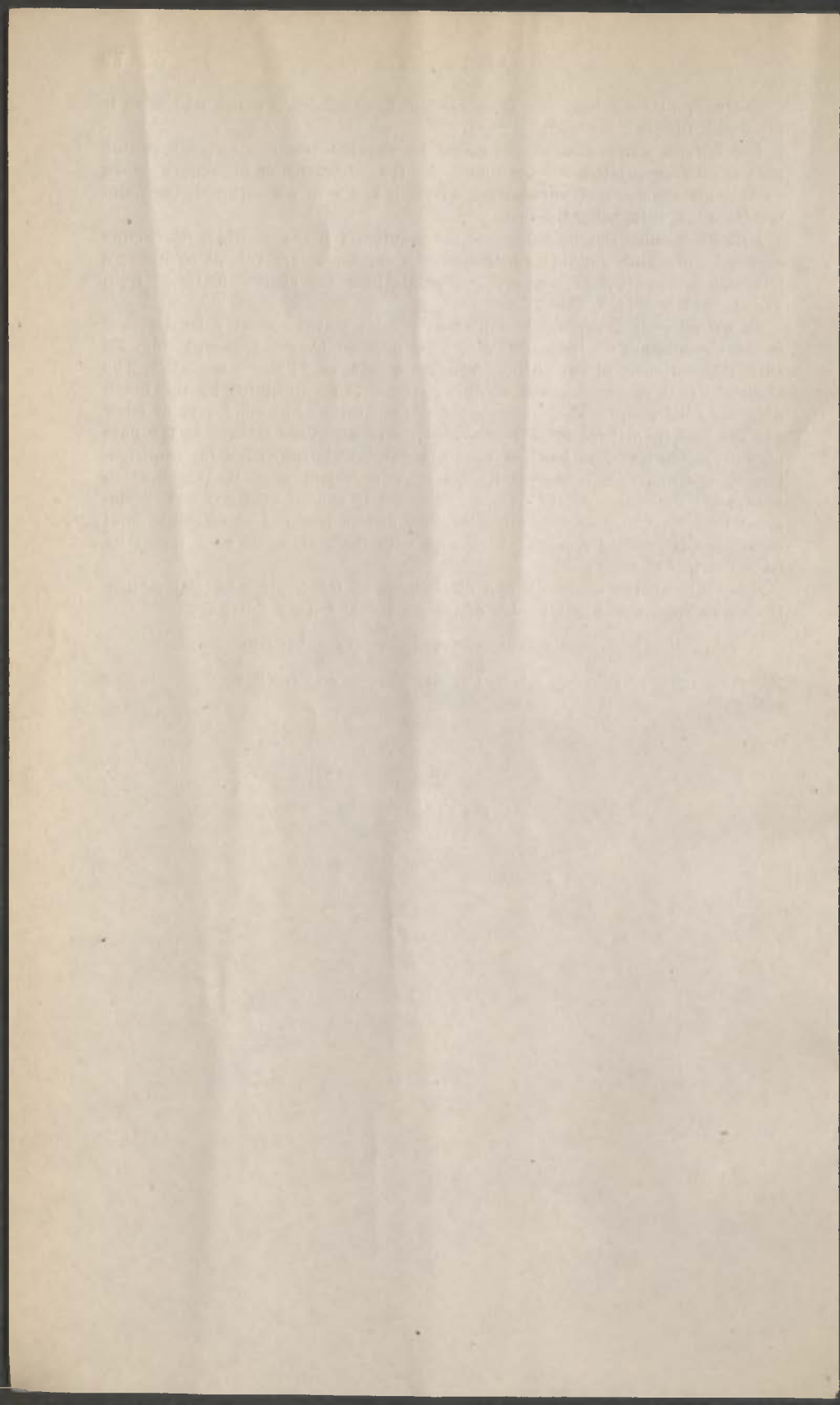
Aug. 16, Senator Cullom submitted a resolution (simple no. 378), which was agreed to, providing for the preparation of a supplementary volume to Malloy's 2-volume compilation of treaties, etc., to include the similar material from Jan. 1, 1910, to Mar. 4, 1913.

An official body from which important reports may reasonably be expected is the Commission on Industrial Relations, created by act approved Aug. 23, 1912, this act being known in its first printed form as "Public—no. 300." The Commission is to be composed of nine persons, to be appointed by the President and confirmed by the Senate, not less than three to be employers of labor and not less than three to be representatives of organized labor. At the date of writing the members had not been appointed. The provision for confirmation by the Senate will necessarily delay the organization of the Commission until some time next winter. It is authorized to submit evidence and recommendations to Congress from time to time and is required to make its final report not later than Aug. 23, 1915, and with the making of such report its official term will expire.

A bulletin on the migration and distribution of the North American herons is soon to appear as a publication of the Biological Survey Bureau.
