MONTHLY CATALOG ONLINE

Librarians often ask about the possibility of obtaining online access to the "Monthly Catalog of United States Covernment Publications." GPO does not preserve supply this service. However, a number of connercial vendors purchase the "Month Catalog" on magnetic tape from the Library of Congress' Cataloging Distribution Service. Two that have come to our attention are Lockheed and BRS. There are undoubtedly others; and local inquiry should identify a vendor in your area.

LIST OF DEPOSITORIES RETURNS

Users of the "Monthly Catalog" are no doubt discovering the special bonus in the issue for October 1981, Shipping List 16,879, February 5, 1982. It is the "List of Depository Libraries" which is returning as a regular feature. You will see it again in October 1' 2, and each October issue the officer.

FBIS PUBLICATION WITHDRAWN

We have been advised by Philip A. Carnone, Chief of Liaison and Requirements Branch, Foreign Broadcast Information Service, that the publication "Trends in Corrunist Media" is being withdrawn from public circulation. The issue doted July 1, 1981, will be the last issue sent to GrO for the Depenitory Library Program. This decision of FEIS will not affect the continuing circulation of the FBIS Daily Report and JPRS serials.
