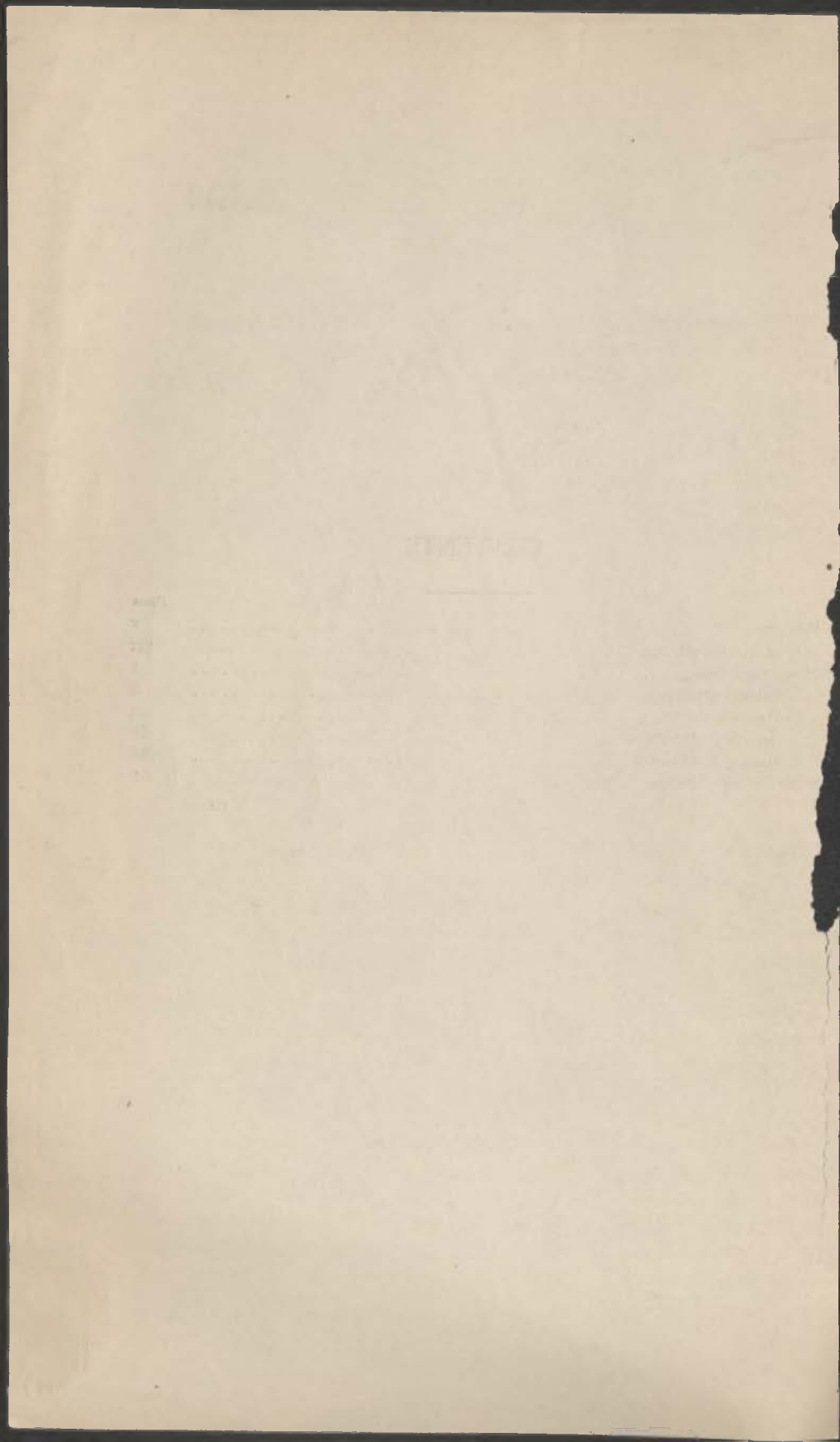

PREFACE

The Numerical lists and schedules of volumes of reports and documents of the second session of the Seventy-fourth Congress herewith presented consists of numerical lists and a schedule of volumes similar to those formerly included in the Document index which has been discontinued. Previously the schedule of volumes was also issued preliminary to the Index.

The documents included in the Numerical lists and schedule of volumes number 2515, divided as follows: Senate reports, 995, nos. 1462-2456 (nos. 776, 944, 1156, 1251, and 1252 are parts of reports of the Seventy-fourth Congress, first session, and are not included in the total figure); House reports, 1179, nos. 1909-3087 (nos. 35, 1675, and 1907 are parts of reports of the Seventy-fourth Congress, first session, and are not included in the total figure); Senate documents, 137, nos. 140-276; House documents, 204, nos. 311-514.

Serial number 9981 is assigned to the Senate Journal and number 9982 is assigned to the House Journal of the second session of the Seventy-fourth Congress.

The bound set (both *numbered* and *lettered* volumes) of congressional reports and documents, listed in the Schedule of volumes, p. 61, represents a set which is distributed only to the Senate and House libraries, the Library of Congress, and the Office of the Superintendent of Documents; heretofore the *numbered* volumes were also sent to the international exchanges, but beginning with the first session of the Sixty-ninth Congress the international exchanges take the same binding and distribution of all volumes as the depository libraries. Although this complete bound set is not sent to depository libraries and international exchanges as such, all publications included in the *numbered* volumes thereof are received by them, but in a slightly different form, if selection has been previously made under the provision of continuing legislation which was first authorized by Public Act 171, Sixty-seventh Congress, approved March 20, 1922. The annual and serial publications of the departments, bureaus, and independent establishments of the Government are sent without the congressional document numbers on the title pages and in the binding used by the office issuing them; the other publications are sent bound in volumes corresponding to those listed in the schedule, but without series volume number title pages. The *lettered* volumes contain only

reports on private bills and private joint resolutions and on simple and concurrent resolutions. These volumes are not sent to depository libraries and international exchanges, as under the provisions of the act of January 20, 1905, only a limited number of such reports can be printed.

For the benefit of those libraries desiring to keep the serial arrangement, the serial numbers will be printed upon strips which will be furnished, on request, to designated depositories and international exchanges for attachment to the bound books.

The publications scheduled to be bound in volumes 19-21 of the Senate documents and in volumes 15-54 of the House documents of this schedule, are annual or serial publications which will be sent to depository libraries and international exchanges without congressional document notation and in the binding used by the issuing office. These publications will not carry serial numbers as listed in the schedule.

The omission of their volume number in the congressional set from the bound volumes of congressional documents and reports distributed to depository libraries was authorized, on recommendation of the Public Printer, by a regulation adopted by the Joint Committee on Printing May 21, 1924. The change authorized by this regulation was inaugurated with the binding of the documents and reports of the first session of the Sixty-eighth Congress. On December 10, 1925, the regulation of May 21, 1924, was amended by the Joint Committee on Printing so as to include those volumes sent to the international exchanges, and the change was made with the first session of the Sixty-ninth Congress. The omission of this volume title page, inaugurated with the Sixty-eighth Congress, makes possible the immediate binding and delivery of all publications large enough to be bound separately.

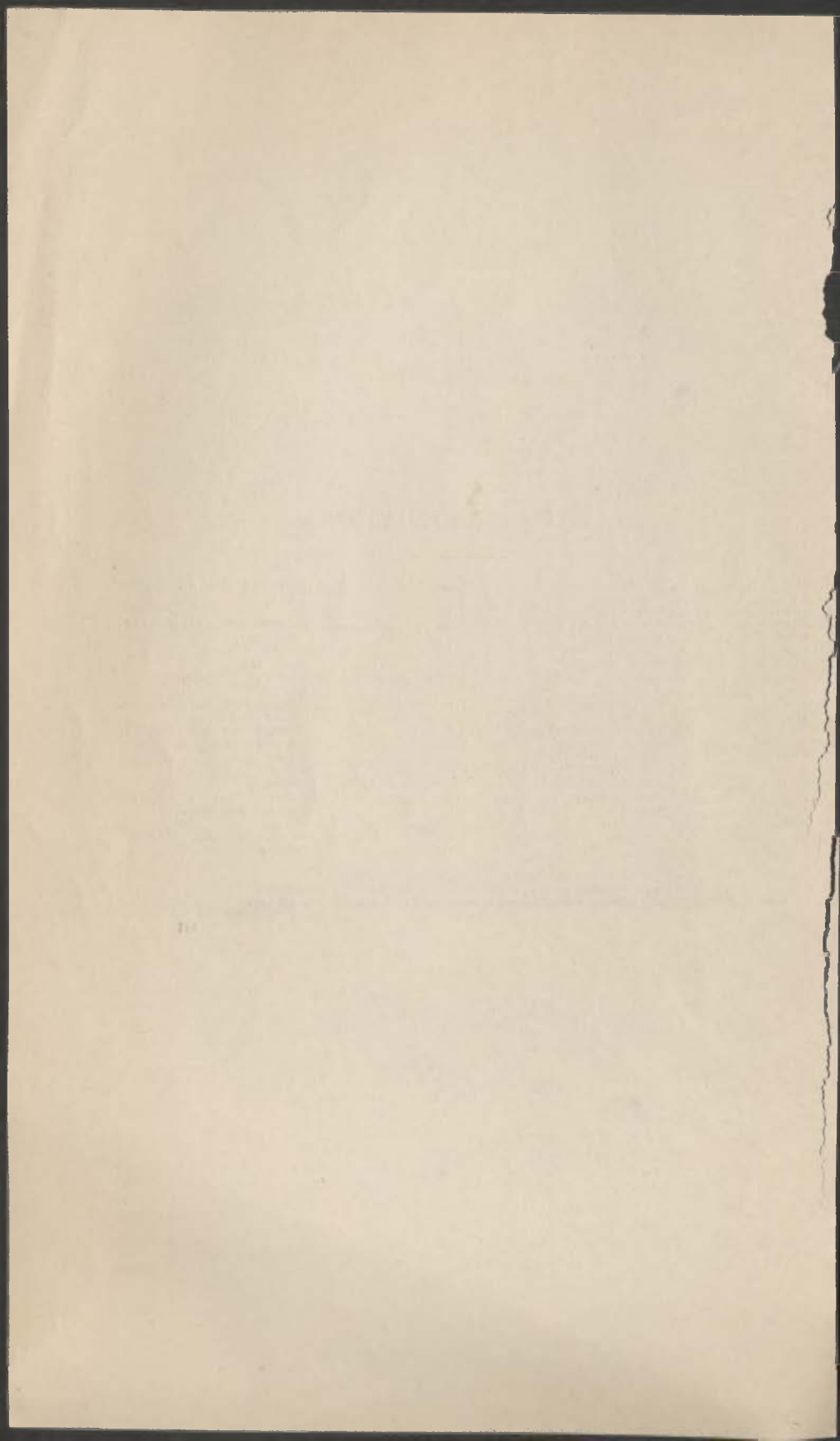

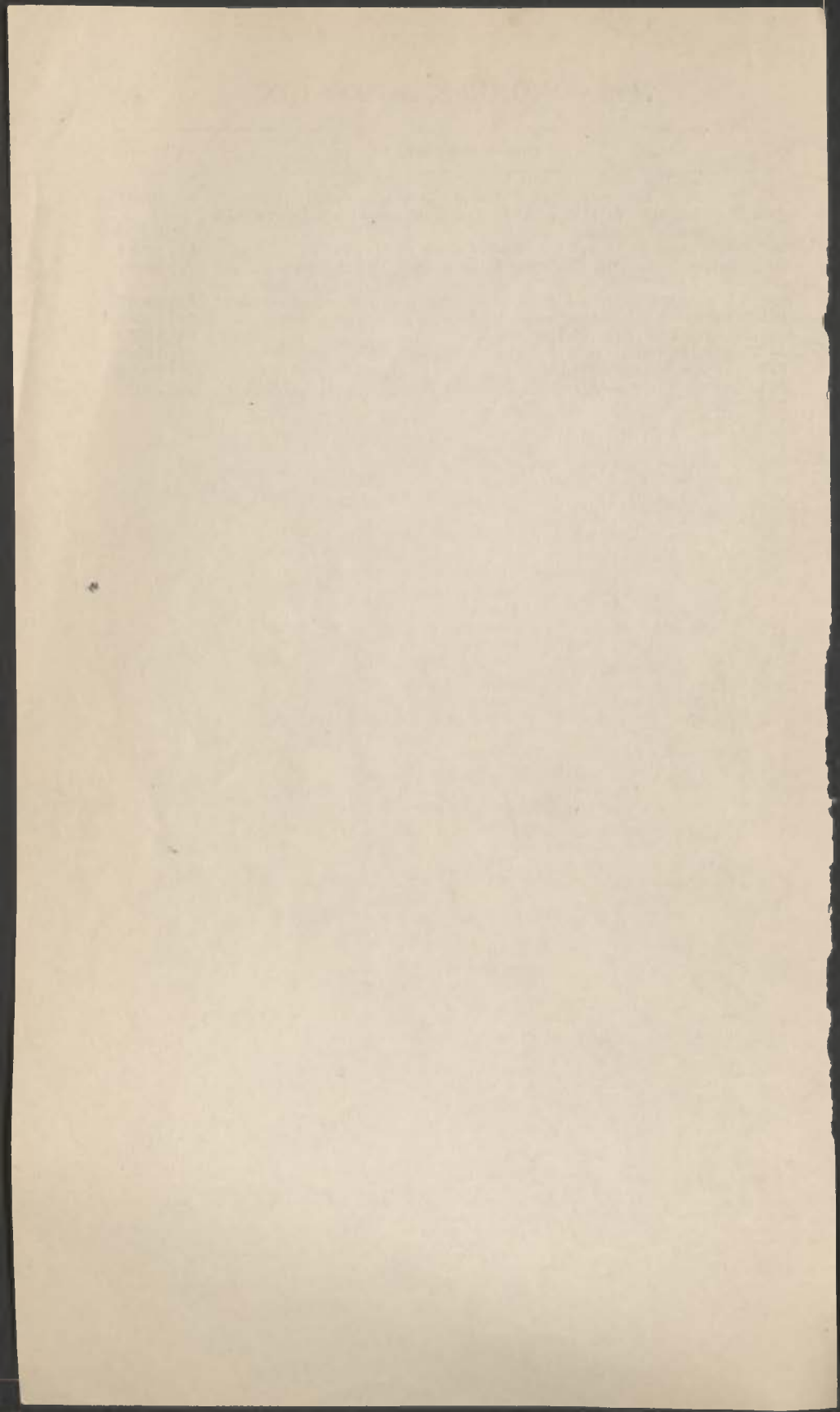
