

Biennial Survey of Depository Libraries, 2003

Introduction

The 2003 Biennial Survey of Depository Libraries was sent to nearly 1,300 depository libraries participating in the Federal Depository Library Program from November 5 through December 5, 2003. The survey was conducted online via World Wide Web. This report, a compilation of the results, is available at http://www.access.gpo.gov/su_docs/fdlp/bisurvey/index.html.

The purpose of the Biennial Survey is to report on conditions in the depository libraries. Required by law (44 USC §1909), the Biennial Survey gathers data from all the depository libraries every 2 years, supplementing the more in-depth inspections or self-studies that are performed every 6 or 7 years.

Some responses were incomplete and could not be tabulated. Percentages may not add up to 100 in all cases because of rounding, answers left blank, and multiple answers. Four libraries indicated they did not intend to remain depositories and did not complete the survey. The final number of completed responses was 1278.
