New York Yankees Baseball Club, 745 Fifth Avenue, New York, Telephone No. Plaza 9-5300, came to the Cleveland Office and furnished the following letter which was received by MICKEY MANTLE on the previous day. Instant letter was postmarked to MICKEY MANTLE, c/o Cleveland Municipal Stat. Clev Ohio. Envelope had a one cent postage due.

The letter, which is handwritten in ink, is as follows:

"I had a son that was drafted with a bad leg & bad eyes he got killed but a rotten draft dodger that could run like you gets turned down. I have a gun with microscopic lenses and I'm going to get you thru both of your knees and its going to happen soon."

MANTLE, STENGEL, [REDACTED] interviewed and all state they have no suspects. MANTLE advised he receives numerous prank letters, but this is the first of a threatening nature. All advised that they desired that this letter and the nature of it be kept confidential. b7C

On 7/20/60 coverage was afforded by this office at the Cleveland Stadium for the night game and the Stadium Police were alerted; however, MANTLE and [REDACTED] were advised the FBI cannot furnish bodyguard or police protection. MANTLE stated that he would advise the FBI if any other threatening letters were received.

USA, Cleveland has requested that letter be sent to the FBI Laboratory for examination and investigation be made at Tonawanda, New York, before he renders a prosecutive opinion.

The FBI Laboratory is requested to conduct a handwriting examination through a search of the Anonymous Letter File.

###### AT BUFFALO, N.Y.:

Will determine from the Buffalo Police Department if they have any suspects who have written threatening letters in the past to well-known persons or prominent sports figures.

###### AT TONAWANDA, N.Y.:

Will make a similar investigation at the Tonawanda Police Department as requested above.

Will contact the local draft board covering Tonawanda to determine if they could possibly identify the person in the letter who was allegedly killed in the Armed Forces and who had a bad leg and bad eyes.

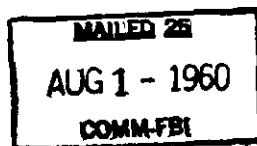

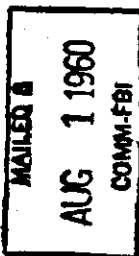

could run like you gets turned down. I have a gun with  
microscopic lenses and I'm going to get you thru both of  
your knees and its going to happen soon."

b7C [REDACTED] furnished the letter and envelope to SA  
[REDACTED]. He stated that he had no suspects in this  
matter, but he did state that MANTLE was upset about the letter,  
and that a number of the men on the baseball club had handled  
the letter and envelope.

[REDACTED] stated that he desired that no publicity  
be given this letter as he feared that if it should receive  
publicity a rash of other letters would be received by the  
Yankee players.

The envelope of this letter was addressed to "MICKEY  
MANTLE, c/o Cleveland Municipal Stad., Clev Ohio," and it was  
postmarked at Tonawanda, New York, on July 18, 1960, at 8:30 AM.

MICKEY MANTLE, New York Yankee Baseball player, was interviewed in the locker room at the Cleveland Municipal Stadium prior to the night baseball game. MANTLE stated that he received the threatening letter at the Stadium on the previous day and, after reading it, he turned it over to [REDACTED]. MANTLE stated that he does not have any suspects as to the sender of the letter and, as far as he can recall, he does not have any acquaintances in Tonawanda, New York. He stated that this is the first threatening letter that he has ever received and he is quite concerned about it. MANTLE stated that he has been thinking about the letter and about getting shot by some crank and, in his opinion, if he were to get shot it would be in Yankee Stadium, as some person could stand on the rooftop on one of the buildings surrounding Yankee Stadium and take a shot at him. MANTLE stated that he does receive a lot of fan mail, both laudatory and critical, but this is the first really bad or disturbing letter which he has ever received.

MANTLE was advised that the FBI could not furnish any bodyguard or police protection for him; however, in the event that he does receive additional threatening letters, he should immediately report the matter to the FBI.

On July 20, 1960, CASEY STENGEL, Manager, New York Yankees Baseball Club, was interviewed at the Cleveland Municipal Stadium by SA [REDACTED] and SA [REDACTED]. STENGEL advised that MANTLE had advised him on the previous day of the receipt of the threatening letter. He stated that he, himself, has received a number of crank letters. In fact, he receives numerous crank letters all of the time in that the senders of these letters are complaining about how he runs the Yankees ball club. STENGEL related that he has not received any threatening letters, and he has no suspects as to the person who may have sent MANTLE the letter.

On the same date, [REDACTED] were contacted concerning the threatening letter, which was received by MANTLE, and all of the stadium police were alerted before the beginning of the night game, and they were all cautioned to keep this investigation confidential.

On the same date, the following Special Agents covered the various entrances of the Cleveland Municipal Stadium to be on the alert for any suspicious persons who may have been carrying firearms to the baseball game: SAs [REDACTED]

b7C [REDACTED] No incidents occurred at the stadium or at the game.

On July 21, 1960, Assistant United States Attorney WILLIAM J. O'NEILL, Federal Building, advised that he desired that the threatening letter be sent to the FBI Laboratory for examination and that investigation be made at Tonawanda, New York, before he renders a prosecutive opinion.

No description was obtained from MANTLE due to the fact that his description is well known and readily available.

By letter dated August 1, 1960, the Laboratory advised that the envelope and letter received by MANTLE was searched in the Anonymous Letter File without effecting an identification.

On September 29, 1960, this matter was again discussed with Assistant United States Attorney O'NEILL by SA [REDACTED]. Mr. O'NEILL stated that he desired no

further investigation be conducted in this matter inasmuch as investigation conducted by the Buffalo Office at Tonawanda, New York, and examination of the envelope and letter by the FBI Laboratory had failed to develop any suspects.

**MICKEY MANTLE**

Mickey Mantle, former well-known baseball player of the New York Yankees, has not been the subject of an investigation by the FBI. However, our files reveal that information received in June, 1956, indicated that Mickey Mantle was "blackmailed" for \$15,000 after being found in a compromising situation with a married woman. Mr. Mantle subsequently denied ever having been caught in a compromising situation. Mr. Mantle readily admitted that he had "shacked up" with many girls in New York City, but stated that he has never been caught. (139-243)

A confidential source, who has furnished reliable information in the past, advised in June, 1957, that a very prominent Washington, D. C., area gambler and bookmaker arranged dates for members of the New York Yankees baseball club at a Washington, D. C., house of prostitution. Allegedly, Mr. Mantle was one of the members of the team who was entertained at this house of prostitution. (62-9-53-31, p. 34)

In February, 1962, it was alleged that an individual, described as a Dallas, Texas, playboy, night club operator and former boy friend of a notorious Dallas stripper, was purchasing the University Club, Dallas, Texas, from a former Dallas gambler. It was further noted that the University Club was a private night club, and that Mickey Mantle of the New York Yankees was one of the individuals financially backing this purchase. (62-9-12-294)

In January, 1963, a confidential source, of unknown reliability, advised that a well-known Dallas, Texas, gambler, who frequently made "heavy bets" on professional football games and other athletic contests, would make a number of telephone calls
