4	to confirm with ESU 1. ESU 1, you now have UC
5	control and eyes on that subject, correct?
6	PARTICIPANT: Correct.
7	PARTICIPANT: You've got CDU-6,
8	8400, 8701, and 8706, we have confirmation and
9	accountability for all of our uniformed
10	personnel on this, correct? And we're back out
11	of the crowd?
12	PARTICIPANT: 8706, I'm waiting for
13	two of mine to come out.
14	PARTICIPANT: 8400, (unintelligible).
15	PARTICIPANT: Cruiser 50, GRU-1. GRU-
16	1, all of your GLU personnel accounted for that
17	are in uniform?
18	PARTICIPANT: GRU-1. All our units
19	are accounted for, sir.
20	PARTICIPANT: Traffic Post 1, I was
21	just notified by a citizen, unattended backpack
22	hanging in a tree about halfway between 17- and

1	1600 block of Constitution.
2	PARTICIPANT: Post (unintelligible)
3	to 36 and 24, are you guys still making your
4	way out?
5	PARTICIPANT: Yeah. We're getting
6	out right now.
7	PARTICIPANT: Copy. What about you,
8	08?
9	PARTICIPANT: Copy.
10	PARTICIPANT: 8706, 8708, are you
11	making your way out of the crowd?
12	PARTICIPANT: I was on the other
13	side, so I'm out. I'm good.
14	PARTICIPANT: Copy.
15	PARTICIPANT: Post 87. Post 87,
16	you've got about five or six black males, Black
17	Lives Matter, walking westbound on Pennsylvania
18	from 4th.
19	PARTICIPANT: Copy.
20	PARTICIPANT: Make that 10.
21	PARTICIPANT: 8701 to 06, we have
22	everyone out.

1	PARTICIPANT: Affirmative.
2	PARTICIPANT: CDU-54, can we get a
3	transport vehicle at 15th and Constitution?
4	PARTICIPANT: What do you have, one
5	body? Male, female?
6	PARTICIPANT: We have an adult male.
7	And can you notify CID to respond over here
8	also?
9	PARTICIPANT: Brian, you may be
10	better off to walk him over to 14th and Con,
11	less foot traffic. You can get that body out
12	of there.
13	PARTICIPANT: Copy.
14	PARTICIPANT: Hey, 34, real quick,
15	I've got the board at 15th and Con. Does
16	someone have a medical?
17	PARTICIPANT: Do you need a transport
18	at 14th and Con?
19	PARTICIPANT: Go ahead and disregard.
20	PARTICIPANT: Copy, 1022 transport at
21	14th and Con.
22	PARTICIPANT: Hey, (unintelligible),

1	that medical, is that AMR or is that DC FEMS
2	ambulance?
3	PARTICIPANT: It's DC FEMS.
4	PARTICIPANT: NTL 16 (phonetic) with
5	a message. It's advising that they've got a
6	group of 10 black males. They are Blacks for
7	Trump, not Black Lives Matter members. Blacks
8	for Trump.
9	PARTICIPANT: And then, JOCC, just be
10	advised, FEMS is saying that they have multiple
11	medicals at 15th and Constitution.
12	PARTICIPANT: 107, I have on
13	Department of State gov list (phonetic) Ms.
14	with me. He said Pompeo is supposed to
15	be coming through my area. I just want to give
16	everybody a heads-up that he will be coming
17	through this area.
18	PARTICIPANT: What area?
19	PARTICIPANT: Fifteenth and I. So,
20	on I Street.
21	PARTICIPANT: I copy. They're going
22	to take a motorcade right through the middle of

BLM. 1 2 PARTICIPANT: Is there another way 3 you want me to redirect them? Or can somebody 4 meet me? Because they're en route to this 5 location as we speak. PARTICIPANT: Yeah. 6 They can go K Street. I'll make my way over there. 7 If you 8 can get them to stop and go K Street and down 9 18th, that would be much better. 10 PARTICIPANT: Copy.
