Go back to office. Order turkey sandwich. Come back to eat. watching tv. Seeing something about violence and protest.

I show him hirschmann and him read. Hirschman says no to second sentence. Cippollone comes in and says NG not deployed yet. Chief said yes we are. Chief says I talked to DOD myself and said deploy. Better deploy.

Run out to tweet. Get Chad.

Lyndee came in and said video crew coming. I go in S potus preparing to give comment:
