2	And so we're on the record at 9:58 a.m.				
3	Good morning. This is the deposition of Bianca Gracia, conducted by the House				
4	Select Committee to investigate the January 6th attack on the United States Capitol,				
5	pursuant to House Resolution 503.				
6	This deposition is being conducted via Zoom. This will be a staff-led deposition,				
7	though Members may choose to join the Zoom call and ask questions.				
8	At this time, I'd ask the witness to please state your full name and spell your last				
9	name for the record.				
10	The Witness. Bianca Gracia, G-r-a-c-i-a.				
11	My name is . I'm an investigative counsel with the				
12	Select Committee. There are no other staff from the Select Committee on the call right				
13	now and no other members, but if people choose to join, I'll try to announce them as they				
14	come in so that you know who's in the room.				
15	The Witness. Okay.				
16	And then I'd also ask at this time for counsel for Ms. Gracia to state				
17	his name for the record.				
18	Mr. Mills. Good morning. It's Laurin Mills for Ms. Gracia. And as we				
19	discussed before, make a short statement. Ms. Gracia is appearing here, respecting the				
20	committee's authority here to subpoena her.				
21	However, in light of comments made by the Attorney General and the Deputy				
22	Attorney General, and by the committee and filings in the Central District of California				
23	and by a judge in the Central District of California, she has opted to invoke her rights				
24	under the Fifth Amendment, not to be a witness against herself.				
25	And so after you swear her in, every answer she's going to give is, I rely on my				

1	Fifth Amendment privilege. And that's how we will proceed. And are you okay with				
2	that shorthand, ?				
3	That's yeah, that's going to be fine. I'll have a few kind of				
4	clarifying statements once we get started as well, but, yeah, we can go with shorthand				
5	after the first invocation.				
6	You know, actually, if you can just give me one second while a staff member is				
7	trying to join the call.				
8	Mr. Mills. Okay.				
9	Okay. All right. Thank you for that, Mr. Mills.				
10	So under House deposition rules, neither committee members, nor staff, may				
11	discuss the substance of the testimony today, unless the committee approves for release				
12	And then also note under House rules, you may have your attorney present, whic				
13	obviously you do, but counsel for other individuals, or attorneys for other government				
14	agencies may not be present and are, therefore, not present today.				
15	And then I'll also note for the record, that we've had				
16	He's another investigative counsel with the Select Committee.				
17	What has been previously marked as exhibit 1 is the Select Committee's January				
18	19, 2022 subpoena for Ms. Bianca Gracia. The House deposition rules are included in				
19	that exhibit.				
20	We've also had a couple more individuals join. We've had				
21	investigative counsel for the committee, and, who's a consultant with				
22	the committee and on the committee staff as well.				
23	So, Ms. Gracia, there's an official reporter that's transcribing the record of this				
24	deposition. So to make her job a little bit easier, if you can just wait until I complete my				
25	questions before you begin your response. We'll try to wait and then I'll also try to				

1	wait until you've completed your answer before I begin my next question.			
2	It's just difficult for the court reporter to try to transcribe two people speaking at			
3	the same time. Does that make sense?			
4	The <u>Witness.</u> Yes.			
5	Okay. And then along the same lines, you need to use verbal			
6	responses today, as opposed to, like, a head shake. So just make sure that you try to			
7	use yes or no or a similar answer when I ask a question.			
8	And then also today, all we ask is that you provide complete answers to the best			
9	of your recollection. If a question is not clear, please ask for clarification or ask me to			
10	restate it. And if you don't know the answer, you can simply say so.			
11	The <u>Witness.</u> Okay.			
12	Also note, and Mr. Mills has already addressed for the record, that			
13	you may refuse to answer a question to preserve a privilege recognized by the select			
14	committee, privileges like the Fifth Amendment right against self-incrimination.			
15	If you refuse to answer a question based on a privilege, staff may either proceed			
16	with the deposition or seek a ruling from the chairman on the objection. If the chairman			
17	overrules such an objection, you'll be required to answer the question.			
18	And then, I also want to remind you that it's unlawful and we provide this			
19	warning for everybody we speak to that it's unlawful to deliberately provide false			
20	information to Congress.			
21	Providing false information could result in criminal penalties for perjury or false			
22	statements, including under 18 U.S.C. 1001, which makes it illegal to provide a false			
23	statement to an congressional investigator like myself, or some of the others that I've			
24	announced on this call. Does that all make sense to you?			

The Witness. Yes.

1	That being said, I want to make clear that this is a congressional				
2	investigation and not a criminal investigation. This proceeding is separate and distinct				
3	from any current criminal proceeding by the United States Department of Justice. Do				
4	you understand that?				
5	The <u>Witness.</u> Yes.				
6	Okay. And then throughout today and throughout our				
7	conversation, if you need any breaks, just let me know. I'll try to take a break about				
8	every hour or so, but if you need one at a different time, feel free to say so.				
9	The <u>Witness.</u> Okay.				
10	And then, I'll mostly be leading our conversation today and asking				
11	most of the questions, but occasionally, other staffers or a member might join the				
12	discussion and ask a follow-up question for you, so that may occur.				
13	And then lastly, because this is a deposition, you are or you will be under oath.				
14	So could you please raise your right hand to be sworn.				
15	The Reporter. Do you solemnly swear and affirm under the penalty of perjury				
16	that the testimony you are about to give will be the truth, the whole truth, and nothing				
17	but the truth?				
18	The <u>Witness.</u> I do.				
19	The <u>Reporter.</u> Thank you.				
20	The <u>Witness.</u> Yes.				
21	Great. And then to start, sort of a housekeeping matter, I'm going				
22	to pull up exhibit 1, which you should be able to see on your screen now. Can you see				
23	that?				
24	The <u>Witness.</u> Yes.				
25	Okay. And this is the January 19, 2022 subpoena issued to you by				

1	the select committee. Have you seen this document before?
2	The Witness. Yes.
3	Okay. And I'll note, obviously at the top of there, we've got Bianca
4	Gracia, and I just want to confirm that you're the individual named in this subpoena. Is
5	that correct?
6	The <u>Witness.</u> Yes.
7	Okay. Great. And then I'm scrolling down to page 5 of this
8	document, which is a schedule of documents requested in the subpoena. Have you
9	seen this document schedule before?
10	The <u>Witness.</u> Yes.
11	Okay. And am I right that in response to the subpoena, which calls
12	for the production of documents, you've produced no documents, correct?
13	Mr. Mills. I'm going to we have already asserted the act-of-production
14	privilege with regard to that.
15	Sure. And just as an initial matter, you know, I'm going to need
16	Ms. Gracia to assert those privileges on the record. So really just a housekeeping matter
17	to get her to put that on the record.
18	Mr. Mills. So, Bianca, you can say, I rely on my Fifth Amendment privilege.
19	The Witness. I rely on my Fifth Amendment privilege.
20	Okay. And then also as an additional matter, I just want to make
21	sure I'm sure you've had conversations with Mr. Mills about this, but I want to make
22	sure you understand what it means to invoke the Fifth Amendment privilege.
23	And so, I hope that you understand that by invoking the Fifth Amendment right
24	against self-incrimination, you're indicating that you believe that truthful answers to my
25	question would be incriminating.

1	Mr. Mills. I object to that characterization. The Fifth Amendment says nothing				
2	about incrimination. It says she has a right not to be a witness against herself. And				
3	that's the objection. So that's the privilege she's asserting.				
4	Do you understand that by providing truthful answers to these				
5	questions and invoking the Fifth Amendment right, that you believe that the answers to				
6	your questions could be used against you in a criminal case?				
7	The Witness. I rely on my Fifth Amendment privilege not to be a witness against				
8	myself.				
9	Okay. And it's also your position that collecting documents and				
10	producing documents would also amount to being used as a witness against yourself? Is				
11	that the case?				
12	The Witness. I rely on my Fifth Amendment Privilege not to be a witness against

19	deposition, Mr. Enrique	Tarrio, and I just want to ask you a few questions about him and
20	how you know him and	what your interactions with him have been.
21	So I'll start just g	generally, do you know Mr. Tarrio?

Were you aware of this 4 flight? 5 6 Α I rely on my Fifth Amendment privilege. 7 Q Okav. Did you help pay for this flight? Α I rely on my Fifth Amendment privilege. 8 9 Q If you did not pay for the flight, do you know who did pay for those flights to 10 D.C. on November 13th? 11 Α I rely on my Fifth Amendment privilege. 12 Okay. Again, I have a series of questions about Mr. Tarrio's travel to 13 Washington, D.C. for the events of November 14th and your knowledge of payments for those flights and other individuals that might've been on the flight. 14 15 Is it your intention to invoke the Fifth Amendment with respect to any questions about the flight with Mr. Tarrio and other Proud Boys from Miami to Washington on 16 D.C. -- to D.C. for November 13th. Would you invoke the Fifth for all of those questions? 17 Α I rely on my Fifth Amendment privilege. 18 19 Q Similarly, other witnesses and evidence that we've collected have indicated 20 that Mr. Thad Cisneros, who also has some ties to the organization Latinos for Trump, was 21 flown by private plane to Washington, D.C. for the events of January 6th. - 7 evening of January 5th?

- first one I'd like to identify and have you confirm is you. On the left side of that screen
- in a red jacket with a mask below your chin, I believe that's you. Can you confirm that
- that's you in the video?
- 13 A I rely on my Fifth Amendment privilege.
- 14 Q Okay. And the other individuals in this video, I believe immediately to your
- right are Mr. Enrique Tarrio, and standing in front of him is Mr. Josh Macias. Standing to
- the right of both of them in the photo is Ms. Kellye SoRelle, and finally behind Ms. Kellye
- 17 SoRelle is Mr. Stewart Rhodes. Do you know these individuals?
- 18 A I rely on my Fifth Amendment privilege.
- 19 Q Okay. I have a series of questions about this meeting and about these
- individuals and the topics discussed at that meeting. Would it be your intention to
- 21 invoke the Fifth Amendment with respect to all of those questions?
- 22 A I rely on my Fifth Amendment privilege.
- Q Do you know Ms. Amy Harris?
- 24 A I rely on my Fifth Amendment privilege.
- Q Okay. Was Ms. Amy Harris also at this meeting?

24	coordinate	with Proud Boys or Oath Keepers in an effort to provide security for anybody

24	Q	Would it be your intention to invoke the Fifth Amendment with respect to	
25	any other q	uestions about your activities on January 6th?	

1	Α	I rely on my Fifth Amendment privilege.	
2	Q	I want to ask about your awareness of other individuals planning for events	
3	of January	6th. Were you aware that there was going to be a march to the Capitol from	
4	the Ellipse	rally?	
5	Α	I rely on my Fifth Amendment privilege.	
6	Q	Were you aware separately that the Proud Boys were planning to march	
7	from the W	ashington Monument area to the Capitol?	
8	Α	I rely on my Fifth Amendment privilege.	
9	Q	Did you have any communications with Mr. Tarrio about his plans for	
10	January 6th	n?	
11	Α	I rely on my Fifth Amendment privilege.	
12	Q	Okay. And similarly I have a series of questions about other individuals'	
13	plans on Ja	nuary 6th and your awareness of those plans. Would it be your intention to	
14	invoke the Fifth Amendment with respect to any questions about any other individuals'		
15	plans for Ja	nuary 6th?	
16	Α	I rely on my Fifth Amendment privilege.	
17	Q	Okay. I'd like to ask some questions about how you communicated with	
18	people for	planning related to January 5th and 6th. Do you use any encrypted	
19	messaging	apps?	
20	Α	I rely on my Fifth Amendment privilege.	
21	Q	Have you ever used Signal?	
22	А	I rely on my Fifth Amendment privilege.	
23	Q	Have you ever used Telegram?	
24	А	I rely on my Fifth Amendment privilege.	
25	Q	Did you ever communicate with Mr. Tarrio through any encrypted messaging	

1	app?
2	A I rely on my Fifth Amendment privilege.
3	Q After were you aware of Mr. Tarrio's arrest on January 4th?
4	A I rely on my Fifth Amendment privilege.
5	Q Either after January 4th or after the events of January 6th, did you ever
6	delete any messages with Mr. Tarrio or any other Proud Boys related to the events of
7	those days?
8	A I rely on my Fifth Amendment privilege.
9	I'm just trying to go back through some of my notes and make sure
10	I've covered most of the topics that we'd like to discuss with you today, but I think we're
11	nearing the end.
12	Let's take just a quick recess. It's 10:38. We'll go into recess until 10:45, and
13	then hopefully when we come back, we can wrap things up.
14	Mr. Mills. Sounds good. Thank you very much.
15	Thanks. You can go ahead and mute your video or camera if you
16	need to. And I will.

8	Q And then how about any other elected officials? We'll start specifically		
9	with Members of the House of Representatives. Did you speak with any Members of		
10	the House of Representatives with relation to your attendance or planning for the events		
11	of January 5th or 6th?		
12	A I rely on my Fifth Amendment privilege.		
13	Q And how about any Members of the Senate?		
14	A I rely on my Fifth Amendment privilege.		
15	Okay. All right. Well, with that, just while we're still on the		
16	record, I appreciate you coming and spending some time with us this morning, and I think		
17	that's all the questions that we have for you right now.		
18	We are because you invoked the Fifth with respect to essentially all of my		
19	questions, we're going to leave this deposition open and have the option of calling you		
20	back at some point, but for today, I believe we're done.		
21	Mr. Mills. Thank you very much.
